An Ordinance to Establish a Right Turn Only Restriction in the Alley on the North Side of West Lincoln Avenue, Between South 75th Street and South 76th Street.

Location: Alley North of West Lincoln Avenue Between S. 75th Street and S. 76th Street

Direction of Travel: Southbound

Turning Movement: Right Turn

Restriction: Right Turn Only

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.
