

\$2,750,000 GENERAL OBLIGA-TION BONDS

OF THE CITY OF WEST ALLIS FOR STREET IMPROVEMENT PROJECTS

WHEREAS, the City needs to obtain funds for the public purpose of financing street improvement

RESOLVED that the City of West Allis, Milwaukee County, Wisconsin, borrow an amount not to exceed \$2,750,000 by issuing its general obligation bonds for the public purpose of financing street improvement projects.

The Wisconsin Statutes (s. 67.05(7)(b)) provide that the initial resolutions need not be submitted to the electors unless within 30 days after adoption of the initial

resolutions a petition is filed in the City Clerk's office requesting a referendum. This petition must be signed by electors numbering at least 10% of the votes cast for governor in the City at the last general election. A petition may be filed with respect to any one or more of the initial resolutions.
