The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of August.

**Incident reports:**

**Case #14-6760, 08/03/2014, at 0225 hrs – 1430 S. 81 St – Paulie’s Field Trip**

On 08/03/2014, at 0225 hrs., Officers responded to 1430 S. 81 St, Paulie’s Field Trip for several parties fighting inside the bar. The Offender caused a disturbance in the bar by shoving patrons, jumping on top of the bar, throwing a glass and shoving the bartender. She was taken into custody for Disorderly Conduct, booked and released. Staff from the Tavern called the police. The Offender was found to be unsteady on his feet, had a strong odor of intoxicants emitting from his breath, was slurring his words, and in the Officer’s opinion, he was under the influence of intoxicants.

**Case # 14-6839, 08/05/2014, at 0202 hrs – 5732 W. Mitchell St – Tap 58**

On 08/05/2014, at 0202 hrs., Officers responded to 5732 W. Mitchell St – Tap 58 for male passed out on the ground, bleeding from the head. The party became uncooperative when officers attempted to render aid and inspect the bleeding wound on the back of his head. The party spat saliva on Officers. He continued to resist inside the ambulance and hospital, forcing Officers to use force to control him and aid in the rendering of his care. He was arrested for three counts of throwing/expelling substances at Public Safety Worker, one count of resisting and one count of Disorderly Conduct. A witness stated the party had been in Tap 58. He was very intoxicated and talking “crazy”. The case was reviewed at the DA’s Office and he was charged with one count of Discharging Bodily Fluids at Public Safety Worker.

**Case #14-7010, 08/10/2014, at 0148 hrs., 9427 W. Greenfield Av – Big Dogs Sports Bar & Grill**

On 08/10/2014, at 0148 hrs., Officers responded to 9427 W. Greenfield Av, Big Dog's Sports Bar and Grill, regarding a male subject causing a disturbance and refusing to leave. The Offender came into the tavern and immediately began causing a disturbance by being loud and using profanity. The Officer detected a strong odor of ingested intoxicants emitting from the Offender. He began arguing with the Officer and threatening to shoot officers and challenging them to a fight. The Offender demanded a courtesy ride from the Officer. Eventually, the Offender was arrested for Disorderly Conduct, booked and released.

**Case #14-7424, 08/22/2014, at 0208 hrs., 5732 W. Mitchell St., Tap 58**

On 08/22/2014, at 0208 hrs., Officers responded to 5732 W. Mitchell St, Tap 58 for a noise complaint. Officers made contact with an Offender who not stop at the Officer's command. Once approached, he became argumentative, refused to provide his name and tried walking away. Officers attempted to detain him, and he resisted. He was ultimately arrested. He had valid bench warrants through MCSO and Kenosha. He was booked and cited for Obstructing and Resisting. The Offender was highly intoxicated.

**Case #14-7506, 08/24/2014, at 1956 hrs., 1901 S. 60 St., M&M's Bar**

On 08/24/2014, at 1956 hrs., Officers responded to 1901 S. 60 St, M&M's Bar for a report of a man causing a disturbance inside the bar. Officers made contact with the man inside the bar. He became uncooperative and failed to listen to Officers. He was transported to the PD, during which time he became boisterous and slammed his head against the Plexiglas divider of the squad. He was issued a citation for Disorderly Conduct. While inside the holding cell, he punched the metal door. Rescue responded and took custody of him.
