

**CITY OF WEST ALLIS
RESOLUTION R-2024-0499**

**RESOLUTION TO AMEND JOINT HEALTH DEPARTMENT AGREEMENT TO
EXTEND WEST MILWAUKEE BOARD OF HEALTH VOTING PRIVILEGES**

WHEREAS, resolution R-2024-0059 established the Southwest Suburban Health Department ("SWSHD") as a joint health department between West Allis and Greenfield effective April 1, 2024;

WHEREAS, the agreement established that the Village of West Milwaukee appoints a voting member to the SWSHD board of health for a limited time; and,

WHEREAS, the City of West Allis and City of Greenfield have agreed to extend the voting rights for West Milwaukee until a future date;

NOW THEREFORE, BE IT RESOLVED that the Common Council of the City of West Allis approves the following amendment to the joint health department agreement:

Strike Section 3, Item b, line iii within the IGA and replace with "The Village of West Milwaukee ("West Milwaukee") presently contracts for health department services and has a member on the SWSHD Board. West Milwaukee will have until June 30, 2025 to decide whether it wishes to become a member of the SWSHD or remain in a contracted services agreement arrangement with the SWSHD. A municipality that joins as a member shall be entitled to appoint a voting member to the SWSHD Board. Alternatively, those in a contracted service agreement shall be entitled to appoint a non-voting liaison member to the SWSHD Board. With respect to West Milwaukee, whether its member will be a voting member or a non-voting liaison member as of July 1, 2025 shall be determined by its decision on membership."

SECTION 1: **ADOPTION** "R-2024-0499" of the City Of West Allis Municipal Resolutions is hereby *added* as follows:

SECTION 2: **EFFECTIVE DATE** This amendment will be effective upon the date that the common councils of West Allis and Greenfield have both approved the amendment language.
