RESOLUTION R-2025-2962**

**RESOLUTION TO APPROVE A CONSTRUCTION CONTRACT WITH ARCH
SOLAR IN THE AMOUNT OF UP TO \$45,030 FOR THE INSTALLATION OF
SOLAR PANELS AT THE LIBERTY HEIGHTS PAVILION**

WHEREAS, the City of West Allis is committed to advancing sustainability and energy efficiency initiatives; and,

WHEREAS, the Liberty Heights Pavilion has been identified as a suitable municipal facility for installation of solar energy infrastructure and the installation could provide energy savings; and,

WHEREAS, the City of West Allis conducted a Request for Proposals for a solar installation to be funded by accumulated program income generated by Energy Efficiency and Conservation Block Grant Fund loan repayments; and,

WHEREAS, staff recommends the selection of Arch Solar for installation of solar panels to the Liberty Heights Pavilion; and,

WHEREAS, the Board of Public Works reports that it duly advertised for bids for the furnishing of certain solar panels and systems at the Liberty Heights Pavilion, that the bids received as shown on the attached bid report were reasonable, and that it recommends and deems it to be for the best interests of the City of West Allis that the bid of Arch Solar be accepted.

NOW THEREFORE, BE IT RESOLVED By the Common Council of the City of West Allis that it hereby approves a construction contract with Arch Solar in the amount of up to \$45,030 for the installation of solar panels at the Liberty Heights Pavilion; and,

BE IT FURTHER RESOLVED That this project shall be funded by the Energy Efficiency and Conservation Block Grant Fund (account 221-7404-563.70-05); and,

BE IT FURTHER RESOLVED That the City Engineer and Economic Development Executive Director are authorized to prepare and to execute the necessary documents for the contract on behalf of the City of West Allis.
