RESOLUTION R-2026-5071**

**RESOLUTION APPROVING A THREE-YEAR AGREEMENT WITH
CLEARPOINT STRATEGY FOR STRATEGIC PERFORMANCE MANAGEMENT
SOFTWARE**

WHEREAS, the City will soon begin preparing its 2027-2031 Strategic Plan; and

WHEREAS, the strategic planning process requires coordinating complex initiatives, capital projects, operational improvements, and performance measures across multiple departments; and

WHEREAS, currently, strategic initiatives are tracked through a combination of spreadsheets, reports, presentations, and departmental updates; and

WHEREAS, the City recognizes that a centralized strategic performance management system is extremely valuable for coordinating, monitoring, and reporting progress; and

WHEREAS, City staff evaluated available strategic performance management platforms and determined that ClearPoint Strategy best meets the City's operational, reporting, transparency, and overall strategic planning needs; and

WHEREAS, ClearPoint Strategy is a cloud-based platform specifically designed for public-sector strategic planning and performance management; and

WHEREAS, ClearPoint Strategy will allow for internal project management and accountability, enhanced strategic oversight, and public transparency and engagement; and

WHEREAS, ClearPoint Strategy will provide the City with a modern strategic management tool that strengthens project oversight, improves organizational accountability, enhances Council visibility into progress, and offers residents a transparent view of how strategic priorities are advancing over time; and

WHEREAS, the cost of the agreement is \$32,000 per year for three years, for a total cost of \$96,000; and;

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the agreement attached to this resolution is approved and the City Administrator or designee is authorized to execute the contract on behalf of the City.

BE IT FURTHER RESOLVED that funding for this agreement will be charged to the Administrative budget, Account No. GL 100-1001-513.30-04 Professional Services / Other.
