The Board discussed the ongoing public relations program to notify patrons of the status of the MCFLS Member Agreement. Informational flyers have been prepared and distributed at the library, an article has been prepared for the next City Newsletter, and Sister Paulson has appeared on a cable program with Mayor Bell.

The Board discussed the recruitment of a new Library Director. The Board interviewed candidates and submitted its recommendation to the Personnel Division. The Personnel Division will keep the Board informed as it conducts background and reference checks on the lead candidate.

The Board discussed the library's proposed 2002 operating budget. The budget passed the Mayor's review without any changes. The next step in the process is a review by the Common Council.

The Board discussed the donation of 20 shares of Johnson Controls, Inc. from Emil and Elfrieda Mater. Sister Paulson moved the Board hold the stock until a more appropriate time to sell due to the current fluctuations in the stock market. Second by Alderman Kopplin. After more discussion, Sister Paulson moved to call the question. Motion to call the question seconded and carried. Motion to hold the 20 shares of Johnson Controls carried.


Ms. Dobrogowski indicated that Sister Paulson will be attending the Wisconsin Library Association Conference in Appleton on October 23-26, 2001.

Ms. Dobrogowski reported that 70,465 items were circulated during August 2001, an increase of 8.3%; 9,592 of the items were circulated via the SelfCheck.

Ms. Dobrogowski indicated that a final report of the 2001 Summer Reading Program was included in tonight's packet for the Board's review.

Ms. Dobrogowski reported that Mary Ann Wasick (Librarian) had retired effective September 16, 2001 after 27 years of service. Mrs. Olson moved that staff prepare a resolution recognizing Ms. Wasick's service. Second by Alderman Kopplin. Motion carried.

There being no further business, Alderman Kopplin moved to adjourn. Second by Mrs. Olson. Motion carried and meeting adjourned at 8:50 p.m.
