The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of October 2020:

## INCIDENT REPORTS:

**CALL#20-035468 – 10/01/2020 – 2215hrs. – Drunk Uncle – 1902 S. 68 St.**

**Caller: Unknown**

### **Sgt. Manthe Reports...**

On 10/1/20 at 2215hrs, officers responded to a parking complaint regarding a Blue in color 2000 Jeep Grand Cherokee parking too close to a fire hydrant. The vehicle was located bearing WI reg 718TWS which expired in 2017 with no vehicle associated to Neal Steffek, M/W [REDACTED]. A check of the VIN: [REDACTED] showed Neal Steffek as the owner with no current registration on the vehicle. There was also an IID OWI sanction listed for the vehicle through New Berlin Municipal Court with no IID visible in the vehicle. A measurement showed the vehicle was parked closer to the fire hydrant than permitted by law. Citations were issued for parking by fire hydrant closer than 10' (Citation #2057141) and unregistered vehicle parked on city street. Based on the violations, N and S Towing removed the vehicle from the street. Contact was made with Steffek who was found to have a municipal warrant for OWI through the City of New Berlin. Based on Covid-19 restrictions, New Berlin did not enforce this warrant and Steffek was advised to contact the municipal court to resolve the matter. Steffek stated he thought I was referring to a separate court case through Waukesha County. A check in CCAP shows Steffek has two open cases in Waukesha County for Operating While Revoked (Due to OWI) *Cases 2019CT000061 and 2019CT001430*. A tavern report was generated to document this incident.

#### **Officer Vanden Boogard Reports....**

On 10/11/20 at 0001hrs, officers responded to the 1700blk of S. 57 St. for shots heard. Officers located six shell casing in the street, however no victims were located. Investigation led to the arrest of Jeffrey NMI Ortiz, M/W [REDACTED], who resides at 1824 S. 57 St. He is on parole and was arrested for Felon in Possession of a Firearm, 2nd Deg. **Officer Carlson Reports...**
