The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of December 2008

Police report incidents involving licensed businesses:

#### Tavern reports:

Case# 08-18212...11/29/08...0132hrs...Shawna's Pub and Grub, 1101 S. 60 St.

Officers responded to a possible man with a gun call at Shawna's Pub and Grub located at 1101 S. 60 St. The complainant was the owner who stated that after he refused to let two parties into his bar due to them not having any identification they threatened to shoot up the tavern. Officers arrived and stopped a vehicle in the area matching the description of the one the parties left in. Two parties were subsequently arrested, the first for OAWI 1<sup>st</sup> offense, Disorderly Conduct and a warrant with Green Bay PD and the second for Disorderly Conduct and Liquor Law violations.

Case# 08-018334...12/01/08...Actual Date of Alleged Offense 11/29/08 at approx. 0030hrs. Brass Monkey, 11904 W. Greenfield Ave.

On 12/01/08 at approx. 1921hrs. a female came into the station to report a possible sexual assault. The party claimed that while she was in the restroom at the Brass Monkey on 11/29/08 at 0030hrs. a male entered the room, exposed himself to her and began to masturbate. The male also rubbed his penis against her before she was able to break away from him and exit the restroom. The female stated that she told the bar owner who approached the male and then kicked him out of the bar. The female stated she only wanted this documented and would not prosecute.

### Case# 08-018429...12/03/08...2342hrs...Rocco's Tavern, 1309 S. 60 St.

Officers responded to a fight inside of Rocco's Tavern. The dispute started out between a male and female and blossomed as patrons attempted to help her. The male left before officers arrived and was eventually contacted and arrested for Disorderly Conduct and Battery.

## Case#08-018803...12/12/08...0025hrs...Lenny's on National, 6309 W. National Ave.

Officers responded to a fight inside of Lenny's on National. Two intoxicated male parties were fighting over a pool game. Parties were eventually both arrested for Disorderly Conduct. One of the two parties involved in the altercation called the department. The owner of the tavern Leonard Malan gave conflicting statements as to what took place in the tavern.

## DWI#08456...12/16/08...0227 hrs...Koozy's Bar and Grill, 1657 S 108 St.

Officers responded to a call from an attendant at Speedway 10306 W. Greenfield Ave. of a possible intoxicated driver. Officers found the vehicle involved traveling SB on S. 108 St and make an illegal U-Turn at W. Greenfield Ave. Officers pulled the vehicle over and eventually arrested the driver for Driving While Under the Influence. The offender was uncooperative during the stop and refused to take an Intoximeter Test. The offender also has a valid warrant through Seminole County Florida for DWI. The warrant is not extraditable. The offender stated that she works at Koozy's Bar and Grill.

# Case# 08-019091...12/18/08...1807hrs...Scotty's Bar, 6500 W. Greenfield Ave.

Officers assisted the Wis. Dept. of Revenue in executing a Tax Search Warrant at Scotty's Bar located at 6500 W. Greenfield Ave. Two parties in the tavern were arrested for drug possession. Also during the search pills were found in a safe behind the bar, a marijuana pipe was found behind the bar, a marijuana cigarette was found in the back room and a bong was also found in the corner of the same room.

# Case# 08-019091...12/18/08...1807hrs...Thirsty's Bar, 6833 W. National Ave.

Officers assisted the Wis. Dept. of Revenue in executing a Tax Search Warrant at Thirsty's Bar located at 6833 W. National Ave. Unknown what was seized other then money. The agents also disabled the video gaming machines.

### Case# 08-019315...12/24/08...2045hrs...Mugshotz Tavern, 1902 S. 68 St.

Officers were dispatched to a weapons complaint at Mugshotz tavern 1902 S. 68 St. where a male pulled a switchblade knife out and threatened another male over a disagreement over parking in front of the bar. Offender fled the scene. No arrest made as of the typing of this report.

# Call#08-059189...12/27/08...0156hrs...Jock Stop 7930 W. National Ave.

Officers responded to a large fight in front of the Jock Stop located at 7930 W. National Ave. The fight started in the tavern and proceeded out into the street. The bartender on duty called the police. A male with a laceration over his nose was the only party left on scene when officers arrived. All other parties fled the scene and the party left behind did not wish any police action into the matter.
