



SUMMARY

Webster reports:

On 06/30/2013 at approximately 2238 hrs., officers responded to 1902 S. 68 St. (Mugshotz Bar) for a report of a man with a gun. Investigation revealed Robert S. Oleszek (m/w 11/20/1979) entered Mugshotz, where alcohol is sold and consumed, with a handgun in his right hand, with his finger on the trigger, and demanded to know where his wife was. Jason L. Schilling (m/w 10/03/1976) was bartending and told Robert his wife was not in the bar. Jason and a patron, identified as Richard H. Schilling (m/w 05/20/1973), told Robert to leave. Robert, who was slurring his words, and appeared intoxicated, backed out of the establishment. When Robert backed out of the bar, Robert raised the firearm below his waistline, to his right side, approximately three feet off of his hip. Robert caused patrons to fear for their safety and Craig F. Burger Jr. (m/w 06/23/1975) said he thought

Robert "meant business". Robert then left southbound on S. 68 St. Jason and Craig followed Robert to a residence, later identified as 1964 S. 68 St. Due to a weapon being involved, officers established a perimeter and attempted phone contact with Robert. Robert did not answer so officers attempted contact via the squad PA system. Robert subsequently came to the front of the door and exited the residence while yelling and swearing at officers. Robert refused to follow commands, forcing officers to deploy an Electronic Control Weapon. Robert was taken into custody and transported to Aurora West Allis Medical Center for medical clearance. Firearms were recovered from the residence, during a protective sweep, in plain view. This case is set for review by the District Attorney's Office on 07/02/2013 at 0830 hrs.

INCIDENT DETAILS

On 06/30/2013 at approximately 2238 hrs., officers responded to 1902 S. 68 St. (Mugshotz Bar) for a weapons call. Alcohol is sold and consumed at this establishment. On arrival, a male was standing outside of the establishment and was on the phone. This male, subsequently identified as Jason L. Schilling, was identified as the caller. I spoke with Jason and gathered preliminary information.

INITIAL CONTACT WITH JASON L. SCHILLING (VICTIM)

Jason said a w/m, wearing blue jeans, a white t-shirt, approximately 5'10" tall, 160 pounds, with a bald head, came into the establishment with a firearm and fled southbound on S. 68 St. I immediately relayed this information to officers en route. Jason said the male enter into the last residence in the 1900 block of S. 68 St., on the east side of the street, with a for sale sign in the front yard, one house north of the church at the end of the block. I again relayed this information to offices en route. The address the male entered was determined to be 1964 S. 68 St.

Jason was behind the bar and was the bartender for the night. Jason said a male, who he recognized as "Bob" from him frequenting the establishment, came into the establishment with a gun in his right hand. Jason then provided me a possible last name of Oleszek through looking at "Bob's" wife's facebook account. I provided dispatch with a possible suspect name of Robert Oleszek. Jason said Robert entered and kept asking "where is Gina". The facebook account Jason showed me had a name of Gina Oleszek. Jason said Robert's finger was on the trigger when he entered. Jason got all patrons into another room. Jason said the slide of the black or gray firearm was "cocked". I relayed this information to responding squads as well. Jason said Robert was in the establishment for approximately 2 minutes. Robert was told to leave and after Robert left, Jason called Police and followed Robert. Jason followed Robert to residence noted above. Jason saw Robert enter the residence but stopped following after being advised by dispatch to stop. Jason said when Robert exited the residence and walked southbound, Robert walked at a brisk pace. Jason said it seemed like it may have dawned on Robert what he did.

On 07/01/2013 I followed up with Jason to see if he could remember any additional details. I know from training and experience severe stress can cause temporary memory loss and these memories can be recovered after calming down. Jason said he could not see if the firearm was loaded. Jason said he "absolutely feared for his safety" and he thought Robert was going to shoot someone.

As I spoke with Jason, additional patrons came out of the establishment. I advised all patrons to not talk to each other until I could interview them. I

then spoke with Richard H. Schilling separately from the other patrons.

INITIAL CONTACT WITH RICHARD H. SCHILLING (VICTIM)

Richard said he was sitting at the northwest end of the bar. Richard said the door was located to his southwest. Richard said he was sitting directly in front of the door. Richard said he saw Robert enter the establishment with the firearm and he was the first to see the firearm. Richard said he got up and stood next to Richard and attempted to talk with him. Richard said he asked Robert, "what are you doing, get the fuck out of here". Richard said Robert asked, "Where is Gina?". Richard told Robert "he didn't know where his wife was". Robert said, "Fuck that! One of you guys got her!". Richard said Robert backed out of the establishment through the doorway. As Robert backed up, Robert raised the gun in his right hand to his side. Richard said Robert's eyes were "wide open" and said he was "fucked up". Richard said Robert slurred his words and was "absolutely intoxicated based on his demeanor".

On 07/01/2013 I followed up with Richard to see if he could remember any additional details. I know from training and experience severe stress can cause temporary memory loss and these memories can be recovered after calming down. Richard said Robert took approximately 4 steps into the establishment, to the right of the door. Richard said he stood to Robert's left when he entered, at approximately a 30 degree angle. Richard said he stood up to diffuse the situation. Richard said Robert's actions "absolutely made him fear for his safety". Richard said as Robert backed out of the establishment, he raised the firearm approximately 3 feet off of his leg and pointed the firearm at the wall. This action caused Richard to step to the left because he thought Robert may use the weapon. Richard said the gun was black and the slide was locked back. Richard said he thought he saw bullets in the gun.

After I spoke with Richard, I spoke with Justin C. Powell.

INITIAL CONTACT WITH JUSTIN C. POWELL (VICTIM)

Justin was sitting in the middle section of the bar, on the southeast corner. Justin said he saw Robert enter the establishment three times. The first time, Jason entered and asked Jason where his wife was. Jason told Robert his wife was not there. Robert responded, "Ok, you want to play those games".

The second time Robert entered, he again asked where his wife was. Justin then heard Robert say something about "your going to see a dead bitch".

Justin said the third time Robert came in, he came in with a gun.

Justin was unsure of the exact times when Robert entered and left.

Craig was sitting in the middle section of the bar at the southwest section. Craig said he saw the firearm and saw a magazine in the firearm. Craig said he thought Robert "meant business". After Robert exited the residence, Craig went with Jason to follow Robert. Craig said he saw Robert inside of the residence. relayed this information to officers on scene.

I then spoke with Chad S. Collins.

INITIAL CONTACT WITH CHAD S. COLLINS (VICTIM)

Chad said he was sitting on the very east end of the bar. Chad said he did not see much and did not have any additional information.



NARRATIVE

Officer Manthe reports...

On Sunday 6-30-13 at approximately 2238 hrs, I, Officer Manthe, responded to 1964 S 68 St to assist in this investigation. Officer Webster advised the offender, Robert Oleszek, had taken a handgun into a tavern while making threatening statements, just prior to officer arrival, while intoxicated causing patrons and staff to fear for their safety. While on scene, I assisted in taking the offender, Robert S Oleszek, into custody.

ARREST OF OFFENDER- ROBERT S OLESZEK

An arrest team was assembled near the South side of the residence and officers gave continuous commands for Oleszek to exit the residence. Based on witness statements that Oleszek had been carrying a handgun while intoxicated a short time earlier, officers instructed Oleszek to exit his residence with his hands visible in the air.

Oleszek came to the front of the residence at one time, yelled obscenities at officers, and shut the door of the residence, refusing to follow commands.

Once Oleszek finally emerged from the residence after continued commands given by Officer Marchant by use of a squad car P.A. Officer Plotkin gave verbal commands to Oleszek to walk towards officers with his hands raised. Oleszek was verbally argumentative with officers during this process swearing and yelling at officers. He not following commands as they were given but continued to walk toward officers. Oleszek was instructed to show his waist band area and would only show the front of his waistband, refusing to follow orders to turn away from officers and lift his shirt.

Oleszek complied with officer commands to place his hands on the ground and continued to yell at officers during this process. As Oleszek was about to place himself in the prone position, with his hands already on the ground, he raised his arms and began to raise up from the prone position. At this time, he was approximately eight feet from officers.

Because Oleszek had been seen with a firearm and refused to reveal his waistband area to officers as instructed, his continued arguing with officers during the command process, and because of the threat to officer safety caused by Oleszek's continued non-compliance demonstrated by his attempt to stand up from the prone position while officers where in a vulnerable position, I deployed an Electronic Control Weapon, (commonly referred to as a Taser), to safely take Oleszek into custody.

After a successful deployment of the Electronic Control Weapon, Oleszek fell to the ground and continued to disregard commands given to him by officers. Oleszek moved his hands under his body, out of view of officers, and would not allow officers to bring his hands behind his back so he could be placed in handcuffs. I deployed a secondary cycle of the Electronic Control Weapon to allow officers to gain control of Oleszek and overcome his continued active resistance while being taken into custody.

Once officers gained control of Oleszek's hands and were able to handcuff him, removing an imminent threat of danger to officers, I removed the cartridge from the Electronic Control Weapon and Oleszek was placed in an ambulance to be treated for any potential injuries and the removal of the Electronic Control Device cartridge barbs.

PHOTOGRAPHS OF RESIDENCE (1964 S 68 St)

I photographed the residence in this incident, 1964 S 68 St, regarding evidence found on scene. This was documented on digital media card S15F, later sealed in a White in color envelope and placed in the West Allis Police Department property room. NARRATIVE

Officer Tuschl reports...

INITIAL RESPONSE

On 07/01/13 at about 0002hrs I responded to 1964 S. 68th St to assist Officers in this incident. Once I arrived on scene I made contact with Sgt Pasdera and was briefed about this incident. Officers currently had a perimeter set up at 1964 S. 68th St and was attempting to get the homeowner (later determined to be Robert S. Oleszek M/W 11/20/79) to exit. Robert was a suspect in a weapons offense that occurred at Mugshotz Tavern, located at 1902 S. 68th St. It was eventually determined to use the PA inside the Police squad to make announcements in an attempt to order Robert out of his residence.

PA ANNOUNCEMENTS

Officer Marchant was assigned to give the announcements over the PA and made her first one at 0046hrs. Officer Marchant stated the following in an attempt to have Robert exit his residence, This is the West Allis Police Department, residents at 1964 S. 68th St I need you to exit the front of the residence with your hands in the air. If your unable to exit call the West Allis Police Department at 302-8000. Again, this is the West Allis Police Department.

After Officer Marchant broadcasted her first announcement over the PA, Sgt Pasdera asked Officer Binter (who was positioned in the rear of the residence at 1964 S. 68th St) if he could hear the PA announcement and that it was coming across clearly. Officer Binter advised he could hear the announcement and it came across clearly. After doing the first announcement Robert still had not exited his residence, so Officer Marchant continued with the same announcement over the PA.

The following are the times Officer Marchant made the announcements over the PA; 0048hrs, 0049hrs, 0051hrs, 0052hrs and 0053hrs. After Officer Marchant made the announcement at 0053hrs I observed Robert exit his residence via the front door. A short time later, Robert was taken into custody for this incident by other Officers.

VOLUNTARY CONSENT FORM- BLOOD

While at the Hospital I asked Robert if he would voluntary consent to a blood draw for this incident. I had Robert view and read the voluntary consent form and he indicated he would be willing to submit to a blood test. I had Robert sign the form and I then signed it along with Officer Marchant. Officer

Marchant signed as a witnessing Officer and also heard Robert consent for the blood draw.

BLOOD DRAW

On 07/01/13 at approximately 0210 hrs, a blood sample was taken from Robert by Phlebotomist Jessica Neuendorf of Aurora West Allis Medical Center. The paperwork was completed and the blood sample was turned over to Officer Tuschl. The blood sample was transported to the West Allis Police Department and placed on property # 13-004825.

VOLUNTARY CONSENT- BREATH

Once I arrived back at the Police Station I asked Robert if he would voluntary consent to a breath test for this incident. After asking Robert to do that he indicated he would be willing to submit to a breath test. Robert had viewed the voluntary consent form and understood it.

OBSERVATION INFORMATION

On 07/01/13 at 0232hrs, I began observing Robert and certify that he did not smoke, regurgitate, vomit or drink alcoholic beverages for twenty minutes prior to the time this breath specimen was taken.

INTOXIMETER RESULTS

I administered the Intoximeter to Robert. I had observed Robert for the 20-minute observation period. Robert was identified by his Wisconsin Driver's License and was in custody for a weapons offense.

I gave Robert a basic instruction of the Intoximeter test. I informed him that he would be required to give at least two adequate samples of his breath. Robert stated that he understood and had no questions. At 0254hrs, Robert gave his first accepted breath sample of .181. At 0258hrs, Robert blew very hard into the mouthpiece and the Intoximeter read Mouth Alcohol- Test Aborted. After the Intoximeter displayed that message, the test was then aborted. After observing that message I reviewed it with Sgt Corwin and it was determined not to do another breath test, due to Robert consenting to the primary test.

During my contact with Robert I detected a strong odor of an intoxicant on his breath, slurred speech and red and glassy eyes. Based on my observations, training and experience as a police officer, I believe Robert S. Oleszek was under the influence of an intoxicant. Robert was cooperative with me during the breath test

IN-CUSTODY STATEMENT OF ROBERT S. OLESZEK- OFFENDER

On 07/01/13 at 0317hrs I conducted an interview with Robert S. Oleszek in the West Allis PD Booking room, interview room- B. The interview was recorded on Olympus Digital Recorder P14, with digital card P14-2. Robert was read his Miranda rights consistent with W.A.P.D Directive 42.016. Robert stated he understood his Miranda rights and wished to answer my questions without an attorney present.

The following is a synopsis of the interview;

I asked Robert if he was at Mugshotz earlier in the day and he stated "yes". Robert stated he was at Mugshotz around noon and I asked him where it was located. Robert stated it was located on S. 68th St near the "tracks". Robert said when he went to Mugshotz around noon he went there with his wife Gina. I asked Robert why they went to Mugshotz and he replied "Shawna works there". Robert stated Shawna is a bartender who he personally knows. Robert stated he ends up staying at Mugshotz for "a couple of hours", which he describes as 3 or 4. Robert stated when he left the bar he went home and Gina stayed behind. Robert stated he left because he had to work in the morning.

I asked Robert what happened when he went home he said "that was it" and stayed on the couch. I asked Robert if he ever went back to Mugshotz after he left around 3 or 4 and he stated "no". I questioned him about what happened to Gina and if he knew where she was. Robert stated he never went back to Mugshotz to look for Gina and believed she had been upstairs, sleeping. I told Robert when he was taken into custody by the Police that he indicated no one else was currently inside his residence. I asked him about the conflicting statements and he now stated Gina was not home and unsure where she was.

Robert was also unsure if he had contact with the Police Department around 7 P.M. on today's date. Robert stated he would not remember if he did or not because he was really drunk. I asked Robert how much alcohol he had to drink while at Mugshotz. Robert stated he had "blood mary's", and estimated having a couple more drinks. Robert also denied being in any altercation with Gina on today's date.

I then brought up the allegation that Robert had came back to Mugshotz around 11 while holding a gun, looking for Gina. After bringing that up to Robert he denied doing that. I told Robert that partons inside the bar observed him come back to the bar around 11 P.M. and he still denied doing that. I asked Robert why would the bartender and patrons tell the Police he went into the bar while holding a gun and he replied "that's not fair". When asked if everyone was lying to get him into trouble, Robert replied "I wouldn't put it

past them". Even after telling Robert that most of the patrons did not know who he was, he indicated they did and also knew who is wife was.

When I kept asking Robert on why he went back to the bar he would reply "that's not fair". Robert stated it was not fair because it was a bunch of "drunks" presumably telling the Police this. Robert continued to maintain that he went home and the next thing that happened was the Police banging on the door. I continued to challenge Robert on his truthfulness and he was unable to provide a reason on why he matched the description provided by the patrons. I asked Robert if he remembered what happened after he left the bar. Robert stated he did and that he went home and went to sleep. I brought up the possibility that Robert did not remember the incident because he "blacked out" due to drinking too much and he denied that possibility.

I then asked Robert more questions about where Gina was currently at and what happened tonight between them. Robert still denied getting into an altercation with Gina and could not say where she currently was. I continued to ask Robert why would the bar contact the Police and say he walked in there with a gun. Robert stated the bar patrons were all "full of shit" and "drunk". I asked Robert if he had gotten into a disagreement with someone inside the bar and they threatened to beat him up and he stated "no".

I attempted to have Robert explain how the Police found a gun inside his residence that matched the description of the gun he had on him, while at the bar. After asking Robert that he replied "does it have a trigger lock on it" over and over again. I asked Robert what types of guns does he own and he replied "12 gauge and 30-06". Robert also stated his daughter owns a "12 gauge" and he is holding onto a gun for his friend and described it as a "9mm". I asked Robert if it was a Glock and he stated "something like that" and added it had a "trigger lock". I again brought up about how Officers located a gun inside of Robert's residence which matched the description for this case and he could not explain why.

Robert continued to deny all allegations against him and that he went home around 4.

Interview was concluded at 0335hrs.

FOLLOW UP INVESTIGATION

After I finished speaking with Robert I attempted to make contact with his wife, Gina Oleszek to obtain her statement about what happened with him today. Robert provided Gina's phone number as 414-881-8453 and believed she was currently at her sister's residence. Robert stated Gina's sisters name is "Sarah Savasta" and lives somewhere in West Allis. Robert was unable to provide an exact address on where Sarah lived or where she lived by. Robert

also claimed no to know any contact numbers for Sarah.

I ran the name Sarah Savasta through the W.A.P.D Phoenix program but did not observe any local contacts with her. However, I did observe a contact with Adrianna M. Savasta (F/W 02/01/02) for 2050 S. 57th St. There was no phone number listed for Adrianna and the only contact with her was a motor vehicle accident from January of 2013. While reviewing that contact no parent information had been listed for Sarah. Based upon Robert's statement about Sarah living in West Allis, I went to 2050 S. 57th St to see if Gina was staying there. I knocked on the front door to the residence and an unidentified party answered the door. She indicated the Savasta's had moved out one month prior and she had no idea where they had moved to. I asked if Sarah Savasta had been living at this address and the party responded "no", and had never heard of anyone by that name.

I ran Sarah's name through Wisconsin CCAP records and found no contacts with her. I also attempted to locate a contact number through 411, but there were no numbers listed for her. As of 7/01/13 I have been unable to make contact with Sarah.

I attempted to contact Gina via her cell phone number, 414-881-8453 but I received a voicemail message. I left Gina detailed message asking her to call me back whenever she receives it. I left the message at 0412hrs on 07/01/13.

At about 0530 I was advised by Sgt Corwin that Robert was now saying Gina's sisters name was "Stacy" and not "Sarah" and lived near "60th and Forest Home Ave". In addition, Robert provided a phone number of 414-430-5663 for Stacy. At about 0550hrs on 07/01/13 I attempted to contact Stacy at the phone number but no one answered. I left Stacy a voicemail asking her to have Gina contact me about this case. I also ran Stacy's information through the Wisconsin CCAP system to see if I could locate an exact address for her. I observed Stacy had a civil case that was filed on 01/25/13 which listed her home address as 3608 S. 60th St in Milwaukee, WI.

Officer Plotkin reports... On 06-30-13 at approximately 2245 hrs, I responded to the area of 1902 S. 68 St., Mug Shotz tavern, for a report of a weapons call, man with a gun. While enroute to this incident, investigation revealed the offender associated with this incident, identified as Robert S. Oleszek, had left the above tavern and was seen by witnesses entering his residence, 1964 S. 68 St., following this incident. Officers subsequently coordinated a perimeter and containment around this residence.

Upon officers organizing containment of this residence, an arrest team was assembled to the immediate southwest of this residence, in which I was the element leader of. Officers attempted phone contact at the above residence and with Oleszek with negative results. During this time, Oleszek suddenly came to and opened the above residence western facing front entry door and front screen door. Officers ordered Oleszek to put his hands in the air and exit his residence. Oleszek refused, yelled "Fuck You!", some other obscenities, and slammed his residence front entry door shut, remaining inside this residence and out of view of officers. Officers continued to attempt phone contact at this residence and with Oleszek with negative results.

Officers then began announcements for Oleszek to exit the residence or contact police via squad public address system as a result of Oleszek refusing to answer our attempts at phone contact. Following numerous announcements, Oleszek again suddenly opened the residence front door. Officers ordered Oleszek to put his hands in the air and exit his residence. Oleszek initially refused, was uncooperative, yelled various obscenities, yelled "Fuck You!" to officers, and yelled other unitelligible statements. I continued dialog with Oleszek during this time and was subsequently able to persuade Oleszek to exit his residence with his hands in the air.

Oleszek remained uncooperative during this time, refused to step off of his residence front porch, continued to yell obscenities at officers, and argued with officers regarding the above requests. I continued dialog with Oleszek during this time and was subsequently able to persuade Oleszek to step off of his residence front porch. During this time, Oleszek was very agitated, continued to yell, yelled various obscenities at officers, repeatedly lowered his hands, repeatedly refused to follow directions, repeatedly argued with officers regarding the above requests, and required extensive levels of verbal persuasion to achieve any level of compliance.

I was subsequently able to persuade Oleszek to walk toward my location and the above arrest team. Once in a desirable position and near the arrest team to the immediate southwest of this residence, I ordered Oleszek to prone out on the ground. Oleszek became very agitated by this, refused, yelled various

obscenities at officers, stated that he would not do this, and began lowering his hands. I continued to order Oleszek to prone out on the ground with negative results and with the above responses by Oleszek to these orders. As a result of Oleszek's non cooperation and resistance to these efforts, a result of Oleszek's violent actions during this incident, and the high probability of a violent resistive episode by Oleszek during arrest based upon his above behavior, a Taser device was subsequently deployed upon Oleszek and Oleszek was taken into custody by officers against his physical resistance.

Investigation revealed Oleszek had come to the above tavern armed with a firearm looking to confront his wife, in which Oleszek believed may be at the above tavern. Once detained, Oleszek was debriefed, and as a result of the nature of this incident and the violent actions of Oleszek during this incident, officers subsequently moved up to clear the above residence in an effort to check on the welfare of Oleszek's wife and/or any other potential occupants of this residence. Officers subsequently cleared the above residence and did not locate anyone else inside. While clearing the residence, I observed various firearms, firearm accessories, ammunition, marijuana, and a marijuana pipe, in plain view, throughout this residence.

During this time and shortly following officer entry into this residence, a dog inside this residence fled out of the residence front entry door. Officers were unable to capture this dog and this dog remained at large.

Following the above residence being secured by officers, and as a result of the nature of this incident and the violent actions of Oleszek during this incident, the residence rear detached garage was also cleared in an effort to check on the welfare of Oleszek's wife and/or any potential occupants. This rear garage was locked and the garage pedestrian entry door, located on the west side of this garage, was forced open to gain entry, damaging this door, as a result. No one was located inside this residence garage. Officers were subsequently able to secure this door via deadbolt, as this deadbolt was not damaged, and the above garage was fully secured by officers, as well as the above residence, prior to officers clearing the scene.

The above weapons and contraband were seized by officers, and their locations photographed and documented, while on scene. Officers cleared the scene of this incident and the above residence following the conclusion of this investigation.

ATTEMPT CONTACT WITH GINA OLESZEK

On 07/01/13, I was asked by Lt. Johnson to follow up on this case regarding Gina Oleszek. Lt. On 07/01/13 at approximately 1130 hrs, I also attempted to make contact with Gina's sister, Stacy Savasta, via phone (414-430-5663), but received her voicemail. I left a message with Stacy asking her to contact the West Allis Police Department, so we can speak with her in regards to her sister, Gina, and verify that Gina is okay.

ACCURINT CHECK

I conducted an Accurint check on both Gina and Stacy, to see if there were any other phone numbers or addresses listed for them. Gina's most current address listed to 1964 S. 68 St, and Stacy's most current address listed to 3608 S. 60 St., which was also listed on CCAP (per Officer Tuschl).

conversation Gina told Lt. Johnson she was slapped by Robert prior to her leaving with their 11 month old daughter.

Prior to leaving the station I called Gina and left her a message. She called me back a short time later and told me it was fine to come out and speak with her. Gina told me she was staying at a friends residence at 2231 S. 68 St.

CONTACT WITH GINA L. OLESZEK-VICTIM

Upon arrival at 2231 s. 68 St., Gina L. Oleszek let us into the residence. Gina said for now she was going to stay with her friend Eva J. Graf. Gina said she did not know how the police were called and what happened but she does know that Robert is in jail because he is trying to contact her. While speaking with Gina, Robert called collect twice from the jail. I asked Gina if she could tell me about yesterday and the events involving her husband Robert.

Gina said her and Robert walked up to Mugshots bar at 1902 S. 68 St. at 1200 hrs. to have some bloody mary's. Gina said she has two older daughters from a previous relationship, Jayna Ranic who is 14 and Trinity Ranic who is 10 and two daughters with Robert, Hope who is 7 and Robin who is 11 months. Gina said her two older daughters were home watching Robin while her daughter Hope was by her sister's house in Milwaukee staying overnight.

Gina said her and Robert drank at mugshots till around 5:00pm and Robert said he was going to go home. Gina said she thought Robert was going to go home and just pass out. Gina said a friend of their's Shawna Fischer was bartending till six so she stayed and talked with her and then her friend, Eva Graf, came up too. Gina said Eva is actually Robert's cousin and came up shortly before he left to walk home. Gina said while at the bar she missed a few calls from Robert and upon calling him back he said, "Bitch you ignoring me?" along with "I'm gonna bring the baby to the bar bitch." Gina said she had no idea what had transpired within the hour of Robert leaving. Gina did say Robert has abused prescription pills in the past but didn't think he used them any more. Gina said, "It wasn't appropriate for my baby to be at the bar so I left." Gina said when she got outside of mugshots, Robert was coming down the block with their 11 month old daughter and threw her to Gina. Gina said she was actually "airborne" and I caught her.

Gina said Robert looked crazy so she was going to go to the house, gather some things for the baby, and stay at Eva's. Gina said when she arrived at her residence she was looking for Trinity who was supposed to still be home, but she later found out that Robert gave her \$10.00 to leave and go to a friends house. I asked Gina where her other daughter, Jayna was and she said she left earlier to go to a friend's house. Gina said she gathered what she could and left her residence. Gina said prior to leaving Robert was slurring his words and yelling at her and had his arm cocked back while making a fist. Gina was holding their 11 month old daughter at the time and she said to Robert, "What

are you going to do hit me?" Gina said she got her and her daughter into a semi-fetal position and closed her eyes expecting Robert to hit her. When it didn't happen she stood up and Robert backhanded her across her face. Gina said either one of Robert's hang nails or something scratched her lip. I looked at Gina's lip and observed a very small scratch that was slightly visible.

Gina said a short while later she was getting calls from Robert, one being he was going to kill her. Gina told myself and Holly that her sister always said to her that Robert was going to kill her. Gina said I just didn't believe it. Gina said the next thing she knew, she was getting collect calls from the jail and figured Robert got arrested.

Gina said she went back to the house today to gather some items and it was "trashed." She said there were pictures strewn around and items broken and it looked like a mess. I told Gina that I had some things I needed to tell her and informed her of Robert going into mugshots with a gun looking for her. Gina said, "Oh my god Jay (Jason Schilling) must have called!" Gina explained that Jason is a friend to both her and Robert and it must have been really bad if he called the police. I told Gina that Robert is obviously in custody and the case will be reviewed tomorrow. I asked Gina if she would be available by phone for the district attorney's office to contact her. Gina said, "Yes, I will be."

Gina was crying and told Holly and I she was feeling overwhelmed because she has four children and currently doesn't work. Gina said her and Robert have had some rough times but she thought that was all over with. Gina said she has no idea where any of this came from with Robert becoming so violent. Gina did fear for her safety and the safety of her children when I explained to her what had taken place with Robert at mugshots bar.

Gina was given information from Holly and also a cell phone in order for her to use. Prior to leaving the residence I did have Gina sign the 72 no contact provision and audio recorded the messages left by Robert on her cell phone.

CONTACT WITH THE DOMESTIC VIOLENCE HOTLINE

On 07/01/13 I contacted the domestic violence hotline at 1500 hrs. and spoke with Norma . I informed Norma about speaking with Gina and having our victim advocate Holly Stephens with me at the time of contact.

- 4. Fourth message was from Robert on 06/30/13 at 1902 hrs. The message starts out, "This is Bob" then he pauses and begins to say something but it is garbled. The next portion of the message I could hear was Robert stating, "I'm going to come up to the bar (he pauses) and then said, "I'm going kill you, bye."

Officers went outside to the sidewalk and Spor came over to us. Spor advised he observed the M/W party that was in the altercation come out of 1964 S. 68 St. and observed him walking southbound on S. 68 St. He pointed out a M/W party wearing a white t shirt. I observed the M/W party and never lost sight of him. Officers made contact with the M/W party, who was later identified as Daniel J. Anderson at 2036 S. 68 St. Anderson, who was with two young girls, advised he lives at the residence and was out with his two daughters. He stated he was not in any physical altercation.

CONTACT/ROBERT S. OLESZEK/1964 S. 68 ST.

Officers went to 1964 S. 68 St. to attempt to speak with the resident. I observed a M/W party, who later identified himself as Robert S. Oleszek, come out of the residence to the porch. I asked him if anyone else lived at the residence, which he told me no. I then asked Oleszek for basic information. When I asked him for his phone number, he told me "it's on there". I told him I did not understand his telephone number and Oleszek finally gave me the number.

During my contact with Oleszek, his speech was slow and slurred. I observed his eyes were red and glassy. While I was speaking with him, he was unsteady on his feet and his body swayed from side to side. I detected a moderate odor of intoxicants emitting from his breath. I observed several empty beer cans on the front porch.

Sgt. T. Clementi reports:

At 1157hrs I began to attempt phone contact at 881-2064. This number went straight to voicemail. I immediately followed up with a phone call to the 607-1193 number, but it went to a busy signal. I would continue to alternate between these numbers every few minutes in an effort to make contact with someone at the residence. I was never able to reach anyone at either of these numbers.

Just before 0024hrs I was provided the two remaining numbers of 395-3092 and 881-8453. At 0024hrs I contacted 395-3092 and got an all circuits are busy message. I would call this number several more times and each time got the same message. At 0025hrs I called 881-8453 and a voicemail message for Gina picked up. I left a message on the voicemail requesting whomever got the message to contact the police department. I continued to attempt contact at that number, but did not leave further messages.

I made numerous attempts rotating through the numbers we were able to locate and was never able to make contact with anyone. Based upon the lack of ability to make contact by phone it was determined that an attempt using the PA system should be attempted next. Off. Marchant was assigned to give verbal PA messages as an attempt to contact the occupants of 1964 S 68 St. (See Off. Marchants supplement)
