Dear Ms. Bell:

This letter is being provided pursuant to the Federal WARN Act and the Wisconsin Business Closing Law to notify you that Hub South Chrysler Jeep ("Hub South"), which is part of the Griffin Auto Group ("Griffin"), has announced the permanent closing of its Hub South Chrysler Jeep dealership located at 3035 South 108th, West Allis, WI 53227. In conjunction with that closing, Hub South will permanently terminate the employment of all 64 employees at that site. However, Griffin will be offering comparable employment to many of those employees at either its Griffin Dodge Mitsubishi Dealership in Menomonee Falls or at its Griffin Ford dealership in Waukesha. The expected date of the first employment separation is March 31, 2008.

Notices of the closing and related layoffs are being provided to all affected employees. None of the affected employees are represented by a union and none have bumping rights. In accordance with 20 C.F.R. §639.7(f), a list of the affected positions and affected employees within each job classification is being maintained on site at Griffin at its Menomonee Falls, WI office.
