- 1. That Affiant, PETER AGNOS, is a resident of the City of West Allis, with a home address of 2851 South Root River Parkway, West Allis, Wisconsin 53227.
- 2. That, as of the date of this Affidavit, I am the owner of record of the property located at 7727 West Greenfield Avenue, as well as the property located at 1420 South 78th Street, both of which are located in the City of West Allis.
 - 3. That I am in the process of selling the above-referenced properties.
- 4. That the 78th Street property was a subject of an application process for a Transitional Use Permit in the City of West Allis.
- 5. That the Transitional Use Permit was denied by the City of West Allis Common Council on August 6, 2002.
- 6. That Affiant sought a Writ Certiorari in Milwaukee County Circuit Court, and said Writ of Certiorari decision was in favor of the City of West Allis.

That, if the Greenfield Avenue property and the 78th Street property are sold to another individual, and the City of West Allis grants said new owner the appropriate permit so as to allow the new owner to use the 78th Street property as a parking lot, Affiant will not seek legal recourse against the City of West Allis in any way, shape or form.
