01 July 2006...Case 06-008411...Knights of Columbus..1800 S 92 St


During an event booked as a "Birthday Party" several fights broke out inside and outside the hall and several shots were fired by at least one attendee, injuring two others not involved in the fight.

04 July 2006...Case 8578...Boz's Sports bar...1325 S 70 St
Several patrons were in the tavern when an ex-boyfriend of one of this group came in with another male party. He was asked to leave by management to avoid problems, and did so but he was followed out by the original group, who choose the same moment to leave the tavern. A fight broke out in the parking lot and several people received minor injures. The bar did not phone police, and all parties left the area. The call came in to the police later from the female who's ex-boyfriend came into the bar, after she arrived at home in Milwaukee.

15 July 2006...Case... 9152....Magoos Tavern....8911 W National Av Officers observed what appeared to be several parties about to fight near 88 and National. Parties fled from officers and were later apprehended. The parties were intoxicated and admitted to having been drinking alcoholic beverages in Magoo's tavern.
