In keeping with Time Warner Cable's tradition of providing customers with state of the art technology, I am writing to inform you that we are continuing to upgrade customers to "Navigator", Time Warner Cable's newest interactive program guide. Navigator is the tool which will allow Time Warner Cable customers to experience new products such as:

- Start Over
- Fantasy sports
- Instant News and weather

Time Warner Cable's Navigator makes finding what you want as easy as A, B, C. The program guide features include:

- A Access Menu. See what's on now by specific programming content. View shows that are playing right now on "Wisconsin On Demand", "News and Weather", "Sports", "Kids Programming", "HDTV" and more.
- B Find programming. The Navigator stores titles of upcoming shows for 7 days. Search for your favorite shows by category, title or rating.
- C Back Button. Returns you to your previous menu.

Increased Parental Control options that parents can use to protect their children from programming they don't want them exposed to. Parents will be able to block by title, channel, rating – and now by content –advisory labels such as "Violence" or "Coarse Language"

Over the next few months, customers who have a digital converter or a DVR will begin to see the new program guide on their TV, as we roll Navigator out in phases throughout Wisconsin. As with any new product we launch, we have taken steps to notify our customers prior to each phase of our roll out. Customers will be notified with a telephone message and Navigator Guide mailed to their residence.

In addition, Time Warner Cable was recently notified that effective April 14, 2008, Sports Illustrated on Demand, on Time Warner Cable's channel 1403, will no longer be providing content and we will remove it from our lineup.
