

**CITY OF WEST ALLIS
RESOLUTION R-2023-0541**

**RESOLUTION APPROVING AN AMENDMENT TO THE NEIGHBORHOOD SMALL
GRANT AGREEMENTS AND GRANT APPLICATIONS**

WHEREAS, the Mayor and Common Council of the City of West Allis, along with staff and citizens, recognize the importance of developing and maintaining healthy neighborhoods throughout the community; and,

WHEREAS, the Common Council of the City of West Allis under Resolution R-2014-0099 the City of West Allis Neighborhood Small Grant Program provides small grants (Organizational and Focus grants) to help organize neighborhood associations and to provide grants for neighborhood enhancement projects; and,

WHEREAS, in order to obtain the Organizational Grant a neighborhood association must first be formally recognized by the Common Council, have an establish financial institution and W-9.

WHEREAS, the Organizational Grant shall offer a total available grant amount up to \$1,000 for first time organizing Neighborhood Associations. The grant agreement attached ORG EXHIBIT. The Focus Grant shall offer a total available grant in the amount up to \$2,000 in accordance with program policies, and based on availability of funding. The grant agreement attached Focus EXHIBIT, and,

WHEREAS, every neighborhood association upon approval of the Focus Grant shall request reimbursement from the City but shall contribute 25% share towards the approved project scope. The reimbursement form attached r-Form EXHIBIT, and

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that it hereby has reviewed the request to increase the amount of the West Allis Organizational Grant total up to \$1,000 and Focus Grant up to \$2,000 under the City of West Allis Neighborhood Small Grant Program.

BE IT FURTHER RESOLVED that up to \$1,000 will be appropriated for the Organizational Grant and up to \$2,000 will be appropriated for the Focus Grant upon the approval from the West Allis Common Council.
