Greenfield Ave., West Allis, Wisconsin, to vote on a motion to convene in closed session at said time and in Room 118 to deliberate and confer with the City Attorney on the Summons and Complaints regarding:

A closed session for the above purpose is authorized pursuant to the provisions of Wis. Stats. Section 19.85(1)(a) and (g), which authorizes a governmental body, upon motion duly made and carried, to meet in closed session to deliberate concerning a case which was the subject of any judicial or quasi-judicial trial or hearing before that governmental body; and to confer with legal counsel for the governmental body who is rendering oral in which it is or is likely to become involved.
