Greenfield Ave., West Allis, Wisconsin, to vote on a motion to convene in closed session at said time and in Room 118 to deliberate and confer with the City Attorney on the Summons and Complaints regarding:

A closed session for the above purpose is authorized pursuant to the provisions of Wis. Stats.
