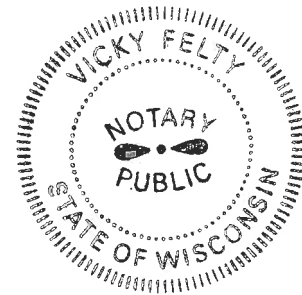

WHEREAS, the City needs to  
obtain funds for the public  
purpose of financing street im-

provement projects.

RESOLVED that the City of  
West Allis, Milwaukee County,  
Wisconsin, borrow an amount  
not to exceed \$2,750,000 by  
issuing its general obligation  
bonds for the public purpose  
of financing street improve-  
ment projects.

The Wisconsin Statutes (s.  
67.05(7)(b)) provide that the  
initial resolutions need not be  
submitted to the electors un-  
less within 30 days after  
adoption of the initial resolu-  
tions a petition is filed in the  
City Clerk's office requesting a  
referendum. This petition  
must be signed by electors  
numbering at least 10% of the  
votes cast for governor in the  
City at the last general elec-  
tion. A petition may be filed  
with respect to any one or  
more of the initial resolutions.
