WHEREAS, The Health Department has requested purchasing flu vaccine from FFF Enterprises, Inc. and GlaxoSmithKline (GSK) for the 2009/10 flu season; and,

WHEREAS, the Health Department of the City of West Allis has determined that this contract is inappropriate for competitive selection because the previous distributors from the Multi State contract were unable to guarantee early shipment. Availability and delivery schedule from FFF Enterprises and GSK is guaranteed and pricing is set by the CDC government contract.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the proposal from FFF Enterprises, Inc. for providing 100 viles of Fluviron for \$7000.00 and the proposal from GSK for providing 100 viles of Flulaval for \$5950.00 for the total net sum of \$12,950.00 be and is hereby accepted.

BE IT FURTHER RESOLVED, that the Purchasing/Central Services Division be and is hereby authorized to enter into a contract for the aforesaid vaccines.

RE: Sole Source Purchase Flu Vaccine

To Whom It May Concern:

This letter is to recommend that we purchase flu vaccine from FFF Enterprises and GlaxoSmithKline for the upcoming 2009 influenza season. The prices are determined by the CDC government contract and both companies guarantee flu vaccine shipment by September 30, 2009. Also, both distributors offer this vaccine as returnable in full vials by December 31, 2009. The other distributors do not offer this option. In the past the distributors used on the Multi State Contract were unable to guarantee early shipment, which negatively impacts our revenue. I request your approval of these vendors for the purchase of our annual flu vaccine. Thank you.
