**RESOLUTION TO APPROVE THE BID OF LALONDE CONTRACTORS, INC.  
FOR STREET CONSTRUCTION AT W. MITCHELL ST. FROM S. 56TH ST. TO S  
60TH ST. IN THE AMOUNT OF \$3,954,921.08**

**WHEREAS**, the Board of Public Works duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as hereinafter described, and the bids were reasonable; and,

**WHEREAS**, the Board of Public Works recommends and deems it to be for the best interests of the City of West Allis that the bid of LaLonde Contractors, Inc. for 2026 Project No. 5 be accepted.

**NOW THEREFORE**, be it resolved by the Common Council of the City of West Allis that the bid of LaLonde Contractors, Inc. for 2026 Project No. 5 for the installation of concrete curb and gutter, concrete pavement, concrete sidewalk, driveway replacement, sanitary sewer relay, storm sewer relay, water main relay, building services and utility adjustments at W. Mitchell St. from S. 56th St. to S. 60th St. (2026 Project No. 5) for the sum of 3,954,921.08 be accepted.

**BE IT FURTHER RESOLVED** that the proper City officers are authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

**BE IT FURTHER RESOLVED** that said improvements be installed with funding by street & utility bond funds, storm cash, and Capital Projects cash reserves (future reimbursement from special assessments), account numbers 350-6008-531.31-01, 540-1807-538.75-01, 501-2901-537.75-01, and 510-3803-536.75-01.


