The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of January 2010.

Police report incidents involving licensed businesses:

Incident reports:

Case 10-000005, 01/01/10 at 0204hrs. Mario's, 1900 S 60 St.

On the above date and time an officer on routine patrol observed an altercation in the entryway at Mario's. A female was arguing and attempted to grab or strike another female party just inside of the main entrance to the tavern. One of the females involved refused to listen to officers and was eventually arrested for Disorderly Conduct.

Call 10-000035, 01/01/10 at 0313hrs. Smokin Joe's, 6139 W Beloit Rd

On the above date and time officers responded to an anonymous call of a male armed with a knife causing a disturbance in Smokin Joe's. Officers checked with the bouncer who stated that they escorted a person matching the description provided by the officers out of the tavern for arguing with other customers. The bouncer stated that he did not see a knife on the party. Officers were unable to locate the party.

Case 10-000258, 01/01/10 at 0118hrs. Smokin Joe's, 6139 W Beloit Rd

On the above date and time officers responded to Smokin Joes after receiving a call from the bartender about trouble with a patron. He stated that they had a subject who was refusing to leave, tried taking drinks from other customers and attempted to strike an employee of the bar with a beer bottle. The party was still at the bar when officers arrived and was arrested for Disorderly Conduct and Resisting.

Case 10-000571, 01/18/10 at 2105hrs. Boz's Sports Bar, 1325 S 70 St.

On the above date and time officers responded to Aurora West Allis Medical Center in regards to a party there claiming he had been assaulted at Boz's Sports Bar. The party had a broken nose as a result of the altercation. After investigation it was revealed a fight had indeed taken place in the bar. The offender was arrested and charged with Substantial Battery. The bartender was advised to call the police when having a problem in the bar.

Call 10-002972, 01/20/10 at 1443hrs. Magoo's, 8911 W National Ave

On the above date and time officers responded to Magoo's for a report of an intoxicated party passed out at the bar. The bartender stated that she served the party two drinks and noticed a short while later the party was passed out in his seat. The party was transported to Aurora West Allis Medical Center for treatment and eventually taken to Mental Health after attempting to leave the hospital.
