**RESOLUTION TO UPDATE LICENSING AND INSPECTION FEES FOR FOOD,  
LODGING, HOUSING, OTHER BUSINESSES, AND WEIGHTS AND MEASURES**

**AMENDING THE FEE SCHEDULE**

**WHEREAS**, the state Department of Agriculture, Trade, and Consumer Protection updated its fees relating to lodging and created new categories of fees related to various types of lodging; and

**WHEREAS**, the City, as an agent of the state, must utilize the same categories and establish its own fee schedule for those categories; and

**WHEREAS**, other fees were also in need of updates to reflect the actual cost to perform that service;

**NOW THEREFORE**, be it resolved by the Common Council of the City of West Allis, in the State of Wisconsin, as follows:
