RESOLUTION R-2021-0040**

**RESOLUTION GRANTING A PRIVILEGE FOR ENCROACHMENT (MAJOR) TO
NEW OWNER CAMINOWA LLC FOR PROPERTY LOCATED AT 7211-13 W.
GREENFIELD AVE. (TAX KEY NO. 453-0089-000)**

WHEREAS, by Resolution No. R-2009-0264, adopted December 15, 2009, the City of West Allis granted to Suzanne Ball a certain Privilege for Encroachment Beyond the Lot Line and Within Public Street Right-of-Way consisting of existing eight (8) exterior commercial grade sign lights (4 at each address) and an existing projecting canopy on the property located at 7211-13 W. Greenfield Ave. (“Privilege”); and,

WHEREAS, the property has now changed ownership to Caminowa LLC, who desires to retain the Privilege; and,

WHEREAS, the new owner of the property, Caminowa LLC, desires to include the installation of a projecting sign on the property located at 7211-13 W. Greenfield Ave.

NOW THEREFORE, BE IT RESOLVED that the City of West Allis grants to Caminowa LLC the Privilege for Encroachment Beyond the Lot Line and within Public Street Right-of-Way consisting of the installation of a projecting sign, existing eight (8) exterior commercial grade sign lights (4 at each address) and an existing projecting canopy on the property located at 7211-13 W. Greenfield Ave.
