SUMMARY

Officer Eklund reports...DISORDERLY CONDUCT 1901 S. 60 ST....On 08/24/14 at approximately 1956 hrs, officers responded to a report of a M/W party wearing a yellow shirt who was causing a disturbance inside the restaurant. On scene, officers made contact with the party, Chanceler J. Primeau, M/W, 02/17/88, inside of M&M's bar, 1900 S. 60 St. Primeau became uncooperative outside of the bar and failed to listen to officers. Officers attempted to locate a responsible and sober party to pick up Primeau, but were unable. Primeau was transported to the West Allis PD during which time he became boisterous and slammed his head against the plexiglass divider of the squad. Primeau was fingerprinted, photographed and booked with #14-003999 and issued municipal citation M140039991 for Disorderly Conduct. Primeau punched the metal door while in holding cell #4 and rescue was dispatched, at which time WAFD took custody of Primeau.

NARRATIVE

INITIAL CALL

On 08/24/14 at approximately 1956 hrs, officers responded to 1901 S. 60 St. for a report of a M/W party wearing a yellow shirt who was creating a disturbance inside of the residence. On-scene, officers made contact with Chancellor J. Primeau, M/W, 02/17/88, inside of M&M's bar, 1900 S. 60 St.

ON-SCENE STATEMENT - CHANCELER J. PRIMEAU - OFFENDER // OFFICER OBSERVATIONS

Primeau was located inside M&M's Sports Bar speaking with a M/B party. The M/B party stated Primeau was trying to find his way home. Officers asked Primeau to step outside of the bar to talk. Primeau was boisterous, extremely unsteady on his feet, had a strong odor of an intoxicant emitting from his breath, his speech was extremely slurred and his emotions were extremely sporadic.

Primeau kept attempting to reach his hands inside his pockets after he was asked not to and continuously did not listen to officers. Officers took control of Primeau's hands based on his refusal to comply with officer's orders. Primeau began to tense his arms while officers brought his hands behind his back to detain him. Officers ordered Primeau to stop tensing his arms, Primeau complied, and was detained with handcuffs which were double locked.

Primeau was unable to tell officers where he lived or where he came from on this date. Primeau was placed in the back of a marked West Allis squad while officers attempted to locate a responsible and sober party to pick him up. During this time, Primeau continued to yell and call officers "Madame". At one point, Primeau began slamming his head against the plexiglass divider inside the squad car and was asked to stop, which he did. Primeau also began yelling, "I have no friends!", "I love her so much!", and complaining his girlfriend did not want to be with him.

Primeau did not want to be transported to detox and none of the persons contacted wanted to take custody of him, so officers placed Primeau under arrest for Disorderly Conduct and transported him to the West Allis Police Department.

ARREST DECISION

Based on reports from Las Palmas restaurant stating Primeau was causing a disturbance inside the restaurant, Primeau's behavior outside of the sports bar, and his behavior inside of the squad car, Primeau was placed under arrest for Disorderly Conduct and transported to the West Allis PD for booking and citation issuance.

TRANSPORT // BOOKING // CITATION ISSUANCE

Once inside the police department, Primeau continued to be extremely defiant, boisterous, and did not follow officer's orders. Primeau was placed inside interview room A and at one point refused to sit down. Officers entered the interview room at which point Primeau continued to refuse to sit down despite officers attempt to assist him in sitting down. Primeau eventually sat on the stool without assistance from officers.

Primeau was eventually able to be photographed, fingerprinted and booked with #14-007506 and was placed in holding cell #4 to be held until sober. Primeau was issued municipal citation #M140039991 for Disorderly Conduct with a court date of 09/29/14 at 0830 hrs.

While inside the cell, Primeau continued to bother officers in dispatch and yell incessantly. A short time later, Primeau reportedly punched the inside of the cell door full force with his right fist.

Primeau was brought out into the booking area and rescue was requested to respond. The knuckles on Primeau's right hand began to swell and he had several small abrasions on his knuckles which were slightly bleeding. Primeau was allowed to attempt to call his girlfriend with his cell phone. Upon WAFD arrival, Primeau refused to get off the cell phone and pulled his hand away from officers. Officers stabilized Primeau's hands while the phone was taken from him. WAFD continued their assessment and Primeau stated he wanted to go to the hospital to get his hand checked out. WAFD took custody of Primeau and his property and transported Primeau to AWAMC.
