### DISPATCH TO CALL/ARRIVAL ON SCENE

On 6/23/13 at 2344hrs officers responded to Barneck's, 7411 W Becher St for a report of people fighting in the bar. Officers arrived on scene and met with multiple individuals.

#### STATEMENT OF VICTIM - AARON DOLINSKI

I spoke with Aaron Dolinski on scene. Dolinski, 19 yoa, was in the bar with his mother Eva. Dolinski stated his step-father, Brian Videkovich, came into the bar at approximately 2330hrs. Dolinski stated that his mother and Brian often have problems and argue a lot. Dolinski stated he went to the bathroom for a brief moment when he began to hear noise out in the bar. When he opened the door, he observed Brian and Eva yelling back and forth at each other.

Dolinski stated he stepped in and stated "Don't talk to her like that" after Brian was making derogatory comments about her. Dolinski stated Brian had knocked Eva to the ground and he stepped in to break the fight up. As Dolinski was attempting to break up the fight after he observed his mother being pushed to the ground two times. Dolinski stated when he tried to break up the fight, Brian grabbed him and held him to the ground. Dolinski stated Brian eventually left the bar after the bartender called 911.

Dolinski received a cut on his left foot, 2nd toe, from the incident. Dolinski was also bleeding from his face, but believes that mark was due to him picking a

#### STATEMENT OF VICTIM - EVA VIDEKOVICH

Eva was highly uncooperative on scene and was unable to give a clear statement on the incidents that occurred.

#### LACK OF CONSENT

Dolinski stated at no time did he give Brian consent to push him to the ground, causing him pain and a small laceration to his foot.

#### 72 HOUR NO CONTACT FORM

I explained the 72 hour no contact form to Eva and Aaron. Aaron stated he understood the provisions and signed the form. Eva refused to sign the form. I provided both parties with a copy of the form and a crime victim information sheet. The DV hotline was no contacted on scene because both parties stated they did not wish to speak with a victim advocate.

#### ON SCENE STATEMENT OF OFFENDER - BRIAN VIDEKOVICH

#### ARREST DECISION

Based upon the statement given by Dolinski and Eva, Brian was placed into custody and transported to the main station for booking.

### IN CUSTODY STATEMENT OF OFFENDER - BRIAN VIDEKOVICH

On at 0107hrs in Interview Room A, I read Videkovich his Miranda Rights from WAPD Directive 42.016. In response to waiver questions, Videkovich stated he understood his rights and agreed to speak with me at the time.

In response to questions, Videkovich stated he came to the bar for approximately 10 minutes after finishing working on his residence in West Allis. When Brian came into the bar, he observed Eva in the back playing games on the computerized slot machines. Brian brought up Eva's gambling problem and stated Eva became very defensive. Brian stated they argued about their money problems and Eva shut the

machine off and got out of her chair and began to push him stating "we're going to be out of here". Brian believes this was in reference to a possible divorce in the near future.

Brian stated Eva continued to push him in the bar so he completed a "stiff arm" type of move to attempt to get Eva to stop her advancement. As this incident is going on, Eva shouted to Aaron, who was in the bathroom at the time. Brian stated Aaron ran out of the bar and came at Brian. Brian stated Eva fell to the ground as Aaron grabbed a bottle from the bar, smashed it and came at Brian with the broken, edged section of the bottle in hand. Brian stated he wrestled Aaron to the ground after Aaron had swung at him, striking him in the chest, causing his chest to bleed.

Brian stated Eva continued to jump at Brian during the incident as he tried to control both Aaron and Eva as he did not realize what was going on. Brian stated he left the bar because he did not know what to do. Brian stated he returned to his residence after the incident.

The interview concluded at 0115hrs. The interview was recorded using WAPD Olympus Digital Voice Recorder #P14. The interview was stored on WAPD Memory Card P14 #4. I placed the memory card in an envelope and secured it in the ID Bureau drawer.

#### NARRATIVE

Officer Tuschl reports...

#### INITIAL RESPONSE

On 06/23/13 at about 2344hrs I responded to Barneks, located at 7411 W. Becher St for a report of three people physically fighting in the bar. Once I arrived on scene I was directed to speak with bartender (later verbally identified as Michelle A. Alexander) inside Barneks to see if she witnessed the physical fight. Michelle gave me the following statement.

### ON-SCENE STATEMENT OF MICHELLE A. ALEXANDER- WITNESS

Michelle stated she is currently employed as a bartender at Barneks and was employed in that capacity during this incident.

Michelle said on today's date a couple that she knows as "Eva" and "Brian" were inside Barneks. Michelle said Eva had been at the bar longer then Brian was. Michelle stated when Brian finally arrived on scene he ordered a beer and spent about fifteen minutes seated at the bar. Michelle said while this was going on Eva was playing one of the video poker machines. Michelle stated at one point Brian walked over to where Eva was playing and started yelling at her. Michelle stated it appeared Brian was mad at Eva because she was playing the video poker machines and would not stop playing when he asked her to.

Michelle stated both Brian and Eva ended up getting into a physical confrontation inside the bar, by the video poker machine. Michelle said she observed Brian push Eva four separate times, with one of the pushes causing Eva to fall to the ground. Michelle stated around this time is when Eva yelled at her to call 911, due to Brian's behavior. Michelle said the incident ended after she called 911 and Brian exited the bar. Michelle believes Brian left the bar because she ended up dialing 911. I asked Michelle if Eva was injured as a result of falling to the ground. Michelle stated she observed that Eva was bleeding, but did not specifically recall where on her body she was. Michelle indicated no one else was involved in the fight.

Michelle stated she is familiar with both parties because they frequent Barneks. I asked Michelle if she knew the last names of both parties and she stated "no". Michelle did not appear to have any more personal information about the two.

After speaking with Michelle I attempted to have Eva read over and sign the 72 hour no contact provision sheet. After I finished explaining the sheet to Eva I requested that she sign it, indicating she understood the terms of the no contact provision. When I asked Eva to sign it she refused and played down tonight's incident.

I also asked Eva if she would be willing to appear in person for the District Attorney's Office review and she indicated she would not attend it.

While interacting with Eva I observed a large bump on her forehead. I asked Eva several times about the injury and she insisted it was a result of a work accident. Eva was uncooperative with the Police investigation throughout this entire incident.

#### NARRATIVE

Officer L. Binter reports:

#### CALL FOR POLICE

On 06/23/13 at approximately 2344 hours, officers responded to Barneks (7411 W. Becher St.) regarding the bartender who called to report a physical fight between 3 subjects. One of the subjects had already left prior to officers arrival. I responded on scene and Officer Foy advised after he spoke to the victim, Eva C. Videkovich (F/W, DOB 09/15/76), the offender, Brian K. Videkovich (M/W, DOB 06/19/70), may have possibly went back to his residence 2172 S. 86 St. Officer Foy advised there was probable cause to arrest Brian for DC/DV. I responded to the above address and made contact with Brian, who was sitting on the front porch of his residence, smoking a cigarette.

#### ON-SCENE STATEMENT-BRIAN K. VIDEKOVICH-OFFENDER

Brian stated he finished staining the floors and walked over to Barneks to inform Eva she should come and look at the finished product. Brian prefaced at this point there has been numerous problems between Eva and her son, Aaron A. Dolinski  $(M/W, DOB\ 03/13/94)$ , who was also present at the tavern. Beyond the problems with her son, Brian also informed me Eva has a gambling problem, which he has told the bartender at Barneks about to keep her out of trouble.

While at the tavern, an argument ensued between Brian and Eva related to the above two issues. The argument soon turned physical when Eva pushed Brian in the upper chest region. Brian pushed Eva back and told her to stop and just come home. Brian stated Eva pushed him a few more times and he pushed her one last time. Brian believes Eva tripped over the bar stool and fell to the ground resulting in the large bump on her head. Afterwards, Aaron broke a bar bottle over the bar and cut Brian with it. Brian stated he left afterwards, due to the fact he did not want to deal with anymore drama.

I placed Brian in handcuffs and transported him back to the West Allis Police Department for booking. Once at the station, I turned Brian over to Officer Foy to finish the process.
