## OUTSTANDING BUILDING CODE VIOLATIONS

On September 12, 2012, Building Inspector Rob Woodard sent a notice of building code violations to Ronald Harstvedt, who applied for an occupancy permit at that location for the tavern, Tap 58. The violation was for constructing a room at the rear of the tavern prior to obtaining the required building permit.

As the violation has not been corrected, a summons and complaint was issued to Sportz Medicine, LLC, who owns the property. The court date for this case will be on March 6, 2013.

Therefore, I am respectfully requesting that the Committee take action against Sportz Medicine, LLC and Tap 58 if the building code violations are not corrected in a timely manner.
