It has been decided by the Council that the cost of issuing a West Allis taxicab license is not cost effective.

We (the owners), were never notified of the changes that were to be made to section 9.11. We feel the City of West Allis failed to give due notice to the license holders.

We feel that the service and the livelihood of taxicab owner and drivers far out weigh the administrative cost to the City.

Many of the owners have invested time, money and effort in this business. The owners have put large amounts of money in vehicles, computer and system equipment.

We provide needed transportation for not only locals, but to visitors to the City of West Allis.

Therefore, we highly recommend that you reconsider your position regarding the non-issuance of taxicab licenses.




