The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of November.

Incident reports:

Case #14-9560, 10/26/2014, at 0030 hrs., 8900 W. Greenfield Av. - Larry Michaels Club

On 10/26/2014, at 0030 hrs., a party came in to the station with his wife to report he had been assaulted at 8900 W. Greenfield Av., Larry Michaels Club and Café the night before by a known party. The two got into a physical altercation and the victim sustained multiple injuries, including contusions to his head, face and hands, a broken orbital bone and several lacerations to the inside of his mouth. The incident began inside the tavern and was carried outside. The Offender had been employed at Larry Michael's as a bouncer. The Offender was arrested and charged at the District Attorney's Office for Substantial Battery.

Case #14-9643, 10/26/2014, at 2345 hrs., 7930 W. National Av – Jock Stop

On 10/26/2014, at 2345 hrs., Officers responded to 7930 W. National Av., Jock Stop, for a report of a fight that occurred the night before. One party advised an unknown party assaulted him the previous evening as he was about to close the bar. The offender punched him in the head, scratched his face and threw him onto the stairs of the front of the bar, causing abrasions to his legs and a possible sprained or broken toe. The Offender is not known.

Case #14-9603, 10/28/2014, 0100 hrs., 1753 S 68 St. - Dopps

On 10/28/2014, at 0100 hrs., Officers responded to 1753 S 68 St, Dopps, for a bar fight. Two intoxicated parties began arguing over politics, which led to a physical altercation. The parties

were arrested and issued Municipal Citations for Disorderly Conduct. One party was given an additional citation for theft. The bartender called 911.

Case #14-9761, 11/01/2014, at 0153 hrs., 6827 W National Av. - GR's National Pub

On 11/01/2014, at 0153 hrs., Officers responded to 6827 W. National Av, GR's National Pub for a theft of a purse. The victim hid her purse on a chair and put her jacket over it in an attempt to conceal the purse. Someone found the purse and stole it. Total value of purse and its contents was \$890.00. Video surveillance was obtained, however it was blurry. The suspects were not identified.

Case #14-9784, 11/02/2014, at 0200 hrs., 1753 S 68 St - Dopp's Bar & Grill

On 11/02/2014 at 0200 hrs., Officers were dispatched to the Kwik Pantry at 6716 W. Lincoln Av regarding a party refusing to leave the store. This male was extremely intoxicated. Investigation revealed the party had been drinking at Dopp's Bar & Grill. As he was walking from the tavern, a car full of people stopped and beat him up. During the booking process, his injuries became apparent; his jaw, left ear, and the contusion on his forehead were noticeably swollen. His left eye bruised to the point he could no longer open it and it was purple and black in color. The party was not able to identify the suspects. It was not verified he was in the bar.

Case #14-9936, 11/06/2014, at 1721 hrs., 6426 W. Greenfield Av - Spotlight

On 11/06/2014, at 1721 hrs., Officers responded to the Spotlight for a report of an assault taking place inside the bar. Investigation revealed that an employee had caused an altercation inside the establishment with fellow employees. The employee was arrested and issued a Municipal Citation for Disorderly Conduct.

Case #14-10007, 11/09/2014, at 0034 hrs, 5732 W. Mitchell St. – Tap 58

On 11/09/2014, at 0034 hrs, Officers responded to Tap 58 Bar, 5732 W. Mitchell St for 20 people fighting. Investigation revealed a party was struck by a vehicle traveling at a very low speed. Witness stated a truck pulled up alongside another truck. The first truck then pulled forward striking the victim in the leg, causing him to fall to the ground on his back. The party yelled in pain. After the driver struck the victim, he backed up and then proceeded forwards toward the victim again like he was going to him. The victim rolled out of the way to avoid getting hit. The bartender stated the bar was holding a birthday party for the victim. The bartender was unaware of any altercation or issues outside of the bar, as there were no known problems with the patrons inside. The Offender was not known.

Case #14-10080, 11/11/2014, at 1123 hrs., 6801 W. Beloit Rd – Happy Tap

On 11/11/2014, at 1123 hrs., Officer conducted a Tavern Check at 6801 W. Beloit Rd, Happy Tap and discovered the bartender did not have a current license. A licensed person arrived at the tavern a short time later. The Officer issued the unlicensed bartender a warning citation. She subsequently applied for a license through the city.

Case #14-10351, 11/19/2014, at 2335 hrs., 6007 W. Burnham St, Las Palmas

On 11/19/2014, at 2335 hrs., Officers responded to Las Palmas, 6007 W. Burnham St for a male party banging on the doors and windows. The intoxicated party was arrested for knocking several chairs/tables over inside the tavern and yelling racial slurs at customers. The party was issued a citation for Disorderly Conduct.

Case #14-10440, 11/22/2014, at 2206 hrs., 7100 W. National Av - Braun's Power House

On 11/22/2014, at 2206 hrs., Officers preformed a tavern check on Braun's Power House, 710 W. National Av. The bartender was found to not have a valid bartending license and the owner was not on scene. The owner arrived on scene and both parties were mailed a citation. The bartender has since applied for a license.

Case #14-10444, 11/23/2014, at 0130 hrs, 8442 W. National Av - Heartbreakers

On 11/23/2014, at 0130 hrs, Officers responded to 8442 W. National Av, Heartbreakers for a report of a male threatening to shoot up the business. Investigation revealed a group of 7 males were inside the club causing problems and were told to leave. One party stated, "I'm going to get my gun and shoot this place up." A high risk traffic stop was conducted with the vehicle and all seven males were detained. Inside the vehicle, Officers located a firearm and approximately 455 grams of marijuana. All parties were arrested and cited and charged accordingly.

Case #14-10445, 11/23/2014, at 0212 hrs., 8812 W. Greenfield Av - Stallis Palace

On 11/23/2014 at 0212 hrs., Officers responded to 8812 W. Greenfield Av, Stallis Palace for a report of a bar patron who slashed a tire on an employee vehicle. The male party was intoxicated inside the bar and created a disturbance. Before bar closing the bartender refused to serve any more alcohol to this male. The male slashed the tire of the doorman outside the tavern. The bar staff stopped the one individual and held her. She denied having any involvement, but was later discovered to know who slashed the tire. She was issued a Municipal Citation for Obstructing. The male party was located and he was issued a citation for Criminal Damage to Property.

Case #14-10656, 11/28/2014, at 1723 hrs., 6426 W. Greenfield Av - Spotlight

On 11/28/2014, at 1721 hrs., Officers responded to the Spotlight for a report of a man leaving the business without paying for \$75.00 worth of lap dances. The highly intoxicated party was located and issued a citation.

Case #14-10664, 11/28/2014, at 2100 hrs., 8101 W. Greenfield Av - State Fair Inn

On 11/28/2014, at 2100 hrs., Officers responded to 8101 W. Greenfield Av, State Fair Inn for a male party being treated by West Allis Fire Dept for burns to his feet and legs. Investigation revealed that a male party went inside the men's room stall, passed out while holding a lit cigarette. The cigarette subsequently set fire to his shoes and pants. He woke up with his feet

and legs in flames, called for help, and eventually the fire was put out by another patron with a fire extinguisher. He was transported for burns on his lower extremities. He was cited for Causing a Fire by Tobacco Smoking.

Case #14-10670, 11/29/2014, at 0338 hrs. 1022 S 60 St

On 11/29/2014, at 0338 hrs., an Officer responded to 1022 S. 60 St, 1022 Club, for a complaint that the owner was still serving alcohol. The complainant stated this is a common occurrence. Contact was made with the owner, as well as 3 patrons that were still inside of the bar drinking alcohol. The owner admitted to serving after the bar was closed. Citations were mailed to all offenders.

Case #14-10707, 11/30/2014, at 2114 hrs., 6108 W. Burnham St - Fiddler's Green

On 11/30/2014, at 2114 hrs., Officers responded to 1905 S. 59 St for a report of shots fired. Investigation revealed a party was involved in an altercations with his cousins. One party got into his vehicle and attempted to strike the other party with his vehicle. That party attempted to move out of the way, drew his 9mm hand gun and fired a shot into the hood area of the vehicle. The firing party was taken into custody, without incident. The 19 year old victim stated he and his cousins had been drinking at 6108 W. Burnham St, Fiddler's Green. He stated he told the bartender his true age.
