The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of May.

Incident reports:

Case # 12-004087, 05/19/2012, at approx. 0149 hrs - Flappers Tavern, 7527 W. Becher St.

On 05/19/2012, at approx. 0149 hrs, the bartender from Flappers Tavern, 7527 W. Becher St, called our department to report several individuals fighting inside the bar. Upon officers arrival the fight was broken up. Officers interviewed several witnesses and subsequently arrested two female subjects; one for disorderly conduct and the second for battery.

Case # 12-004113, 05/20/2012, at 0048 hrs, - Randy's Inn, 6922 W. Becher St.

On 05/20/2012, at 0048 hrs, our department received an anonymous complaint of an underage person drinking at Randy's Inn, 6922 W. Becher St. Upon officers arrival they identified a male subject who was 19 years of age. This subject apparently brought his own booze into the bar and was mixing it with soda provided by the bartender. The bartender acknowledged that she was aware this individual was underage and allowed him to stay in the bar. Both the underage person and the bartender were cited.

Case # 12-004259, 05/24/2012, at 0213 hrs - The Draft Tavern, (formerly HEROS), 9105 W. Lincoln Ave.

On 05/24/2012, at 0213 hrs, Officers responded to the Draft Tavern, 9105 W. Lincoln Avenue, for a report of parties arguing outside the bar. Upon Officers arrival they observed 5 parties inside the bar consuming alcohol after closing time. The 5 parties were cited for remaining on licensed premises after closing. The bartender was cited for allowing patrons to remain on a licensed premise after closing.

Case # 12-004384, 05/27/201212, at 2324 hrs - Dog House Tavern, 1641 S. 68th St.

On 05/27/2012, at 2324 hrs, officers responded to the Dog House tavern, 1641 S. 68th St, regarding a trouble call. Upon officers arrival witnesses identified a male subject as the offender who caused damage to a parked vehicle by kicking the passenger door. This party was arrested for Criminal Damage to Property; he was transported to the station, booked for CDTP and released.
