09/08/95. I advised Greene to enter each of the listed businesses and attempt to purchase a six pack of Miller Lite beer.

I instructed Greene when the sales clerk asked her for identification she should advise the clerk she did not have identification and leave the store. I provided Greene with \$20.00 from the WAPD Crime Prevention fund for the attempted purchases.

I confirmed Greene did not have any identification with her when she entered the businesses. I also took a photograph of Greene with a department issued digital camera and secured the photograph onto a WAPD media card to document her appearance on the day of the compliance check. The media card was later secured in an envelope and placed in the Forensics and Technical Bureau.
