The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of September 2017

Incident reports:

Case #17-035596 // 09 September 2017 at 0142hrs. // Uncle Fester's – 5732 W. Mitchell St. NO TAVERN VIOLATION

Caller: Candice Feavel – mother of involved juvenile

Disorderly Conduct & Obstructing: On 09/09/2017 at 0142hrs., officers were dispatched to Uncle Fester's (5732 W. Mitchell St.) regarding a complaint of two (2) juvenile females lying in the street. Officers learned there was an incident involving the owner of Uncle Fester's (Timothy E. Wergin) and two (2) juveniles females. Initially, Wergin was accused of exposing his genitals to the females. Wergin was intoxicated and arrested. There were no charges filed against Wergin by the Milwaukee County District Attorney's Office. Wergin (Disorderly Conduct) and one of the juveniles (Obstructing an Officer) were issued municipal citations.

Case #17-035633 // 09 September 2017 at apprx. 0100hrs. // Boosters – 7731 W. Becher St. NO VIOLATION

Caller: Travis C. Berge – Victim of theft

Theft of wallet: On 09/09/2017, at 1025 hrs., Travis C. Berge, m/w, **Mathematic**, came into the WAPD to report the theft of his wallet that occurred at the bar around 0100 hrs. Berge advised he set the wallet down at the bar and a b/m, late 30's early 40's possibly named "Isaic" stole the wallet and it was captured on video footage. Berge advised he was buying this male drinks and giving him cigarettes all night. Berge advised he was in contact with the owner of the bar who will get video footage to the investigating officer.

<u>Case #17-036690 // 16 September 2017 at 1733hrs. // Sarge's Corner – 1979 S. 54 St.</u> <u>SMOKING BAN VIOLATION</u>

Caller: Officer Ryan Schultz – Conducting tavern check

Smoking Ban Violation: On 09/16/17 at approximately 1733 hours, officers conducted a tavern check at Sarges Corner (17-791). Officers walked in and observed John W. Huebner M/W actively smoking a cigarette in the tavern. There was a large ash tray on the bar. Contact was made with the bartender, Mary A. Bergin F/W. I asked her to step aside and confronted her about the party smoking inside the bar. She stated the owner, Rickey E. Sergeant M/W allows people to smoke in the bar. Mary stated she has brought it up to him before and he insists on letting it happen. Ricky was warned in 2010 about the same issue (10.050443). Based on this being the second documented violation, a citation was issued to Ricky.

Case #17-037807 // 24 Sept. 2017 at 0222hrs. // Braun's Power House – 7100 W. National Ave. // NO VIOLATION

Caller: Joseph S. Braun – Owner

Disorderly Conduct & Resisting Officer: On 09/24/17 at approx. 0222hrs., officers responded to Braun's Power House, 7100 W. National Ave. for a disgruntled ex-employee, identified as Alexander R. Czaplewski M/W **Example**, causing problems at the bar. Alexander was restrained by patrons outside prior to officer arrival. Alexander continued acting belligerent upon officer arrival, and resisted officers while being taken into custody. Alexander was placed under arrest and issued municipal citations for Resisting and Disorderly Conduct. Municipal court date set for 11/13/17 at 0830hrs.

Case #17-038194 // 26 Sept. 2017 at 1944hrs. // Rockstar Saloon – 5826 W. Burnham St. NO VIOLATION

Caller: Peter W. Grubor - Victim

Disorderly Conduct while Armed: On 09/26/17 at approx. 1944 hours, officers responded to Rock Star Saloon located at 5826 W Burnham St for a report of a male party with a knife. Investigation revealed Gregory R Momberg (M/W,) was involved in a verbal argument with Peter W Grubor (M/W,) while inside the tavern. During the argument, Gregory removed a knife from his pocket in an attempt to intimidate Peter. Gregory left the tavern prior to officer arrival and was located nearby. Gregory was placed under arrest for DC / While Armed and transported to WAPD for booking. Gregory was issued a municipal citation with a court date of 10/30/17 at 0830 hours and released.

Tobacco and Alcohol / Tavern Compliance checks:

- No tobacco compliance checks were completed during this reporting period.
- A tavern compliance check was completed 05 September 2017. Ten (10) taverns were randomly selected for the compliance check. All of the taverns requested identification from one of two females who were under 21 years old and declined to sell an alcoholic beverage. - An alcohol compliance check was completed on 23 September 2017. Fourteen (14) businesses were randomly selected for the compliance check. All of the businesses requested identification from the female who was under 21 years old and declined to sell alcohol. A list of the businesses checked is available in case #17-037726.

Violation of Wisconsin Clean Air Act Smoking Ban:

There was one (1) violation of the Clean Air Smoking Ban. Please refer to case #17-036690 above.
