

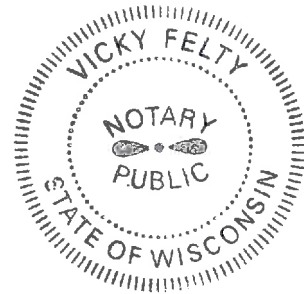

Montana Ave. to W. Dakota St., North/South Alley between S. 90 St. - S. 91 St.; W. Rogers St. to W. Becher St., East/West Alley between S. 94 St. - S. 96 St.; W. Harding Pl. to W. Cleveland Ave., North/South and East/West Alley between S. 77 St. - S. 78 St.; Union Pacific RR to W. Hicks St., North/South Alley between S. 58 St. - S. 59 St.; W. Mitchell St. to W. Burnham St., and North/South Alley between S. 60 St. - S. 61 St.; W. Greenfield Ave. to W. Orchard St. be improved by removal and reconstruction of the concrete alley pavement, storm sewer and storm underdrain. Properties abutting the above alleys for the extents given are proposed as being benefited and are proposed to be assessed.
