The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of November 2008

Police report incidents involving licensed businesses:

Tavern reports:

Case # 08-017553...11/15/08...2333hrs...Marios, 1900 S. 60 St.

Officers responded to Mario's after a call from the owner stating he was having problems with a male party in the bar. The party had left before officers arrived but was pointed out by the complainant as down the street getting into a vehicle. Officers stopped the party and during the course of their investigation found he was carrying a knife and two small baggie's containing marijuana. Party was arrested and given municipal citations for Carrying a Concealed Weapon and Possession of THC.

Case # 08-18079...11/26/08...0201hrs...Smokin Joe's, 6139 W. Beloit Rd.

Officers responded to Smokin Joe's Tavern located at 6139 W. Beloit Rd after a call from a bartender stating there was a fight inside the bar. Officers stopped a large group of parties leaving the tavern and two of them fled on foot and were apprehended a short distance away. They were identified as a 17 and 18 year old female. The girls admitted to being in the tavern. It should be noted the girls paid the \$5.00 cover and had stamps on their hands. Also both females smelled of intoxicants and appeared under the influence.

Inside the tavern the bartender **Joseph A Jeffords, [REDACTED]** (who is also the owner), while being interviewed admitted knowing one of the girls as a regular in the tavern and assumed she had

been carded in the past. The other bartender on duty **John M Sutton**, [REDACTED] also admitted to serving one of the underage parties and knew her by name. Both parties were issued municipal citations for Dispensing Alcohol to Underage Persons.

Case # 08-018132...11/27/08...0128hrs...Spot Lite, 6426 W. Greenfield Ave.

Officers responded to a call at the Spot Lite Tavern located at 6426 W. Greenfield Ave. in regards to problems with a patron. The incident involved a patron who left the bar with his beer to answer a phone call and then wanted to reenter the bar with the beer. He was denied entry and then caused a disturbance. While officers were on scene the patron threatened the bouncer and also threatened to do criminal damage to the bar. He was eventually arrested and at that time also began making racial remarks about one of the officers.

Tobacco and Alcohol Compliance checks;
