

The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of December.

**Incident reports:**

**Case #14-10775, 12/02/2014, 2236 hrs: 8900 W. Greenfield Av – Larry Michael’s Club & Cafe**

On 12/02/2014 at 2236 hrs., Officers responded to Larry Michael’s Club & Café for a report of an intoxicated female fighting inside the tavern. Officers spoke with witnesses who stated a female started yelling at people in the tavern, refused to leave, and attempted to strike another female patron who left and was unidentified. The intoxicated female, and the male she was with, were not located.

**Case #14-10829, 12/03/2014, 2059 hrs: 7534 W Beloit Rd – Sir Gregory’s Pub**

On 12/03/2014, at 2059 hrs., Officers performed a tavern check on Sir Gregory’s Pub. The bartender was found to not have a valid bartending license with the City of West Allis and there was not a licensed bartender on scene. The owner of the bar responded to the establishment a short time later. The bartender and owner were mailed a citation through the mail.

**Call #14-54184, 12/07/2014, 0133 hrs: 7211 W. Greenfield Av – Seven West Bistro**

On 12/07/2014, at 0133 hrs., Officers performed a tavern compliance check at Seven West Bistro. Earlier in the shift, Officers responded to a complaint of a large fight in the 1400 blk of S. 72 St. There was no fight, but Officers observed a very large volume of parked vehicles in the area and the tavern appeared very crowded. At 0146 hrs., Officers entered the tavern and

observed it was very crowded. The owner was cooperative and was advised the Officer believed his establishment to be over capacity. There was also armed security present.

✓ **Case #14-11238 , 12/18/2014, at 0152 hrs: 5732 W. Mitchell St – Tap 58**

On 12/18/2014, at 0152 hrs., Officers responded to Tap 58 for a large fight. On arrival, several parties ran and were apprehended after several foot chases. Five Offenders were arrested for various violations. All parties were released, except one, who had a valid warrant through the Milwaukee County Sheriff's Department. The bartender was spoken to, but provided limited information. She did not call the police, because she decided to close the bar to diffuse the situation by having the male party who was causing problem to leave.

✓ **Call #14-55300, 12/14/2014, 1923 hrs: 5906 W. Burnham St – Drunken Duck**

On 12/14/2014, at 1923 hrs., Officers responded to the Drunken Duck for a party who reported he was assaulted by another party during the Packer game. The Offender came into the bar and pushed the victim, causing him to fall and strike his head, telling him he would beat him up if he saw him on the street. The victim did not want the Offender arrested.

✓ **Case #14-11120, 12/14/2014, 0007 hrs: 6833 W. National Av – Studz Pub**

On 12/14/2014, at 0007 hrs., Officers responded to a Substantial Battery at Studz Pub. Officers made contact with the victim at Aurora West Allis Medical Center. She advised while she was inside Studz Pub, the Offender threw her drink in her face after she was talking to that girl's boyfriend. She then threw her drink in that girl's face. The Offender grabbed a pint glass or beer bottle and hit the victim in the right side of her face, causing lacerations to her scalp, face and left hand. She received six stitches. The Offender was arrested conveyed to the County Justice Facility.

✓ **Case #14-11329, 12/20/2014, 2228 hrs: 6833 W. National Av – Studz Pub**

On 12/20/2014, at 2228 hrs., Officers responded to an assault at Studz Pub. Officers spoke with the bartender, who advised an unknown male party struck him with a closed fist in the back of the head five times before fleeing the scene. The bar owner, Dean Ratas, had booked a Christmas party at the tavern for a company. This unknown male was with the Christmas party. Officers left 6 voicemails and even conducted a tavern check at Studz Pub in attempt to make contact with Ratas, however, Ratas has not been compliant and has not spoken to an Officer in person.

**Case #14-11304, 12/20/2014, 0208 hrs: 8812 W. Greenfield Av - Stallis Palace**

On 12/20/2014, at 0208 hrs., Officers responded to the Stallis Palace for a trouble call. Two females were involved in a verbal argument over a drink one of the females bought for the other female's boyfriend. The argument developed into a wrestling match outside the tavern. The highly intoxicated female, who came up behind the other, grabbed her by the hair and punched

her in the face, was ultimately taken into custody for Battery, issued a municipal citation and released.

✓ **Case #-14-11385, 12/22/2014, 2119 hrs: 9141 W. National Av – Oval Bar**

On 12/22/2014, at 2119 hrs, Officers responded to the Oval Bar for a report of a male lying down in the roadway bleeding. Investigation revealed the party had been drinking at the Oval Bar since 1500 hrs and was intoxicated. When he left the bar, he fell in the road, causing a cut above his right eye and a bloody nose. He was transported to the Aurora West Allis Medical Center for medical treatment.

✓ **Case #14-11356, 12/22/2014, 0100 hrs: 7211 W. Greenfield Av – Seven West Bistro**

On 12/22/2014, at 0100 hrs., Officers responded to a trouble call at Seven West Bistro for several parties fighting in the street. An intoxicated and uncooperative party was taken into custody for Disorderly Conduct. He was cited and released.

✓ **Case #14-11456, 12/25/2014, 0111 hrs: 8900 W. Greenfield Av – Larry Michael's Club & Café. Also, 8812 W. Greenfield Av - Stallis Palace**

On 12/25/2014 at 0111 hrs., Officers responded to Larry Michael's Club & Café and Stallis Palace for a report of an incident with a firearm. Investigation revealed an incident occurred between two parties at Larry Michael's. One of the parties ended up with possession of a firearm that the other party had originally brought into the bar. He then took the firearm and went to Stallis Palace where he continued to consume alcohol. Officers eventually took both parties into custody, and booked each for CCW, armed while intoxicated and carrying a handgun – alcohol sold/consumed. One of the parties also had a warrant through the Department of Corrections.

✓ **Case #-14-11527, 12/27/2014, 2058 hrs: 1753 S 68 St – Dopp's**

On 12/27/2014, at 2058 hrs., Officers responded to Dopp's for a trouble call. Upon entering the establishment the Offender was yelling at the other patrons and threw a barstool. He was immediately detained. Investigation revealed he was highly intoxicated upon entering the bar, and began causing problems when he did not approve of how his drink was served. He threw two beer bottles at the bartender and knocked over several bar stools, while the bartender called the police. The Offender was arrested for Disorderly Conduct, cited and released.

✓ **Case #-14-11609, 12/30/2014, 2205 hrs: 9141 W. National Av – Oval Bar**

On 12/30/2014, at 2205 hrs, Officers responded to the Oval Bar for a report of a male that broke a glass and was threatening patrons. Officers arrived and were unable to locate the male. The bartender did not know the male, however, she stated she stopped serving him because he was highly intoxicated. He became extremely upset and began to yell that he has killed people and he was going to kill everyone there.

**Tobacco and Alcohol Compliance checks:**

- Case #14-11186. On 12/16/2014, an alcohol compliance check at 12 randomly selected West Allis businesses that have a license to sell alcohol was conducted. The check was completed through the use of a 19-year-old female who attempted to purchase a six-pack of Miller Lite beer. All of the 12 businesses requested identification from the 19-year-old female and did not complete the sale.
- Case #14-11228: On 12/17/2014, a tobacco compliance check at 14 randomly selected West Allis businesses that have a license to sell tobacco was conducted. The check was completed through the use of a 16-year-old male who attempted to purchase a pack of Newport cigarettes. All of the 14 businesses requested identification from the 16 year old and did not complete the sale.

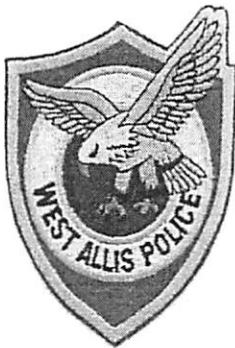

There will be no further follow up at this time.

**NARRATIVE****INITIAL RESPONSE**

On Tuesday, 12/02/14 at 2236hrs I, Officer Kleinfeldt, with Officer Kwasinski in the same squad (squad 15) responded to a trouble call at Larry Michaels Tavern, 8900 W Greenfield Ave. Bartender Alma A Frye (F/W 02/20/71) reported an intoxicated female was fighting another patron in the tavern and had left westbound on W Greenfield Ave. I drove to the location east on W Greenfield Ave and did not observe any females in the area.

**CONTACT WITH ALMA A FRYE (F/W 02/20/71)**

Alma A Frye (F/W 02/20/71) was the bartender on duty. Frye stated a female described as having blonde hair and wearing a brown sweater was with her boyfriend in the tavern and was intoxicated. Frye said the female began arguing with everyone in the bar and started yelling. Frye asked the female to leave and she refused. Frye said these females yelled, "You're all finished!" and that they were all doomed, and claimed she was a cop. Frye said while telling the female to get out of the tavern, the female attempted to reach at her from over the bar but could not reach her. Frye explained another female who was not identified tried getting this intoxicated female to leave and these two females ended up struggling with each other. Frye stated she observed the intoxicated female try to hit this female and was not sure if she connected, and this was when Frye called the

police. Frye said the other female that the intoxicated one was trying to hit also left the tavern before police arrived.

**CONTACT WITH ANTHONY J KIM (M/W 02/19/78)**

Anthony J Kim (M/W 02/19/78) was a patron at the tavern and gave the same account of events as Frye. Kim added he separated the intoxicated female from the other female patron when the intoxicated female started fighting. Kim believed the intoxicated female and her boyfriend left westbound on W Greenfield Ave.

**PROPERTY - PRESCRIPTION BOTTLE**

Frye handed me a prescription bottle that was found on the floor of the tavern. It was in the name of Jodi Tegeler of Tennessee for a Zoloft prescription, and there was one half of a Zoloft pill left in the bottle. I later entered this into property under property number 14-008722-1.

**ATTEMPTED SUSPECT IDENTIFICATION**

Officers were unable to locate the intoxicated female. I later checked local records and CCAP and did not find any record of Jodi Tegeler. I checked this name in KGIS and found Jodi L Tegeler (F/W 05/30/72) of Greendale was arrested by Franklin PD in 2009. Tegeler comes back on file through Wisconsin and I could not find any information about her living in Tennessee as the prescription bottle states. I also do not know if Tegeler was the subject of Frye's complaint or if Tegeler was the other female that was struck by the intoxicated female.

**CASE DISPOSITION**

Officers were not able to locate the suspect or identify her as the subject of the complaint, there will be no further follow up with this matter.

complex, I observed the male running S/B along the east side of the building. As I chased the male S/B in the gangway, we both had to run around several grills and jump over multiple pieces of plywood that were dividing peoples rear properties.

The male party then reached W. Mitchell St. where he continued S/B into the alley 1700 block 58/59. I caught up to the male party as he entered the alley and immediately tackled him to the ground. Once on the ground, I had the male party pinned to the ground by his upper shoulder area and legs with my knees. As I ordered the male party to put his hands behind his back, a citizen ran up and assisted me with taking him into custody. The male party was then turned over to Officer Mathy who escorted him back to Tap 58 while I walked with the citizen, Haytham A. Asad M/W 07/02/87 back across the street to 5812 W. Mitchell St.

ARREST OF JESSE NMI FERNANDEZ

Haytham who lives at 5812 W. Mitchell St. #1 heard the commotion and advised he ran outside to assist Officers. After taking the male party into custody, Haytham requested that I walk with him to the north side of the building to make sure his boat was not damaged. As we neared the N/W corner of the building where my squad car was still located, a male party appeared in the darkness and was walking on the north side of the building from the east to the west. I immediately identified myself to the male party who was breathing heavily and missing a boot. The male party identified himself with a Florida Photo DL as Jesse NMI Fernandez M/H 10/09/90. Jesse stated he was at Tap 58 and got scared after the incident outside and decided to run off. Jesse stated he does not live at 5812 W. Mitchell St. and does not have any business being on the property. Jesse was subsequently detained in handcuffs, secured in my squad car and transported back to Tap 58.

CONTACT WITH TODD A. BAKER

On arrival at Tap 58, I turned Jesse over to Officer Fletcher while I spoke with the male party that I initially took into custody. Upon opening the rear squad door, the male party immediately began screaming, yelling and swearing at me. I therefore attempted to calm the male party down by asking him for his information however I only received his name, Todd A. Baker. I then asked Todd what his date of birth is and he stated, "Fuck You." Based on Todd's lack of cooperation and agitated state I secured the door to allow him to cool down. During my contact with Todd I detected a strong odor of intoxicants emitting from his breath, his eyes were red and glassy and his speech was slurred.

After securing the door, I walked back to the area where I located Jesse and attempted to find his missing boot. While doing so I began hearing a loud banging noise coming from the Tap 58 area and was requested to return by Sgt. Corwin as Todd was kicking the squad car door. I then ran back to the Tap 58 area and assisted Sgt. Corwin with removing Todd from the rear of the squad car. While doing so I looked inside the rear passenger compartment and noticed on the floor

behind the drivers seat was a large pool of vomit. Todd was removed from the squad car and stabilized on the grass in a prone position. While on the ground, Todd was thrashing his body around, tensing his arms and screaming, yelling and swearing at Officers. Todd was additionally yelling that he was a "Latin King" gang member, that he spent time in prison already and threatened to harm Officers and their families.

Eventually the WAPD patrol wagon arrived on scene and Todd was escorted to the rear of it. Once seated in the rear of the patrol wagon, Todd refused to allow Officers to close the door as he continually kicked the door while yelling and threatening Officers. As a result I assisted Sgt. Corwin with physically moving Todd away from the door as he would not do so when asked. While moving Todd, Sgt. Corwin yelled that he might be possibly trying to bite him and as a result I delivered one focused strike to his abdomen area. I also delivered two to three knee strikes to Todd's abdomen area while physically struggling to move him farther away from the door. During the struggle in the patrol wagon, Todd was told numerous times to stop resisting. Officers were finally able to secure the van door and upon doing so Todd moved back closer to the door and continued kicking it.

PHOENIX LOCALS

In searching Phoenix locals I found Todd A. Baker M/W with a date of birth of 03/14/83.

POSITIVE IDENTIFICATION

On arrival at the WAPD, I requested Officers to attempt to FAST ID Todd as I had not positively identified him. Todd however refused to be identified as he refused to un-ball his fists and refused to cooperate with instructions. While attempting to explain to Todd why he needed to be positively identified, he confirmed his name was Todd A. Baker and his date of birth is 03/14/83. Todd refused to provide any other requested information.

Todd was then physically escorted to Cell #4 and once inside Todd again resisted Officers. See Sgt. Corwin's supplement report.

With Todd secured in the cell, I ran his information through NCIC which showed he was on probation and had a warrant. I additionally queried his DOT and DOC photos which were clearly not the person I had in custody. I confronted Todd with this information and he again provided me with the same information.

Todd was eventually removed again from the Cell #4 where he finally cooperated with the FAST ID after numerous explanations as to why he was in custody and why Officers needed to positively identify him. The bartender instructed everyone to leave the bar since they were arguing and all parties involved exited the establishment. Once outside, Gonzalez observed Baker and Calhoun have a physical altercation, but she was unsure who threw the first punch. Gonzalez attempted to break up the fight but was unsuccessful.

At this point, Alicea told Gonzalez to get into his car so they could go home. As they were about to enter the vehicle, the police arrived, and all parties involved in the altercation ran, including Alicea. Gonzalez was unsure why Alicea ran, but she repeatedly stated he was "stupid" and doesn't make good decisions.

**TRANSPORT/BOOKING OF MONTREL L. CALHOUN**

I transported Calhoun back to the department for booking. Once at the station, I booked Calhoun for disorderly conduct. During the booking process, Calhoun stated he did not know Baker and he was not involved in the fight. Calhoun attempted to break up the fight and then stopped because he decided it was not worth the trouble.

Calhoun has resided in Houston Texas for the past 5 years and drives trucks for a living. Calhoun was originally in Wisconsin and had returned this week to visit his family. I issued Calhoun citation M140058981 for disorderly conduct. Calhoun was advised of the court date and signed the pr bond.

**STATEMENT OF MONTREL L. CALHOUN**

I placed Calhoun into Interview room C of the Detective bureau. I advised Calhoun of his Miranda rights and he agreed to make a statement without the presence of an attorney. I recorded the interview onto a memory card and turned it over to FTSB. The following is a summary of the statement Calhoun provided me:

Calhoun stated he met his brother and cousin at Tap 58 this evening. Calhoun consumed a Budweiser and a sprite and played darts. Calhoun observed 2 white males arguing with each other and then they exited the bar. Calhoun attempted to break up the fight until he realized it wasn't worth it and he walked away. As Calhoun was at his vehicle, he observed officers arrive on scene and an officer told him to stay where he was. Calhoun then waited by his vehicle.

Calhoun could not identify the 2 white males that were fighting. Calhoun stated he was not in a gang and he has lived in Texas for the past 5 years. I then ended the interview.

Calhoun was released a short time later.

Sergeant Corwin reports...

INITIAL OBSERVATIONS

On 12/18/14 at approximately 0152hrs, officers were dispatched to Tap 58 Tavern, 5732 W. Mitchell St, for a report of six to seven people fighting in the street. I arrived on scene within about one minute of being dispatched. I was the first officer to arrive. I was in a marked City of West Allis Patrol SUV, in full police uniform.

As I was pulling up in front of the tavern I observed approximately five males standing in the middle of the roadway near S. 58 St / W. Mitchell St. Immediately upon seeing my squad, several of these males took off running. I observed two males, (later identified as Jesse "nmi" Fernandez, M/H, 10/09/90 and Daniel L. Baker, M/W, 01/29/81), run north on S. 58 St for a short distance and then run west through the residential yards. I quickly lost sight of these two males.

I also observed another male, (later identified as Wilfredo W. Alicea, M/H, 10/06/92), run north on S. 58 St.

Two additional males from the group stayed on S. 58 St just north of W. Mitchell St and did not run, (later identified as Montrell L. Calhoun, M/B, 09/05/75 and Martago A. Hicks, M/B, 10/05/75).

I radioed to dispatch that several people had observed my squad and were running away from me.

FOOT PURSUIT - APPREHENSION OF WILFREDO W. ALICEA

I pulled my squad north onto S. 58 St, quickly parked, exited and began running after Wilfredo Alicea. Alicea ran north a short distance on S. 58 St and then cut west behind Tap 58. I started running after him while yelling several times, "Stop Police!" Alicea did not stop, continued running west and then cut to his right and ran south along the east side of the tavern. I stopped following him and ran south along the west side of Tap 58 with intentions of cutting him off in front of the tavern. As I ran towards the front of the tavern, I yelled at both Calhoun and Hicks to stay where they were and to not leave the scene. I then ran to the front of the tavern.

When I got to the front of Tap 58, I observed Alicea attempting to enter the driver's seat of a newer model Silver Chevrolet Camaro (WI #282WCH), that was

parked directly in front of the tavern near the entrance. I yelled at Alicea to stop, ran up to him, escorted him away from the driver's seat and walked him to the rear of the vehicle. I then handcuffed him without incident. A female was standing on the opposite side of the vehicle yelling at me that Alicea was her son. This female was later identified as Tammy Lee Gonzalez, F/H, 03/23/73. Gonzalez did not cause any problems, remained on scene and later provided a statement to Officer Carlson.

While I was handcuffing Alicea, I looked to the west and observed Baker and Fernandez peek out from an apartment building about 1/2 block away on the north side of W. Mitchell St. Baker then walked out into the middle of W. Mitchell St, but quickly turned around and began running north in the alley along the west side of the apartment building. Baker ran because he observed Officer Gold turn east onto W. Mitchell St from S. 60 St in his marked squad. Officer Gold appeared to have observed Baker and he immediately drove his squad to where Baker had run. At the same time, I radioed my observations to Officer Gold. Officer Gold then became involved in a foot chase with Baker.

While Officer Gold was chasing Baker on foot, I observed Fernandez again peek out from the west side of the same apartment building, (north side - 5800 block of W. Mitchell St). After Officer Gold concluded his foot chase and had Baker in custody, I radioed to him my observations of Fernandez. Officer Gold checked that area and found Fernandez hiding behind the same apartment building. Fernandez was taken into custody.

Calhoun and Hicks stayed on scene as instructed. Officers Meyer and Agor made contact with them.

Refer to additional officers supplement reports for further details.

**VEHICLE SEARCH - WILFREDO ALICEA**

After I handcuffed Alicea, I asked him if he had any weapons on his person or in his vehicle. Alicea told me that he had a "knife" inside his vehicle and that he had the knife for protection.

In plain view, (driver's door was already opened by Alicea upon contact), I observed a "butterfly knife" with a darker colored handle in the cup holder between the two front seats. The knife was approximately 6" inches long.

I asked Alicea if the vehicle, Silver Chevrolet Camaro, was his and he said, "yes." Alicea gave me consent to search his vehicle. I then seized the butterfly knife as evidence and later turned it over to Officer Mathy, who in turn gave it to Officer Otto to be placed on property. Nothing else of evidentiary value was found in the vehicle.

DISORDERLY / RESISTIVE CONDUCT - DANIEL BAKER

Baker was handcuffed and secured in a squad on scene while officers continued to investigate the incident. After a short time, I heard a loud banging type noise coming from the squad where Baker was secured. It appeared that Baker was repeatedly and very aggressively kicking the inside of the squad. I went over to the squad and asked Baker to stop. Baker was yelling and continued with his violent behavior and therefore was escorted out of the squad and placed in a prone position on the ground. Baker was resisting as he tensed his body, was screaming and spraying saliva. Baker was repeatedly yelling that he was a "Latin King" gang member and made threats to harm officers and their families. Baker appeared highly intoxicated. He had a strong odor of intoxicants on his breath, slurred speech and red and glassy eyes.

Due to Baker's violent and resistive behavior a transport van was requested to respond to our location.

After the van arrived on scene, officers attempted to secure Baker inside. Baker continued to yell and threaten officers and repeatedly kicked the rear door of the police van preventing officers from closing it. Myself and other officers entered the van and had to physically move Baker away from the door. Baker continued to yell and spray saliva. At one point Baker's mouth was directly next to my right arm and it appeared that he might try to bite me. I repeatedly yelled at Baker to not bite me, to not spit at me and to stop resisting. After a brief struggle, officers were able to secure Baker in the van far enough away from the door. After closing the police van door, Baker began to repeatedly kick the inside of the van.

Once in the cell block, Baker was escorted to cell #4. Baker continued to struggle and resist officers, as he tensed his arms, tried to pull his arms underneath him and tried to stand up. The entire time he was yelling threats at officers, yelling that he was a Latin King gang member, and challenging officers to fight. Officers were attempting to control Baker, however he continued to struggle. Several officers that were attempting to hold down his upper body on the cell bed began yelling, "Tase him!" It appeared that they were losing control of his upper body and that Baker might assault them if he broke free. Based on Baker's violent, aggressive and resistive behavior, I withdrew my electronic control device, (commonly referred to as a Taser), took off the cartridge and placed the Taser against the back of his left calf on his lower leg. I then applied a 1 to 2 second contact stun while yelling at him to "Stop Resisting!" Baker continued to resist, so I applied as second contact stun to the same location for about 1 to 2 seconds, again yelling at him to "Stop Resisting!". Officers were then able to gain control of Baker.

Officer Agor reports...

**INITIAL CALL**

On 12-18-14 at 0152 hours, officers responded to Tap 58, located at 5732 W. Mitchell St., for multiple parties fighting outside of the bar. En route to the bar, I heard Sergeant Clint Corwin inform dispatch that several parties were running from the scene. Upon arrival, Sgt. Corwin directed me to two subjects, later identified as Martago A. Hicks (M/B 10-05-75) and his step-brother, identified as Montrel L. Calhoun (M/B 09-05-75), that appeared to be leaving the scene. As I made contact with Martago, Officer Lance Meyer made contact with Montrel.

**ON SCENE STATEMENT OF MARTAGO A. HICKS (OFFENDER)**

Martago initially reported that he was leaving the bar when he was ordered by Sgt. Corwin to stop. When I asked Martago if he was involved in or observed a fight that occurred outside of the bar, Martago stated he was not involved in a fight, nor did he observe a fight occur inside or outside of the bar.

Martago recanted his initial statement and admitted to being involved in trying to separate an altercation between Montrel and two other unknown males. Martago identified Montrel as a member of the Gangster Disciples and stated the two other subject involved in the physical altercation were known Latin Kings. As I spoke with Martago, I noticed Martago had a small abrasion with fresh blood on the middle knuckle of his left hand. I asked him how he received the abrasion. Martago said he received it while trying to break up the fight.

I place Martago in handcuffs and detained him in the back of my squad for further investigation.

After I placed Martago in the back of my squad, I responded to the residence of the caller, identified as Michael S. Kucan (M/W 10-14-85), who resided at 1702 S. 58<sup>th</sup> St. It should be noted Michael's residence is located directly across the street from Tap 58, on the southwest corner of S. 58th St./ W. Mitchell St. As I made my way to Michael's house, I was informed by Officer Lete Carlson that a witness, identified as Tammy Lee Gonzalez (F/W 03-27-73), identified Martago as being involved in a fight between multiple parties.

Michael reported he came home from work and took a shower, at the time he came home, he did not notice anything out of the ordinary at Tap 58. While he was finishing up with his shower, he heard multiple persons yelling. Michael looked out of his window and observed up to 10 people fighting between Tap 58 and the fence located just east of the bar. Michael then stated the fight spilled over into the street in the 5700 block of W. Mitchell St., just north of his residence. Michael said all of the parties were throwing punches at each other when they were located by the fence, but that only one white male and one black male appeared to continue to throw punches while the crowd moved into the street. Michael was unsure if the rest of the crowd was still cheering the two on, or they were trying to break the two up. Soon after, Michael contacted the police.

#### ARREST OF MARTAGO A. HICKS (OFFENDER)

Based on Michael and Tammy's statements about Martago's involvement in the large disturbance, I placed Martago under arrest for Disorderly Conduct.

interview was recorded on an Olympus DS-220 Digital Voice Recorder #P14, using audio media card #P14-1. The following is Hicks' statement in paraphrase form:

Martago reported before he went to Tap 58 with his step-brother, Montrel, he drank some alcoholic beverages at home. Martago reported he never saw Montrel swing a punch at anyone, which was contrary to his initial on scene statement. Martago also initially stated that he did not observe how the fight started because he was coming out of the bathroom, but that he recalled multiple people fighting in the area between Tap 58 and the fence just east of the bar. Martago admitted he had a lot of alcohol to drink at the bar.

I ended the interview at approximately 0508 hours.

The media card was placed in a Digital Media Card Envelope, and the envelope was secured in the Digital Media Card Slot in the Forensics and Technical Services Bureau as evidence.

Martago was booked and fingerprinted under booking #14-005901. After I issued Martago municipal citation #M140059012, for Disorderly Conduct, he was released. Martago was given a municipal court date of 01-19-15 at 0830 hours.

Officer Foy reports...

**RESISTING AN OFFICER**

On 12/18/14 at approximately 0300hrs I assisted officers with an uncooperative subject in the booking room. Officers attempted to complete a Fast ID task with Daniel L Baker, who was extremely uncooperative. I held Baker's right arm to attempt to complete a task by placing Baker's left and right index finger print on a machine. While I was holding onto Baker's right arm, I detected a strong amount of resistive tension. I placed my right hand on Baker's right hand and my left on his elbow in order to attempt to control him. Several additional officers were present to hold onto other limbs for the task.

Baker's refused to cooperate with the task. Baker's refused to remove his finger from a fist, making the task unable to be completed. This continued for several minutes before it was determined that officers were not making progress with Baker's and he was to be transported back to his cell after a search was completed.

While walked to the cell, Baker began to swing his arms wildly. I lost control of Baker's right arm as he pulled away. Due to this, Baker was stabilized against the wall in order to regain control of his right arm. Baker was eventually escorted to the cell where he refused to go onto the ground. Baker continued to thrash his body around in an attempt to gain control. Baker turned onto one side and shouted "it takes five of you fuckers to control me!?"

Baker continued to attempt to thrash his body around as I yelled to him to "stop resisting" multiple times. Based upon his continued efforts to resist officers' attempt to complete a thorough search of his person, I removed taser from the holster, removed the taser cartridge and placed the taser on Baker's upper back. I held the taser in place and yelled "taser taser" and pulled released the trigger. The taser continued through a five second cycle before turning off. Baker's resistive efforts briefly stopped as officers were able to gain more control on him.

Eventually, a thorough search was completed and Baker was advised to stay in position and maintain that position until officers left the room. Baker stood up and began to kid the door and scream. Baker uncooperative and explosive behavior continued until he was released to MCSO.

Officer Fletcher reports...

INITIAL RESPONSE

On 12/18/14 at approx. 0152hrs., officers responded to Tap 58, 5732 W. Mitchell St. for a report of a large fight. Officers arrived on scene and apprehended several parties who fled on foot. Upon arrival, I spoke with Jesse NMI Fernandez M/H 10/09/90, who was in custody in the back of Officer Gold's squad.

CONTACT WITH JESSE NMI FERNANDEZ

Fernandez advised he was at Tap 58 since approx. 0100hrs. earlier in the evening, and that he came there with his mother and her boyfriend. Fernandez stated he did not know any other parties at the tavern, and that his mother and her boyfriend left the tavern at approx. 0130hrs. Shortly before officers arrived on scene, Fernandez walked outside to smoke a cigarette when he heard a verbal argument taking place between several unknown male parties on the sidewalk. Fernandez advised he "didn't want to get involved" with the argument, so he began walking away from the tavern. Fernandez did not remember where he was walking, stating multiple times that he was not familiar with the area because he just recently moved to Milwaukee from Florida.

Fernandez advised he was walking around for approx. five minutes when he encountered Officer Gold in an unknown alley. Fernandez advised he did not know why Officers were in the area, or why he was taken into custody. I explained to Fernandez that he was in custody due to the fact that officers had information that he may have been involved in the fight outside of the tavern.

During my contact with Fernandez, I detected a strong odor of alcohol coming from his person. I also observed that Fernandez was sweating, missing one Black Nike boot, and had several small lacerations to his knuckles that were bleeding. I asked Fernandez why he was missing a boot, and he advised that it "fell off" while he was walking through the alley. I additionally asked Fernandez why his knuckles were bleeding, and he was unable to provide a valid explanation for his injuries. Fernandez advised he did not require medical attention for these injuries.

As I continued to question Fernandez regarding his involvement in the altercation, he repeatedly denied any involvement and stated he did not know any of the parties involved. Fernandez also denied ever running from

officers, and stated he was "just walking in the area" to get away from the bar when Officer Gold stopped him.

I subsequently transported Fernandez back to the station for booking. Fernandez was booked under booking #14-005896, and issued a municipal citation for Disorderly Conduct. Fernandez was given a municipal court date of 01/19/15 at 0830hrs.

It should be noted that during the booking process, Fernandez shouted numerous times to Daniel L. Baker 12/29/81, who was being held in a booking room cell. Fernandez shouted at Baker to "hang in there" and referred to him by his nickname, "Deebo." Fernandez also later admitted to me that both he and Baker are "Latin Kings."

INTERVIEW

On 12/18/14 at approx. 0325hrs., while in interview room B of the West Allis Police Department, I read Fernandez his Miranda warnings off Departmental Directive 42.016. Fernandez declined to speak with me regarding this incident.

**INITIAL CALL**

Officer Mathy reports...

On 12/18/14 at approximately 0152hrs, I responded to Tap 58 bar, 5732 W. Mitchell St. for a fight in the roadway. Prior to my arrival, Sgt. Corwin radioed that several parties fled on foot and that Officer Gold was in foot pursuit with another person involved.

**INITIAL CONTACT- DANIEL L. BAKER (OFFENDER)**

Upon arrival I observed Officer Gold in contact with the offender, later identified as Daniel L. Baker M/W 01/29/81, who was previously running from Officer Gold. Officer Gold requested that I escort Baker to a squad and secure him. I escorted Baker to my squad, who appeared intoxicated as his speech was slurred, he had red and glassy eyes and he had a strong odor of intoxicants emitting from his breath. I escorted Baker to my squad which was parked on W. Mitchell St. directly in front of Tap 58. Baker began to scream that he was not being chased by a Police Officer and began to curse loudly. Sgt. Corwin requested I make contact with the bartender of Tap 58 and I did so after securing Baker in the squad.

**STATEMENT- SARA E. STOUT (WITNESS)**

I made contact with the bartender of Tap 58, Sara E. Stout F/W 09/23/79, who stated she was the only bartender working during closing hours. I asked Stout to explain what occurred prior to Police arrival. Sara stated there was approximately 10-15 people inside the bar just prior to the incident. Stout said a slender black male, between 25-30 years old and wearing a green and gold Green Bay Packers sweatshirt, began to yell toward a group of people that he was a "regular" at the bar and that he did not know who the other people were. Stout said she did not know why the male was upset, however, she decided to tell the entire bar that they were closing, in an effort to diffuse the situation. Stout said the male, as well as the majority of patrons did leave the bar.

Shortly after the patrons left, a few, whom she could not identify, returned to the bar and informed her that the male had left the area. Stout said the remaining patrons gathered their coats and left the bar. Stout said she then locked the bar and began to check the bathrooms and basement to ensure that nobody was still inside. Shortly after checking the aforementioned areas, Stout said she heard people yelling. Stout said she observed a group of

approximately 6 people yelling at each other in the roadway, located at the intersection of W. Mitchell St./ S. 58 St. Stout said she did not observe specifically what occurred because her view was obstructed by the southwest entrance door. Stout said she specifically observed a male in a gray hooded sweatshirt yelling at the group that gathered in the intersection. Stout said she observed a squad arrive with its overhead lights illuminated and knew she did not have to call the Police.

I asked Stout if the behavior of the black male, whom she mentioned previously, prompted her to call the Police. Stout said she did not call the Police because it was close to the time for her to close the bar. Stout said she decided to close the bar for the night and said she would have called the Police if the male refused to leave. Stout did not have any other pertinent information related to the incident.

**RESISTING/ BOOKING OF DANIEL L. BAKER (OFFENDER)**

After I spoke with Stout, Sgt. Corwin informed me that Baker was kicking the side of my squad door and was escorted out. Additionally, Baker vomited inside the back of the squad. As I approached I observed Baker screaming and cursing at Officers. Baker made reference to being in a gang and stated "you guys ain't shit." Due to Baker's behavior the patrol transport van was requested to convey Baker back to the WAPD for booking. Once the van arrived on scene, I escorted Baker to the van with the assistance of other Officers. Once I secured Baker in the van and fastened his seat belt, Officers attempted to close the metal view-port door. Baker began to violently kick the door as we attempted to close it. Baker continued to do this and was ordered several times to stop kicking. Baker did not comply and I entered the van to move Baker to a different location in the van, away from the view-port door. As Officer Gold, Sgt. Corwin and I moved Baker to a different seat location, I felt strong resistive tension in Bakers right arm. Sgt. Corwin then announced that Baker was attempting to bite him. I then administered a mandibular angle pressure point on the right side of Baker's head and ordered him to "stop resisting."

Baker was eventually secured with a seat belt and the van door was closed without further incident. During the my contact with Baker, he was extremely un-cooperative. Several Officer's were needed to monitor and secure baker in the patrol van. Baker continued to curse at Officers throughout my contact with him.

Once inside the WAPD booking room, I assisted Officers escort Baker to the fast ID fingerprint scan, as Baker did not have an ID. Petty was in pain and the bleeding was significant. While speaking to Petty medical staff at the hospital gave shots to Petty at the three locations of the cuts to numb all the areas for stitches. Photos were taken of the above injuries by Officer Stuetngen and are described in his supplemental report.

CONTACT WITH VICTIM AT AURORA WEST ALLIS MEMORIAL HOSPITAL (AWAHM) - JAMIE L. PETTY (F/W, 2-27-82)

Jamie L. Petty stated this evening she was out drinking as a final celebration before she began a long and arduous chemotherapy treatment. Petty first started the evening at the June Bug's Bar located at 6231 W Mitchell St., then went with some friends to the Studz Pub, 6833 W National Ave at approximately 10:10 pm on 12-13-14.

Upon making contact with Petty I immediately observed she had the odor of intoxicants on her breath, her eyes were both red and glassy and her speech was both slow and slurred. Petty stated to me that she was drinking from approximately 6 pm on 12-13-14 till the time she became injured (around midnight) and that she felt she was intoxicated.

I asked Petty what led up to her receiving the cuts to her face and she relayed to me the following events:

Petty said while at Studz Pub she there was a male she made contact with, who she described as a white male, approximately 6'0 ft tall, with a long beard (possibly dirty blond), who as standing mid-bar between the north and south of the bar. Petty said she exchanged words with the male, never learned his name and spoke to him outside smoking twice during the time at Studz Pub. Petty said the bartender said they knew the names and identity of this male and the female he was with from prior contacts with them.

Petty said just before the incident, which caused the injuries she was standing at the bar, mid bar between the north and south, when the male clinked glasses with her, making "cheers." Petty said immediately after this "cheers" a female, white, wearing glasses, approx. 5'03-5'05 with dirty blonde hair, approx. 160-190 lbs, threw the contents of her drink at Petty, saying something about Petty staying away from her man. Petty in response threw the contents of her drink back at the female. Then the female took a pint glass or bottle and struck Petty in the face with such force that the glass broke and caused cuts to her face, head and left hand. Petty said it was hard for her to recall the exact description of the female because the first and last time she saw the female was during this brief incident.

Petty said after the bottle struck her she remembers being taken to the rear of the bar where people at the bar began to render aid to her. Petty then came to the hospital with her two friends (see Officer Binter's supplemental report

Petty said her contact with the male this evening was not anything that would warrant such a response from his girlfriend, who Petty assumed struck with the glass in her face.

While at the AWAMH I relayed to the officers investigating at Studz Pub the description of the male and female as given to me and documented in this report as well as making them aware the bartender allegedly knew the identity of the offender. Officers at the Studz Pub advised the description matched that of witnesses they spoke to and that they were working with the bartender to get the identity of the alleged offender.

LACK OF CONSENT

Jamie L. Petty stated she did not consent to anyone at anytime to strike her in the face with glass, breaking it on her face and causing lacerations / cuts to her head, face and left hand, which later resulted in stitches.

While at the hospital (AWAMH) speaking to Jamie L. Petty, her friend, Tiffany L. Kirkpatrick, advised two of their acquaintances were at the June Bug's and stated that they witnessed the event while previously at Studz Pub.

Myself and Officer Binter then made contact with three individuals at the bar, June Bug's, 6231 W Mitchell St. I spoke to Christopher J. Gaar, Jr. and Christopher J. Gaar, Sr., who said while at the Studz Pub sometime between 10 pm and 12 am on 12-13-14 they heard a loud noise and then saw that there was broken glass and female injured. In addition, I observed the front seat passenger, later determined to be Steffen, to be a white female, approximately 40 years of age. These parties matched the description of both Steffen and Piontek, and I subsequently pulled out from my parked location and traveled toward the vehicle.

The vehicle continued westbound on W. Madison St., and turned northbound in the alley between S. 113 St. and S. 112 St. from W. Madison St. Piontek then performed a backing maneuver, and parked the Suburban in the alley behind 1236 S. 113 St. I radioed the vehicle registration information and advised I believed I located the subjects involved in the altercation at Studz Pub. WAPD Dispatch informed me the vehicle listed the registered owner as Piontek, who at this point stepped out of the vehicle with Steffen. I requested to speak with Steffen, while Officer Stuetzgen spoke with Piontek.

beverages, while Petty was "getting too close" to Piontek. Steffen stated at one point she got up to use the restroom at Studz Pub, and upon returning, she observed Petty touching Piontek as the two parties "cheersed" with their beers.

Steffen approached Petty, and told her something to the effect of, "stay away and mind your own business." Petty stood up and both parties argued face to face for a brief moment. Steffen advised someone, unknown who specifically, attempted to get between the two of them, and Petty reached toward her face. Steffen explained she was in fear for her safety and in self-defense, swung her right hand, which was holding a beer bottle, striking Petty in the face. I asked Steffen if Petty appeared to have sustained any injury as a result from being struck in the face with the beer bottle, which she stated she observed Petty had a laceration that was bleeding in the area around her forehead.

Steffen advised she and Piontek then left Studz Pub, in an attempt to avoid any repercussions as a result from the altercation. The two parties went to Dopps, 1753 S. 68 St., where officers shortly after contacted Piontek via cell phone. Steffen was informed officers wanted to speak with her regarding the incident, and they subsequently entered the Suburban, with Piontek driving, and made their way back to their residence at 1236 S. 113 St. Once Piontek pulled into the alley parking space behind their residence, she was then approached by officers.

**STATEMENT-CHRISTOPHER D. GEHRT-WITNESS**

Gehrt stated he was at the tavern with his girlfriend Petty, who started a conversation with an unknown male, later identified as Michael J. Piontek (M/W, DOB 06/18/69). Piontek was at the bar with an unknown female, later identified as Trisha Lynn Steffen (F/W, DOB 02/19/74), who Gehrt surmised was Piontek's girlfriend. Gehrt informed me they were all seated against the bar at this time.

Piontek had a long goatee which Petty started to play with for a while in a 'social capacity' in front of Steffen. Piontek bought a round of beverages for the small group while Gehrt went to the restroom to relieve himself when he heard a loud commotion near the bar. Gehrt ran back to the bar and saw Petty was surrounded by a group of people and bleeding from the face.

Gehrt eventually learned through other people Petty was struck in the face with some glass by Steffen. Based on the injuries a friend drove them to Aurora West Allis Medical Center for treatment. Gehrt did not know who the subjects were and had never seen them before. He believed the bartender Dean (no further information) knew them. Gehrt described Piontek as a M/W, 50 yoa, 600-603, medium build, with a large goatee. Steffen was described as a F/W, 45 yoa, 507-509, heavier build, with brown hair.

**STATEMENT-TIFFANY L. KIRKPATRICK-CONTACT**

Kirkpatrick stated she is Petty's cousin and was called to the hospital due to her injuries. Kirkpatrick did not witness the incident and was not at the tavern. Kirkpatrick was able to pull up Steffen's Facebook page in the emergency room. Gehrt and Petty identified Steffen and Piontek from the pictures on the Facebook website. Afterwards, I responded to Junebugs (6231 W. Mitchell St.) to speak with a witness, Joseph H. Guthrie (M/W, DOB 05/29/68).

**STATEMENT-JOSEPH H. GUTHRIE-WITNESS**

Guthrie stated he did not know any of the parties involved and was approximately 10-15 feet away when the incident. Guthrie saw a female (described above who was eventually found to be Steffen) and a male (described above who was eventually found to be Piontek) speaking with Petty. Eventually Steffen smashed a glass in Petty's face which caused her to start bleeding. Piontek got in Guthrie's face and stated, "Fuck you! You didn't see nothing!" Guthrie decided to disengage although pointed out Piontek was extremely aggressive and eventually left the tavern with Steffen.

**NARRATIVE****INITIAL RESPONSE**

On 12/20/14 at 2310hrs Officer Martin and I responded to Studz Pub, 6833 W. National Ave., for an assault that occurred inside the tavern. I made contact with Edward J. Speth, M/W 03/24/75, and obtained his statement regarding the incident.

**STATEMENT OF EDWARD J. SPETH**

Speth advised on today's date, 12/20/14, he was bartending at Studz Pub. There was a company Christmas party going on inside the tavern but Speth did not know the name of the company hosting the party. An unidentified male who was with the Christmas party got into a verbal argument with another unidentified male who was not with the Christmas party, in the tavern. Speth advised he stepped in between the two parties and began escorting the male who was not in the Christmas party, out of the tavern. Speth was near the front door, when he was punched with a closed fist, in the back of the head fives times by another unidentified male party who was with the Christmas party. The male that assaulted him was not involved in the verbal argument that just occurred.

Speth described the male that punched him in the back of the head as, a M/H, approximately 6'01-6'02, medium build, with short hair, and Speth advised the male was heavily intoxicated.

After several minutes, I resumed talking with Gray regarding the incident. Gray advised he was minding his own business inside the establishment, when out of nowhere, he was shoved outside and punched in the face by an unknown black male. Gray advised any altercation was unprovoked on his part, and the only reason he got punched in the face was because he was white. Gray also shouted several times that officers would regret dealing with him, because he was a manager at the Wisconsin Club. It should also be noted that Gray was shouting "niggers" throughout my contact with him in the back of my squad.

It was determined Gray had a bill he needed to pay inside, which totaled approximately \$42. Gray advised officers could use a credit card located inside his wallet to pay the bill, which was shortly after declined. Seven West Bistro personnel advised they did not want to pursue an arrest for Gray not paying his bill, but wanted him arrested for the disturbance he created, along with a trespass warning that he was no longer permitted to enter the establishment.

ARREST DECISION

After speaking with officers on scene, which determined Gray was the primary subject creating a disturbance, and based Gray's highly intoxicated and uncooperative state, Gray was taken into custody for disorderly conduct and transported to the station for processing.

Gray continued to be uncooperative with officers upon arrival at the police department. When performing a thorough search of Gray in an interview room, he again tensed up both his arms and attempted to pull away from officers. Gray was secured against the wall, where a thorough search was performed, and he was subsequently placed in a holding cell.

MIRANDA WARNING/INTERVIEW

On 12/22/14 at approximately 0300 hrs, while in the booking room of the West Allis Police Department, I read Gray his Miranda Warnings off Departmental Directive 42.016. Gray declined to speak with me regarding this incident, as he advised upon his arrest he requested a lawyer.

Gray was booked under #14-005947 for WA-947.01, issued corresponding municipal court citation M140059471, and released without further incident.

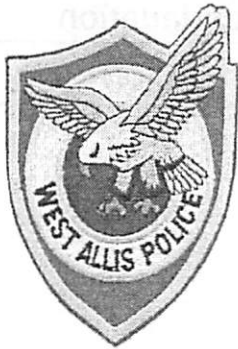

**DISPATCH TO CALL/ARRIVAL ON SCENE**

On 12/25/14 at 0111hrs officers responded to Larry Michael's, 8900 W Greenfield Ave for a report of an incident involving a firearm. I arrived on scene with Officer Martin and spoke with officers regarding the current location of the firearm used in the incident. I was advised that an individual identified as Adam Malmquist was in possession of the firearm and was currently inside of Stallis Palace, 8812 W Greenfield Ave. I was advised that Malmquist was inside of the bar wearing a blue Ralph Lauren vest.

I made contact inside of the business and was unable to locate anyone matching the immediate description of the Malmquist. After exiting the bar, a male matching the description came out and stood next to Officer Martin. Officer Martin then asked the male again if his name was Malmquist, and he responded "yes". The male then signaled for officers to walk to the side of the business to discuss the incident that occurred at Larry Michael's.

**STATEMENT OF OFFENDER - ADAM MALMQUIST**

I walked to the side of the business with Malmquist and spoke with him regarding his involvement. Malmquist stated he initially lied about his name because he did not know what to do. Immediately Malmquist advised he had some sort of involvement with the incident. Based upon this I asked him immediately if he had

possession of the firearm involved or knowledge of its current location. Malmquist took his left hand and point to the left pocket of the vest he was wearing. Officer Martin removed the gun from his pocket and secured the weapon.

I then spoke with Malmquist regarding the incident. Malmquist stated he was at Larry Michael's earlier in the night visiting his girlfriend, who was bartending, when he observed a male, who he knew as Mark Shallow, inside of the bar causing problems. Malmquist stated he has never met Shallow before but knows of him because he owns the jewelry store across the street and that his girlfriend knows who he is. Malmquist stated he observed Shallow having an argument with a male wearing a camouflage shirt.

Malmquist stated he brought Shallow outside of the bar to have a cigarette and attempted to calm him down. Malmquist stated he was outside with Shallow when Shallow began to tell him about the man wearing camouflage, whom Shallow stated was a "biker". Malmquist stated he went back inside with Shallow and continued on with the night. Malmquist stated he observed Shallow continuing to start a physical fight with the man in camouflage, but observed that the fight never occurred.

Malmquist stated he sat at the bar for approximately 10 minutes before Shallow came up to him. Malmquist stated he felt something under his chin. Malmquist stated he did not know what the item was but felt it first before he saw anything. Malmquist saw Shallow was holding the item with his (Shallow's) left hand and that he grabbed Shallow's wrist immediately. Malmquist stated the item was pointed upwards below his chin. Malmquist stated he began to hit Shallow's wrist in order to remove the item from his hand.

Malmquist was able to remove the item, which he determined to be a firearm, from Shallow's hand after striking Shallow several times at his wrist until Shallow let go of the firearm. Malmquist stated he never heard Shallow make any statements during the altercation. Malmquist stated he took the firearm and yelled to the bartender, opposite from his girlfriend working, to call 911. Malmquist stated he left the bar and walked outside to the vehicle to attempt to make the firearm safe. Malmquist has no knowledge of why Shallow would hold a firearm up to his chin.

Malmquist took the firearm to his vehicle, however was unable to make the firearm safe. Malmquist stated he did not know how to work the action for the firearm so he placed it back in his pocket. Malmquist stated he went to Stallis Palace, 8812 W Greenfield Ave, to consume one alcoholic drink. Malmquist stated he planned on placing the firearm in his vehicle after he finished the drink. Malmquist admitted to knowingly possessing the firearm inside of the business for approximately three minutes until police made contact with him.

When I asked Malmquist why he didn't called 911, he responded stating "I told the bartender to call 911". While speaking with Malmquist I detected a strong odor of

intoxicants emitting from his breath. Malmquist displayed red, glassy eyes and he slurred his speech whenever he spoke with me. Based upon my observations I believed Malmquist to be highly intoxicated.

#### ARREST DECISION

Based upon the presence of a firearm located on Malmquist's person, the strong odor of intoxicants emitting from his breath, and the fact he was in possession of a firearm inside of the tavern, I placed him into custody and transported him to the main station for a booking process.

A check was complete to see if Malmquist was a concealed weapons permit holder and I was advised that he was not. Malmquist also denied having ever applied for one.

#### IN CUSTODY STATEMENT OF OFFENDER - ADAM MALMQUIST

On 12/25/14 at 0227hrs in Interview Room A, I read Malmquist his Miranda Rights from WAPD Directive 42.016. In response to waiver questions, Malmquist stated he understood his rights and refused to speak with me at the time. Malmquist specifically stated he wanted to speak with his friend, who is a judge and a lawyer prior to speaking with me.

The interview concluded at 0230hrs. The interview was recorded using WAPD Olympus Digital Voice Recorder. I turned the memory card over to Officer Carlson to complete her interview and eventually place the memory card in an envelope and secured it in the ID Bureau drawer.

#### INTOXIMETER OPERATOR REPORT

I read a WAPD Consent form for a breath sample to Malmquist regarding obtaining a breath sample via the use of an Intoximeter. Malmquist stated he understood the form and I had Malmquist circle the "Yes" box and sign the form.

I administered the Intoximeter to Malmquist. I observed Malmquist for the 20-minute observation period from 0255 to 0315.

I gave Malmquist a basic instruction of the Intoximeter test. I informed him that he would be required to give at least two adequate samples of his breath. Malmquist stated that he understood and had no questions. Initially, Malmquist argued with officers over the arrest and the test initially timed out. After Malmquist calmed down again he was able to provide his first breath sample. At 0322hrs, Malmquist gave his first accepted breath sample of .223. At 0221hrs, Malmquist gave his second accepted breath sample of .221. His reported value was .22 g/210L. I explained the breath test results to Malmquist and he did not have any questions.

During my contact with Malmquist I detected a strong odor of an intoxicant on his breath, slurred speech and red and glassy eyes. Based on my observations, training and experience as a police officer, I believe Adam Malmquist was under the influence of an intoxicant. Malmquist was cooperative with me during the breath test.

**PILL ID**

I identified the prescription pills that were recovered from Malmquist during this investigation. The pills were rectangular in shape, white in color, and had the markings "TV 1003" on one side and "5 5 5" on the other. Using the website [http://www.drugs.com/pill\\_identification.html](http://www.drugs.com/pill_identification.html) as a means of drug identification, these pills were identified as Buspirone 15mg, not a DEA Schedule controlled substance however required a prescription for possession. I packaged the pill into a manilla paper envelope and placed it on property.

Malmquist advised that he had a valid prescription for the Buspirone but he combined the pill into his Alprazolam bottle because he did not want to carry additional medications bottles around with him.

**NARRATIVE****INITIAL RESPONSE**

**STATEMENT OF ALMA A. FRYE**

On scene, I made contact with bartender Alma A. Frye, F/W, 02/20/79, who stated she was in the bathroom when the incident occurred. When Frye exited the bathroom, her boyfriend, Adam L. Malmquist was holding a firearm in his hand.

Malmquist informed Frye that Mark S. Shallow had pointed the firearm at this head and then pointed it at Jeffrey J. Fuch's head. Malmquist told Frye that he grabbed the firearm and took it away from Shallow. Malmquist then walked outside of the bar to disarm the weapon. I asked Frye about the offender Shallow, and she stated he was a regular at the bar. When Shallow was at the bar this evening, Frye served him 2 beers. Frye stated Shallow was "mouthy" with the patrons and appeared to be upset/angry but she did not know why. Frye did not see Shallow leave the bar.

**TRANSPORT**

Once Shallow was taken into custody, I placed him into the vehicle and transported him to the station for the booking process.

**STATEMENT OF MARK S. SHALLOW**

I placed Shallow into Interview room B of the booking room. I read Shallow his Miranda Rights and during the course of explaining it Shallow stated he would talk to me as well as talk to an attorney.

**BOOKING**

I booked Shallow for: go arm with a firearm while intoxicated, carrying a concealed weapon, and carry handgun-alcohol sold/consumed. While fingerprinting Shallow he asked numerous times why he was arrested. I informed him each time of the charges he was arrested for. Shallow then informed me he wanted to talk about what had occurred this evening because he did not have a firearm on his person.

**STATEMENT OF MARK S. SHALLOW**

After completing the booking process, I again placed Shallow into Interview room B of the booking room. I again Mirandized Shallow who agreed to provide a statement without the presence of an attorney. I recorded the interview and

placed it on a memory card and turned it over to FTSB. The following is a summary of the statement Shallow provided:

Shallow stated he was at Larry Michael's this evening and returned to his residence sometime later. Shallow stated he drank a "couple of pints of Miller Lite" while he was at the bar. Shallow did not drink alcohol at his residence this evening and he does not have alcohol in his home. Shallow denied getting in an argument with anyone while at Larry Michael's and that he went to the bar alone. Shallow denied taking a firearm out of his residence this evening or taking a firearm to the bar.

Shallow stated that he was having an intimate relationship with Malmquist's girlfriend, Frye, and Malmquist was "not happy about it". Shallow believes he is being blamed for the incidents because of Malmquist.

Shallow left the front door of his residence open as well as unlocked and the back door was unlocked as well. Shallow then changed his story and stated the front door was closed but unlocked. Shallow keeps his residence unlocked because, "everyone knows not to fuck with me".

I again asked Shallow about bringing a firearm to Larry Michael's and he stated the firearm could have been a lighter that looked like a firearm. Shallow again denied having a firearm on him or pointing it at anyone.

Shallow believes someone may have set him up because people are "pissed at him". I asked which "people," and he stated his "ex-girlfriends". I asked Shallow if they (ex-girlfriends) would take his gun from his residence this evening and put it in his hand, and he stated they have before.

Shallow again informed me that Malmquist "set this up" because Frye wanted to have a relationship with him. Shallow repeatedly stated he never put a gun to anyone's head and did not do anything wrong this evening.

**RELEASE**

I informed Shallow he needed to report to circuit court on 01/19/15 regarding the offenses he was arrested for this evening. Shallow had an outstanding warrant with MCSO and was turned over to their agency.

**STATEMENT OF SCOTT N. BRZYCKI**

Scott advised he was working as the sole bartender, when two males, later identified as Tommie L. King and Justin D. Gragg, M/B 02-06-82 came into the bar. Scott stated they were at the bar earlier that afternoon also, but had since left for several hours. Upon returning, King and Gragg ordered a beer and a shot. Scott made their drinks as requested, meanwhile, Gragg stepped out of the bar. Scott gave both drinks to King, who became immediately upset, insisting he ordered a vodka / "Monster" mixed drink, instead of a beer. Scott explained to King that he ordered a vodka / "Monster" earlier this afternoon when he was here, but just now he ordered a beer. King became irate and began screaming profanities at Scott, calling him a racist.

Due to King's profane, aggressive, and loud behavior, Scott felt he may be too intoxicated and chose to stop serving him. Scott explained he planned to refuse him service and asked King to leave. King refused to leave the bar, despite Scott's warning of calling the police. King then grabbed the beer bottle (still full), which Scott had brought to him as part of his order. King threw the glass beer bottle at Scott, which missed him and landed on the rubber mat behind the bar, preventing it from breaking. Scott then took the full shot off of the bar and again told King to leave. King still refused and knocked over every unoccupied stool inside of the bar. Another patron was putting the stools back up, as King continued yelling and swearing at Scott and the other customers, still insisting they were racist. Scott stated none of the patrons spoke to King.

Gragg re-entered the bar at some point during King's outburst, but Scott was unsure when he came back. Scott advised Gragg did not directly cause any problems, but he was also highly intoxicated and did not make any attempts to stop King's behavior. Scott advised he never charged either party for the beer and shot. Scott requested they both be removed from the property.

INITIAL CALL

Lt. Saftig reports...Officers performed a tavern compliance check at Seven West Bistro (7211 W. Greenfield Ave.). Earlier in the shift, officers responded to a complaint of a large fight in the 1400blk. of S. 72 St. There was no fight upon our arrival, but we observed a very large volume of parked vehicles in the area and that the Seven West Bistro (tavern/nightclub) appeared very crowded. (See initial call# 14-054173). At approximately 0146hrs., officers entered the establishment and observed it was very crowded. I eventually made contact with the owner, Edward A. Brown Jr., M/B 12/20/1968. Brown was very cooperative and agreed to speak with me regarding several questions I had. I asked him about occupancy. Brown said the maximum capacity was posted as 103 people. I told him I believed there was well over 103 individuals in the establishment at the current time. (The lights came on and closing procedures started as I was speaking with Brown.) He said one of the doormen/security tracks the crowd flow using an "app" on his phone. I advised Brown that he needs to ensure this is strictly enforced. All patrons entering the club are supposed to use the front (north) door on W. Greenfield Ave. There is a rear (south) door that is supposed to be used for smoking outside of the establishment and is guarded by a security officer. I also asked him about security personnel, as there were both uniformed and plain clothes security present. At least one of the uniformed security officers was armed during our visit. Brown said he contracts with two (2) different companies. He said he did not know the name of one company, but it is a friend, George Harris, who is in charge. He said Harris and several of his employees have CCW permits, but it is not sure when/if they will be armed. The other agency is Midwest Intelligence; providing uniformed security. One of the five uniformed security officers was armed. Harris said the establishment will be open six (6) days/nights a week and closed on Mondays. Each day will have a different theme. He said he only expects the larger crowds on Friday and Saturday nights. Tonight's large crowd was attributed to him hosting what he referred to as a "D-list celebrity" rapper/entertainer. There were several photographers and videographers present during our visit. Brown said he will be at the business nearly every night and is assisted by his brother, Tom Brown. They operate under Wisconsin Beverage and Entertainment Partners LLC.

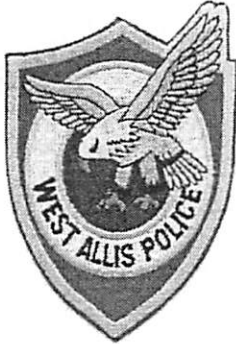

**CONTACT WITH ANTHONY J KIM (M/W 02/19/78)**

I checked this name in KGIS and found Jodi L Tegeler (F/W 05/30/72) of Greendale was arrested by Franklin PD in 2009. Tegeler comes back on file through Wisconsin and I could not find any information about her living in Tennessee as the prescription bottle states. I also do not know if Tegeler was the subject of Frye's complaint or if Tegeler was the other female that was struck by the intoxicated female.
