In the case of your failure to appear as required by this summons, the allegations in the complaint against you shall be taken as true and, if the License and Health Committee of the West Allis Common Council finds the allegations sufficient, a recommendation that your

license/permit (s) be suspended or revoked will be made to the full Common Council. The Common Council may then vote to suspend, revoke, or not renew your license(s).

You are further notified that if you appear as required by this summons and contest the allegations in the complaint, a hearing will be scheduled at a later date before the License and Health Committee, at which time you may be represented by counsel, cross examine the witnesses who testify adversely against you, and present witnesses in your own behalf. A written transcript of said hearing shall be made and you may obtain a copy of the transcript of this proceeding at your expense.

Michael J. Czaplewski, being duly sworn, on oath deposes and states as a complaint against Sonya Bautista as follows:

- 1. That the complainant is a resident of the City of West Allis, is the duly elected

 Alderperson for the First Aldermanic District in the City of West Allis, is the chair of
 the License and Health Committee, and makes this complaint at the direction of the
 License and Health Committee of the West Allis Common Council.
- 2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis and the West Allis Police

 Department, which records complainant believes to be reliable and accurate.
- 3. That Sonya Bautista is the holder of a Class "I" Operator's License No. 15-204, granted on July 1, 2013, entitling Sonya Bautista to work as an operator upon premises licensed under retail Class "A" or Class "B" Intoxicating Liquor and/or Fermented Malt Beverage licenses, pursuant to section 9.02(16) of the West Allis Revised Municipal Code and sections 125.17, 125.32(2) and 125.68(2) of the Wisconsin Statutes.
- 4. That on January 31, 2015, West Allis Police Department officers responded to the 57 Bar for a complaint of patrons smoking. Upon arrival, Corporal Ryan McNally observed bar patron, Rochelle Peters, smoking a cigarette inside the tavern. Further,

Corporal McNally observed Sonya Bautista, who was the bartender and in charge of the tavern, being approximately five feet away from Peters while she was smoking the cigarette. Corporal McNally issued warnings to Peters and Bautista for the smoking violation.

- 5. That on February 18, 2015, City Clerk Monica Schultz sent a letter to Sonya Bautista to notify her that the License and Health Committee ordered her appearance at its meeting on February 24, 2015. See attached Exhibit 1.
- 6. That Sonya Bautista failed to appear at the February 24, 2015 meeting.
- 7. That on February 25, 2015, City Clerk Monica Schultz sent a second letter to Sonya Bautista via certified mail to notify her that the License and Health Committee ordered her appearance at its meeting on March 3, 2015. See attached Exhibit 2.
- 8. That Sonya Bautista failed to appear at the March 3, 2015 meeting.
- 9. That Sonya Bautista has violated the provisions of Wis. Stat. § 101.123(2m)(a) and § 101.123(2m)(c) and West Allis Revised Municipal Code Sections 9.02(12)(b) and 9.02(12)(d); the conduct of Sonya Bautista substantially relates to the alcohol licensed activity contrary to Wis. Stat. § 125.04(5)(b) and is grounds for non-renewal, suspension, or revocation of her operator's license.

WHEREFORE, Michael J. Czaplewski requests that Sonya Bautista be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Operator's License issued to Sonya Bautista should be suspended, revoked or not renewed.
