The Common Council of the City of West Allis do ordain as follows:

PART I. Subsection 9.05(2)(b) of the Revised Municipal Code of the City of West Allis is hereby ereated to read:

9.05 DANCE HALLS

6/10/10.(2) Dance Hall License.

(b) This section shall not apply to studios or dance academies whose primary business is dance instruction and do not offer food or beverages for sale on the premises.

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby amended.

PART III. This ordinance shall take effect and be in force from and after its passage and publication.
