SUMMARY

Pto Lazaris reports...**Battery**...

On 12/16/19 at 0010hrs., officers were dispatched to Tap City (7207 W. National Ave.) for the report of an individual who was starting fights inside the bar. Officers arrived on scene and spoke with the caller, Sara A. Quesnell (F/W [redacted] who stated she witnessed a M/W (later identified as John H. Anderson, M/W [redacted] assault multiple individuals inside the bar. Officers also spoke with Joshua J. Borchardt (M/W [redacted] who sustained an approximate 3in long abrasion to his forehead as a result of John's actions. Officers located John at his residence and he was arrested, booked, and cited for Battery. John was provided with a Municipal Court date of 01/20/20 at 0830hrs prior to his release from the station.

NARRATIVE**Pto Lazaris reports...****INITIAL CALL**

On 12/16/19 at 0010hrs., officers were dispatched to Tap City (7207 W. National Ave.) for the report of an individual who starting fights with patrons. As I was responding to the above address, dispatch advised the offender fled westbound on W. National Ave. in a white Dodge Ram (unknown plates). Just prior to hearing this update, I observed a white Dodge Ram traveling at a high rate of speed westbound on W. National Ave. The vehicle conducted a northbound turn onto S. 76 St. but officers were unable to located the vehicle or the driver. Officers then responded to Tap City to speak with the caller.

Officers arrived at the tavern and spoke with Sara A. Quesnell F/W [REDACTED] (caller), Yvonne M. Hoeft F/W [REDACTED] (witness), Daniel Pekrul M/W [REDACTED] (witness), Joshua J. Borchardt M/W [REDACTED] (victim), Scott S. Wilson M/W [REDACTED] (victim), Henry J. Schmidt M/W [REDACTED] (contact), and Kari C. Stapleton F/W [REDACTED] (contact). Officers would later respond to 1551 S. 91 St. and make contact with the offender, John H. Anderson (M/W [REDACTED]).

OFFICER OBSERVATIONS

Shortly after entering the bar, I observed a M/W standing on the south side of the establishment. The M/W was later identified as Joshua J. Borchardt (M/W [REDACTED]). I approached the Joshua and observed he had an approximate 3 inch long laceration on his forehead. I also observed Joshua's forehead was red and swollen. I asked Joshua how he obtained the injury and he stated he had been thrown into the bathroom door by the offender (John). I also observed Joshua had a bag of ice that he was applying to his injury. Joshua stated he did not need medical attention.

STATEMENT OF VICTIM (JOSHUA)

I asked Joshua if he had any contact with the individual who was causing problems at the bar. Joshua stated he had been involved in the altercation. I asked Joshua to tell me what happened starting from the beginning. Joshua stated he observed a M/W (later identified as John H. Anderson M/W [REDACTED]) enter the bar through the door on the west side of the business. Upon entering the bar, the bartender told him to get the fuck out. John did not leave the establishment and proceeded to yell and scream at the bartender. John proceeded to walk towards the south side of the bar.

Joshua continued watching John as he walked towards the south end of the bar. Joshua stated he initially wasn't going to get involved however; he got involved once he observed John was "Slamming girls out of the way." Joshua stated at least one girl fell to the ground as a result of John's actions. I asked Joshua which girl was knocked to the ground and he pointed to a female who was later identified as Kari C. Stapleton (F/W [REDACTED]). I asked Joshua what he did after he observed Kari being knocked to the ground. Joshua stated he encouraged John to leave the establishment.

Joshua stated John did not immediately leave the residence and the two of them engaged in pushing and shoving. It was during this altercation that Joshua was thrown into the bathroom door. John eventually exited the establishment stating "Fuck you, call the cops."

STATEMENT OF CALLER (SARA)

Sara stated she did not have any direct contact with John throughout the night. Sara stated she called the police because the bartender, Yvonne M. Hoeft (F/W [REDACTED]) asked John to leave the bar and he was refusing to leave. Sara stated she observed multiple people encouraging John to leave the bar however; he still refused to exit the establishment. I asked Sara if she observed John throw Kari to the ground and she stated Kari fell to the ground while the bar patrons were attempting to escort John out of the establishment. I asked Sara if she observed anything else or if she had any additional information to add to her statement and she stated she did not.

I asked Sara to describe the offender to me and she stated the offender was approximately 6'02 and was wearing blue jeans. Sara also observed the offender drive away in a white Dodge Ram bearing WI Reg. #JT8531. Sara was also able to obtain a photograph on the license plate prior to John leaving. Sara showed me the photograph and I confirmed the license plate was #JT8531. I provided this information to dispatch who advised the owner was John H. Anderson (M/W [REDACTED]) who resides at 1551 S. 91 St. Officers would later respond to this address and make contact with John.

CONTACT WITH OFFENDER (JOHN)

After speaking with everyone involved, officers responded to John's address (1551 S. 91 St.) in an attempt to speak with him regarding the incident that took place at Tap City. Upon arrival to the residence, I observed a white Dodge Ram bearing WI Reg. #JT8531 parked in the driveway. The vehicle was unoccupied and officers proceeded to attempt contact at the front door.

Officers knocked at the front door and were eventually able to make contact with a M/W who was later identified as John H. Anderson (M/W [REDACTED]). I asked John if he had any weapons concealed on his person and he stated he did not. I conducted a frisk of his person for weapons. During this frisk, I felt an object in John's back right pocket. Based on my training and experience as a police officer, I believed the object to be a weapon (brass knuckles). I removed the item from his pocket and observed it was brass knuckles. Officers would later place this item in the Phoenix property as evidence. Officers asked John if they could enter his residence and speak with him and he stated officers could speak with him inside his residence.

Once inside the residence, I asked John if he was at Tap City earlier and he stated he was at the establishment earlier in the evening with his girlfriend Kari C. Stapleton (F/W [REDACTED]). While at the bar, John became upset because he found out Kari was cheating on him. I asked John if there was a confrontation between him and Kari and he stated there was not. I asked John if the bartender asked him to leave and he stated he was asked to leave.

I asked John what happened next and he stated there was an older gentleman that "jumped" and "attacked" him. John stated he did not know why he was attacked. I asked John if he pushed or shoved anyone and he stated he did not. I asked John what happened after the older gentleman attacked him and he stated he fell to the ground. I asked John if it was possible the physical confrontation took place because he did not leave the bar after being kicked out. John stated he left the bar immediately after being asked to leave. John stated he did not have any other

physical confrontations with any other individual aside from the older gentleman who attacked him. I then inquired about the brass knuckles I located on his person. John stated the brass knuckles were part of a belt buckle and he brought them to the bar to give to Kari as a Christmas gift. John stated he eventually left Tap City and went to Studz Pub without any further issues.

ARREST DECISION

Based on officers observations and the statements obtained by officers, I arrested John for Battery.

BOOKING/CITATION ISSUANCE

I booked John for Battery under #19-004580. I also issued John Municipal Citation #1S804VWKP8 and provided him with a Municipal Court date of 01/20/20 at 0830hrs.

IN-CUSTODY STATEMENT

While in the booking room of the West Allis Police Department, I read John his rights as they are written on my department issued card. John stated he understood his rights and would be willing to answer questions concerning his arrest. The interview began at 0139hrs and was conducted in interview room #B of the West Allis Police Department.

I asked John to provide me with the details of what happened starting from the very beginning. John stated he went to Tap City at approximately 2100hrs on 12/15/19. John stated he went to Tap City to meet up with his girlfriend, Kari. John stated he socialized with his friends (including Kari) for approximately one and a half hours. During this time, there were no arguments or physical altercations between anyone. At approximately 2230hrs., John left Tap City and went to Studz Pub to meet up with other friends. John stated he was not involved in any arguments or physical altercations while he was at Studz Pub. At approximately 2340hrs., John went back to Tap City to meet up with Kari.

As soon as John entered Tap City, the bartender asked him to leave. John stated he did not immediately leave the establishment because he was trying to locate Kari.

John stated he was then attacked by an elderly gentleman and the two of them fell to the ground. I asked John why he believed he was attacked and John stated he did not know. I asked John what happened next and he stated he was able to "fight his way out of it." John stated he did not swing at anyone during this altercation.

I asked John how much alcohol he consumed prior to the altercation taking place and he stated he consumed approximately 6-8 White Claws (hard seltzer water) and three shots of alcohol. I also inquired about the brass knuckles I located on his person while at his residence. John stated he intentionally brought the brass knuckles to Tap City because he wanted to show them to Kari. John also stated the brass knuckles were part of a belt buckle, but it was clear there was no ability for the item to be a belt buckle. I asked John if he had any additional information to add to his statement and he stated he did not.

The interview was recorded on my department issued body worn camera. Please refer to the footage for precise details. John appeared to be intoxicated for the duration of my contact with him.

CASE DISPOSITION

John H. Anderson was arrested, booked and cited for Battery. John was provided with a Municipal Court date of 01/20/20 at 0830hrs. At the conclusion of the booking process, I provided John with a courtesy ride back to his residence located at 1551 S 91 St.

NARRATIVE

Sergeant Kleinfeldt:

At the time of this investigation I was wearing my WAPD issued body camera, which was functional and activated. The body worn camera footage was categorized as Municipal Arrest. See video recording for precise details as the following is a summary based off little or no review.

RESPONSE

On 12/16/19 at 0010hrs I, Sergeant Kleinfeldt, responded to Tap City at 7207 W National Ave and assisted other officers on this complaint.

Upon arriving, I was told by one of the patrons an older male patron had exited the back door and had been knocked down to the floor during the physical incident. I went outside to locate the male.

CONTACT WITH SCOTT WILSON

I found Scott S Wilson (M/W [REDACTED]) outside the back door. Wilson said he witnessed the incident and gave me the following information over my contact with him.

Wilson was inside the bar when a male, later identified as John H Anderson (M/W 05/19/72), came into the bar. Wilson said Anderson entered into a verbal argument with others at the other end of the bar about personal matters, and the bartender (Yvonne Hoeft) asked him to leave. According to Wilson, Anderson refused to leave. Wilson said people in the bar, including him, began

to escort him out. Wilson did not go into detail regarding how the patrons of the bar escorted him out.

Wilson said Anderson pushed him down intentionally, and he fell to the floor. Wilson said he did not feel any pain and he would be fine. Wilson was 71 years old, and had no visible injuries. I asked Wilson to describe how Anderson pushed him, and Wilson said the situation happened quickly and he could not recall.

I asked Wilson to describe the offender. Wilson described him as a white male, husky build, "scruffy" looking, maybe 45 years old, about 6 foot tall, and had short hair which was graying. I later observed this description matched Anderson.

FOLLOW UP

I then traveled with other officers to 1551 S 91 St to make contact with Anderson. Officer Lazaris primarily spoke with Anderson after he allowed us into the house and confirmed he was present for the altercation. I observed Anderson appeared to be intoxicated by his glassy/bloodshot eyes, odor of alcoholic beverage, thick speech, and admission of drinking all day. Anderson became more argumentative as the contact progressed.

NARRATIVE

Officer Vanden Boogard reports....

INITIAL RESPONSE

On 12/16/19 at approximately 0038hrs, I responded to 1551 S. 91 St. to assist other officers in a battery incident that occurred at Tap City bar at 7207 W. National Ave. Contact was made with the suspect, John H. Anderson, M/W [REDACTED] by other officers. Through contact with him, it mentioned he had been at Studz Pub at 6833 W. National Ave. earlier in the night.

CONTACT WITH EMPLOYEE OF STUDZ PUB

After clearing from Anderson's residence I responded to Studz Pub at approximately 0124hrs, and made contact with the bartender, Rebecca A. Hagmann, F/W [REDACTED] Hagmann was familiar with Anderson as she has known him for many years and she considers him a friend. She stated he is a "troubled" person referencing his personal life. Anderson was at Studz Pub tonight around 2330hrs. He arrived alone and left by himself. He consumed approximately 2-3 alcoholic beverages. Hagmann was unsure where he came from before arriving at the bar. She did not observe any injuries to him. She was aware that he had been texting with a female named Kari but was unsure of the conversation. Hagmann knows Kari as a bartender in the area, and is not friend's with her.

Hagmann believed Anderson went home after leaving Studz Pub. She later was made aware that Anderson went to Tap City afterwards. She stated she knows everyone in the neighborhood and had spoken to someone regarding Anderson. She texted him "Hello?..." (which was her way of checking in on him). She did not receive a response from him.

My body camera was mistakenly not activated immediately while speaking with
