The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of April.

Incident reports:

Case # 12-002639, 04/01/2012, at approx. 0100 hrs - Boz's Sports Bar, 1325 S. 70th St.

On 04/01/2012, at approx. 0441 hrs, the complainant came into the station to report that at approx. 0100 hrs while at Boz's Sport's Bar (1325 S. 70th St) he was punched in the face by a known individual. The complainant appeared to be very intoxicated while making this report. Further investigation revealed that a mutual fight ensued between the complainant and another male patron; both parties were subsequently cited for Disorderly Conduct.

Case # 12-002691, 04/02/2012, at 2316 hrs – Crazy Horse Gentlemen's Club, 9442 W. National Ave.

On 04/02/2012, at 2316 hrs, Officers responded to Crazy Horse Gentlemen's Club (9442 W. National Ave) regarding an assault complaint. The complainant / victim called our department to report that he was physically assaulted while inside the bar; stating, he was forced to the ground and punched in the head by another patron(s). Officer's investigation identified the two males who were responsible for assaulting the victim. One of the offenders was also in possession of THC; both offenders were taken into custody, booked, and cited for D/C. In addition, the person who possessed the THC was cited for that as well.

Case # 12-2968, 04/11/2012, at 2330 hrs – DND Sports Bar, (1022 S. 60 St).

On 04/11/2012, at 2349 hrs, Officers were dispatched to DND Sports Bar (1022 S. 60th St) for a report of a sexual assault. The complainant / victim reported to investigating officers that she was sexually assaulted by three male persons who were currently in the bar. The assault allegedly took place in the women's restroom. Further investigation revealed that the complainant engaged in sexual activity with one of the three male's that were in the bar.

There were conflicting statements as to what actually occurred, but the complainant / victim and one of the male individuals both acknowledged that they engaged in sexual activity in the women's restroom. It appeared that the bartender was aware of what was going on and did not take any measures to prevent this incident, nor did he call the police. It was clear that the female complainant was highly intoxicated when she entered the bar and should not have been served.

Case # 12-2970, 04/12/12, at 0148 hrs - Johnny Hammers Tavern (6300 W. Lincoln Ave).

On 04/12/2012, at 0148 hrs, while on routine patrol in the 6300 blk of Lincoln Ave, Sgt. Corwin observed a M/H look directly at him and displayed an offensive hand gesture. Sgt. Corwin made contact with this intoxicated individual who stated he was gesturing the sky. While speaking with this person a friend of his asked officers what was going on? Investigation revealed that this person was underage and had been drinking alcohol inside Johnny Hammers Tavern; he and the bartender were subsequently cited.

Case # 12-3263, 04/22/2012, at 0301 hrs - Whammy Bar (formerly Smokin Joes), 6139 W. Beloit Rd.

On 04/22/2012, at 0301 hrs, Cpl. McNally responded to the Whammy Bar, 6139 W. Beloit Rd, regarding patrons inside the bar after hours. Upon Officer McNally's arrival he observed a group of approx. 12-15 individuals who were still inside the bar, and several of them were consuming alcohol. Several of the patrons appeared to be band members, but were not packing up their equipment (they were standing behind patrons who were seated at the bar). One individual in particular was giving Officer McNally a difficult time; he was identified as Peter Grubor whose name I recognize from appearing in front of the license committee previously (affiliated with Smokin Joes Bar). Mr. Grubor stated to Officer McNally that he was with the band and was waiting to get paid. Officers issued numerous tickets to the individuals who were in the bar.
