Ordinance to amend Section 12.20(3)(b) of the Revised Municipal Code by including a provision for the type and number of vehicles permitted to park off-street and upon single and two-family residential properties.

The Common Council of the City of West Allis do ordain as follows:

PART I. Section 12.20(3)(b) of the Revised Municipal Code of the City of West Allis is hereby amended, as follows:

### 12.20 OFF-STREET PARKING REGULATIONS FOR SINGLE- AND TWO-FAMILY DWELLINGS.

#### (3) Types of vehicles

(b) No more than one of the following types of commercial vehicles or commercial vehicle attachments are permitted per property and must be on paved surfaces (also see Section 12.17 of the RMC regarding home occupancy vehicle and business use restrictions):


6. A tow truck or a flatbed hauler truck (maximum single vehicle capacity) when the operator is on-call and is a City towing contractor in accordance with Section 9.24 of the Municipal Code. When parked in a residential district the tow truck and/or flatbed hauler vehicle shall be kept empty (without vehicle in tow).


PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect and be enforced from and after its passage and publication.
