Recently, Jeff Warchol, West Allis Assistant City Attorney, provided me information about the City of Brookfield's program of publicizing the names of delinquent personal property taxes in the Brookfield NOW newspaper. It occurred to us that the City of West Allis should consider a similar program.

A West Allis program of this nature could include not only real estate and personal property taxes, but it could also include other unpaid items and accounts. The names listed could be everyone or just the habitual offenders. The list could be maintained on the City's Intranet so it can be accessed by all departments to be kept up to date. Names could be listed in a variety of media formats, including newspapers, the City web site, the City cable channel, the City newsletter, and possibly other targeted listings.

Publicizing the Names of Delinquent Property Taxes, etc.

This memorandum is to document the conditions under which the publicizing of the names of delinquent property taxes and other unpaid accounts may be done by City staff. These guidelines were included in the Administration & Finance Committee approval of my request to do such in my communication to the Common Council dated July 26, 2010 (August 9, 2010 Administration & Finance Committee meeting).

The conditions/guidelines are as follows:

- 1. Target only habitual offenders (three years or more).
- 2. No newspaper publication of names (only use the City Newsletter, web site, and cable channel).
- 3. Staff must ensure that the information is absolutely accurate before any names are publicized (IT will develop a list for display on City Intranet so all departments can access it and keep it up to date).
- 4. A "last chance" letter (before publicizing) will be sent in advance to all delinquents. (Staff should consider presentation of unique information or extenuating circumstances that might justify not publicizing a certain delinquent name. Also, if the delinquent makes some "good faith" effort in paying a portion of the delinquency, then staff should consider not publicizing the name.)
- 5. No addresses or phone numbers will be publicized with the names.
