

Good morning Alderperson Czaplewski and Common Council:

Include are a few dozen signatures I obtained this weekend between my two jobs that were **AGAINST** the requested ordinance amendment change to the C-2 zones to allow clinics.

I spent 2 ½ hours on Friday and 1 1/2 hours on Saturday with a clip board and the Informational Neighborhood Meeting letter you sent out dated May 31, 2011. The most difficult part, aside from the time, was finding people home. Less than a handful didn't sign. I obtained a signature averaging every 4.3 minutes. I spoke to approximately 59 people, obtaining 55 signatures which is **93%** of those addressed being **opposed** to the ordinance amendment request. This is most definitely a substantial representation of the residents in the area **not** wanting Brotoloc's outpatient mental health clinic at 5812 W Burnham Street and opposing the amendment request for the C-2 zones. Thank you.






