

SUMMARY

Officer Agor reports... On 11-08-13 at 0027 hours, officers responded to Brooklyn's, located at 9442 W. National Ave., for a trouble call. Officers made contact with two patrons identified as Anthony M. Cereceres (M/W 11-24-81) and Peter D. Griffin (M/B 12-21-61) as well as two security staff members identified as David E. Cusimano (M/W 08-15-51) and Todd E. Kohler (M/W 02-02-65). Investigation showed Anthony was asked to leave the establishment by Brooklyn staff, but refused to comply and assaulted both security personnel. Anthony was taken into custody and issued municipal citations for Criminal Trespass to Dwelling and Disorderly Conduct. Anthony was given a court date of 12-09-13 at 0830 hours and was eventually released.

NARRATIVE

Officer Agor reports...

INITIAL CALL

On 11-08-13 at 0027 hours, officers responded to Brooklyn's, located at 9442 W. National Ave., for a trouble call for two males fighting/ swinging a belt at security.

INITIAL OBSERVATION

Upon arrival, I observed Todd E. Kohler (M/W 02-02-65) standing outside of Brooklyn's with a disheveled sport jacket pointing at a white male, later identified as Anthony M. Cereceres (M/W 11-24-81). Todd repeatedly stated, he (Anthony) was the customer causing all of the problems. I immediately placed Anthony in handcuffs and place him in the back of my squad for further investigation.

ON SCENE STATEMENT OF ANTHONY M. CERECERES (OFFENDER)

Anthony stated he did not do anything and that nothing happened. As Anthony spoke, I could detect a strong odor of an alcoholic beverage emitting from his breath. I observed Anthony's eyes were red and glassy and his speech was slow and slurred. Based on my observations of Anthony and my training and experience, I believed Anthony was intoxicated. Anthony repeatedly told me he was sorry. I asked Anthony what he was sorry for. Anthony replied he was sorry the police had

LACK OF CONSENT

Todd informed officers that Anthony was asked repeatedly to leave. Anthony refused to leave and was escorted out of the establishment. After Anthony was escorted out of Brooklyn's, he took his belt off and struck David and Todd. Neither David nor Todd gave Anthony permission to strike them with his (Anthony's) belt.

ARREST DECISION

Based on Todd's, David's and Peter's statements of how Anthony was asked to leave Brooklyn's, but refused to and was eventually escorted out, as well as Anthony's assault of David and Todd, I placed Anthony under arrest for Criminal Trespass to a Dwelling and Disorderly Conduct.

CONVEYANCE AND BOOKING OF ANTHONY M. CERECERES (OFFENDER)

I conveyed Anthony to the West Allis police station where I booked and fingerprinted Anthony under booking #2013005243. I issued Anthony municipal citation #M130052431 for Disorderly Conduct and municipal citation #M130052432 for Criminal Trespass to Dwelling. Anthony was given a court date of 12-09-13 at 0830 hours.

DISPOSITION

Anthony was arrested for Disorderly Conduct and Criminal Trespass to Dwelling, both with a court date of 12-09-13 at 0830 hours. Anthony was highly intoxicated. Anthony was released when he became sober.

Officer Taylor reports

CALL FOR SERVICE

On 11/08/2013, at approximately 00:39 hrs, officers responded to a call of two males fighting at Brooklyn's (9442 W. National Ave). Upon arrival, I spoke with David E. Cusimano Jr., M/W, 8/15/1951.

ON SCENE STATEMENT-DAVID E CUSIMANO JR-VICTIM

Cusimano stated an intoxicated male, later identified as Anthony M. Cereceres, M/H, 11/24/1981, fought with security staff within Brooklyn's.

Cusimano explained the incident began when he approached Cereceres, and asked him to stop putting his hands on another patron. Cereceres was angered by the request, and stated the patron being touched was his friend. Cusimano gave Cereceres several more chances to leave on his own accord. Cereceres became "animated" and "cocked his fist back." Cusimano demonstrated "cocking" his fist back behind his head. This forced Cusimano to take control of Cereceres.

Head of security Todd E. Kohler (M/W 02-02-1965), and Cusimano took control of Cereceres, and took him outside. Kohler attempted to get Cereceres to leave by pushing him out the door, culminating in Cereceres taking his belt off. Cereceres "took swings" at both Kohler and Cusimano. Cereceres then began to swing his belt at Kohler and Cusimano, successfully hitting both with the belt. Kohler then punched Cereceres in the face three times. Police arrived on scene and took Cereceres into custody.

LACK OF CONSENT

Cusimano did not Cereceres his permission to punch or "whip" him with the belt.

CALL FOR SERVICE

On 11/08/13 at 0027 hrs, officers responded to a trouble call at Brooklyn's, 9442 W. National Ave. Upon arrival, I was directed to obtain a statement from security employee, Todd E. Kohler (m/w, 02/02/65).

STATEMENT - TODD E. KOHLER

Kohler stated he observed a disturbance within the establishment between two patrons, one of whom was identified as Anthony M. Cereceres (m/h, 11/24/81). Cereceres was told numerous times to calm his behavior, but he continued to create a disturbance by yelling and ultimately confronting a security employee, Cusimano. The two parties escorted Cereceres outside, where he continued to yell. Kohler stated Cereceres appeared highly intoxicated.

Kohler stated while outside, Cereceres took off his belt and struck Kohler in a whipping motion approximately five or six times on his right arm and right side. Kohler and Cusimano pushed Cereceres against the building, and Kohler stated he punched Cereceres in the face approximately three times. Cereceres grabbed ahold of Kohler's suit jacket, which resulted in the buttons being ripped off the jacket. Kohler separated from Cereceres and went into Brooklyn's, where the police were called.

Kohler requested Cereceres be charged with disorderly conduct and criminal trespass. Kohler stated he had no injuries and did not need medical attention. Kohler advised he had no further information on the incident.

CALL INFORMATION

On 11/08/13 at 0027hrs. officers responded to Brooklyn's Gentleman's Club at 9442 W. National Ave for 2 males fighting with security. Upon arrival PO Agor was already on scene and had a male, identified as Anthony Michael Cereceres M/W 11/24/81, in custody.

STATEMENT OF GRIFFIN (WITNESS)

I spoke with a male outside who was identified by WI DL as Peter D. Griffin M/B 12/21/61. According to Griffin he was Cereceres' designated driver tonight. Cereceres had too much to drink and started verbally causing problems so security had gotten involved. Cereceres started a verbal altercation with security who escorted Cereceres out of the club. While they were escorting him out, Cereceres continued with the verbal altercation and began pushing security. Griffin stated the security had then gotten outside with Cereceres and he didn't know what happened after that. Griffin repeated stated that Cereceres had way too much to drink and that was the only problem.
