NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Common Council of the City of West Allis that the proposal dated October 18, 2013 submitted by Ewald Automotive Group for furnishing and delivering five (5) 2014 Chevrolet Impala Police 4-door Squad cars for \$106,215.00 and one (1) 2014 Jeep Wrangler Parking Checker vehicle for \$28,695.00 for a total net sum of \$134,910.00 be and is hereby accepted.



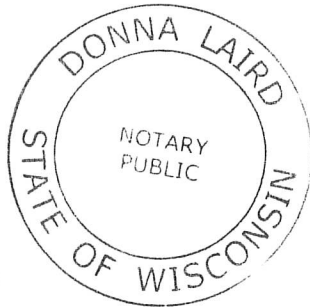
