

INITIAL RESPONSE

He was described as wearing a brewer shirt and bright green shorts. I was the first officer on scene and approached the business from the east. I observed a M/W matching the description of the suspect sitting on the cement steps in front of the business. I approached the male and as I was approaching twenty feet away from him, dispatch radioed that the caller called back and stated the male had a firearm. I ordered the male to put his hands in the air and to keep them there, which he complied. I approached him, and did not observe a firearm in plain view. I had the male stand up and then I performed a pat down for my safety. I did not locate any weapons.

STATEMENT OF BRANDON M. DORT - OFFENDER

The male identified himself as Brandon M. Dort, M/W 10/17/95 and I obtained his statement. Brandon advised he and his mother, Denise had started their night by drinking at the bar, then they got a shuttle to the Brewer game and then they got shuttle back to the bar where an incident occurred. male was hitting on his mother inside the business. He told the male (later ID as Andrew M. Tocco, M/W 02/17/73) to stop talking to his mother several times. Parties had gone outside and Brandon and his mother were standing near the cement steps while Andrew was standing near the front door. Andrew continued to talk to Denise which infuriated Brandon. Brandon stated he struck Andrew in the face and Andrew fell down. Brandon stated he walked away down the street, however he came back a short period later to find Andrew to fight him some more. Brandon could not get into the bar so he began walking back and forth on the sidewalk. Police arrived shortly after. Brandon stated he had several drinks at the bar and he felt that he should not drive home under his current impaired state.

I asked Brandon why there was a mention that he had a firearm. He stated he had a CCW permit. He also stated his firearm was in his vehicle that was parked on a nearby street, however he stated he never had the gun on him tonight and he did not bring it into the bar. He continuously stated he knew that if he had been carrying his gun while drinking than he would go to jail, and he would not do that because he did not want to go to jail. He stated he has a Glock 19 Gen 4 9mm handgun in the center console of his vehicle. He stated the gun had a loaded magazine in it but there was no ammunition in the chamber.

I then spoke with other officers on scene and it was determined that several witnesses observed Brandon assault Andrew, and then he pulled out the firearm and pointed it at him. Brandon continued to deny ever having the firearm on his person at the bar and he denied pointing it at anyone.

See Officer Kaye's report regarding location of the firearm. Officer Kaye radioed to me that the firearm was not located where Brandon stated it should have been (center console), as the firearm was actually located in the trunk. In addition there was no ammunition in the firearm as the magazine was pulled out and also located in the trunk. I informed Brandon that the firearm was not located in the vehicle where he had told me it should have been. He could not think of any other place the firearm would have been, because he stated he always carried it in the center console. I asked him again if he had gone to his vehicle and grabbed his firearm after getting back from the Brewer game, and he denied doing any such thing.

OFFICER OBSERVATIONS

I detected an odor of an intoxicant emitting from Brandon's breath. His eyes were red and glassy, he slurred his words, and he appeared unsteady on his feet. I also observed a fresh scrape to his right hand on his knuckle in which the skin was peeled off and it had been bleeding. I noticed there was dry blood on his shirt. Brandon denied needing medical attention.

At the station I asked Brandon if he would be willing to perform Standardized Field Sobriety Tests, which he agreed. The tests were conducted in the booking room.

Horizontal Gaze Nystagmus

Brandon was asked if he could see my pen and was instructed to touch the tip of my pen. I instructed the defendant to follow the tip of my pen with his eyes-only and not to move his head. He stated that he understood my directions.

I checked for equal pupil size and equal tracking, a lack of smooth pursuit, distinct sustained nystagmus at maximum deviation and an onset of nystagmus, prior to a 45-degree angle. I checked each eye twice for each clue, starting with the left eye. I also checked for vertical nystagmus.

Results: I observed a lack of smooth pursuit, as well as distinct sustained nystagmus at maximum deviation, as well as nystagmus prior to a 45-degree angle. I also observed vertical gaze nystagmus, a possible indicator of a high level of

WALK AND TURN

I placed Brandon in the instructional stance by having him place his left foot on a straight line (using the line floor line in the booking room) with the right foot in front, heel to toe. I instructed him to keep his arms at his side and maintain that position until I told him to begin the test. I gave Brandon a complete set of instructions and a demonstration of the test. He stated he understood my directions.

Results: Brandon fell off balance one time during the instructional period. During the first set of nine steps he fell off line on step 2. On the return set of nine he fell off line on steps 2 and 3.

The defendant exhibited 2 clues or indicators of a possible total of 8 clues or indicators a person who may be intoxicated by alcohol or drugs may exhibit.

ONE LEG STAND

I gave Brandon a complete set of instructions and a demonstration of the test. He stated he understood my directions.

Results: He raised his left foot for the test. On his count of 8 he swayed and stuck his arms straight out to the side for balance.

Brandon exhibited 2 clues or indicators of a possible total of 4 clues or indicators a person who may be intoxicated by alcohol or drugs may exhibit.

Card. He agreed to speak with me regarding this incident. This interview was audio recorded on a Digital Voice Recorder and saved on my departmental media card (2619). The media card was later uploaded to the DIMS system. Brandon's statement here is paraphrased for this report.

Brandon stated he went to a place called "One More" with his mother. From there they went to the brewer and afterwards went back to the bar. He stated some things were said towards his mother that he did not agree with and he hit the individual saying them in the face. He struck the person three to four times, before he was stopped by someone else. He was unaware if the man needed medical attention. Brandon sustained an injury to his right knuckles. Brandon admitted to consuming alcohol, and estimated he had less than ten beers. He did not have any shots of liquor and was not taking any medications. The incident occurred outside the bar in the front of it.

I questioned Brandon regarding his firearm. He stated he had thought about "taking it out" but he came to his senses and did not. However he stated he moved the gun and he possibly put it in trunk. He stated he did not have any recollection of taking the gun out while standing in front of the bar. He remember thinking about bringing it out but did not believe he actually did. I asked him why he would not remember bringing the gun out and he replied because it was in the heat of the moment and his adrenaline was going. He stated he did not remember pointing the gun at anyone. He stated the gun should not have had a bullet in the chamber but the magazine should have been loaded.

I asked Brandon if he was yelling at his mother and if that may have caused the start of the incident. He stated he was not yelling at her but talking to her in a firm matter.

The interview ended at approximately 0349hrs.

CASE DISPOSITION

Brandon M. Dort, was outside of a tavern when he physically assault Andrew M. Tocco. According to the victim and witnesses, Brandon then pulled out a firearm and pointed it at Andrew. Officer located a firearm in Brandon's vehicle that was parked approximately one block away. Brandon was intoxicated and submitted to an intoximeter test which registered his BAC at .19. He was arrested for 2nd Degree R.E.S. / ESBUDW/ and Battery. The DA review is set for 06/04/17 at 0830hrs.

NARRATIVE

PO Kaye Reports:

On 06/03/17 at approximately 0132hrs, officers responded to the One More tavern, 7534 W Beloit Rd, for a report of an individual who was attempting to fight with individuals. While enroute, it was advised by the WAPD Dispatch the offender was in possession of a firearm.

saw Brandon outside but never saw the firearm.

Lopez stated she locked the business and closed it off so that no one could come in or leave. Lopez heard someone was banging on the door but did not hear what he was saying. Lopez waited inside with all other individuals until the police arrived. Lopez was able to call Denise, Brandon's mother, and find a location where she resides. I responded over to Denise's address in Milwaukee.

STATEMENT OF WITNESS - DENISE DORT

I spoke with the mother of Brandon Dort, the offender, at her residence in Milwaukee at 8830 W Howard Ave. Denise stated she was having a mother/son day with her son Brandon. Denise stated she went to the Brewers game for Lopez' birthday party and they all went back to the bar afterwards. Denise stated Brandon is very protective of her.

As she was leaving with Brandon, Denise walked outside and ran into her friend Dean. Denise stated that Dean came up to her and said hi and she briefly began to speak with Dean. At one point, Denise observed Andy, another bar patron whom she knows well, and Brandon were having an exchange of words. Denise did not hear the initial exchange of words, however did hear Andy state "don't disrespect your mom". Denise did not know why Andy said it or what may have provoked him to say it.

Denise observed Brandon immediately attack Andy. Denise watched as they began to roll around on the ground and Brandon attempting to strike Andy with a closed fist. Denise was shouting "what are you doing" to Brandon. Denise stated Brandon was "very out of line" with what happened. Denise stated Andy "did nothing wrong".

Denise was trying to stop the fight when Brandon rolled over and immediately pulled the firearm out of his waistline. Denise did not believe that Brandon had the firearm with him in the bar. Denise did not hear what Brandon said after that but left immediately when she observed what Brandon was doing. Denise thinks he may have gone to the car at some point after the Brewers game to retrieve it. Denise knows that Brandon has a valid CCW permit because he has always feels the need to have it with him. Denise stated he owns the firearm to protect her.

INTOXIMETER OPERATOR REPORT

I gave Dort a basic instruction of the Intoximeter test. I informed him that he would be required to give at least two adequate samples of his breath. Dort stated that he understood and had no questions. At 0259hrs, Dort gave his first accepted breath sample of .195. At 0303hrs, Dort gave his second accepted breath sample of .195. His reported value was .19 g/210L. I explained the breath test results to Dort and he did not have any questions.

During my contact with Dort I detected a strong odor of an intoxicant on his breath, slurred speech and red and glassy eyes. Based on my observations, training and experience as a police officer, I believe Brandon Dort was under the influence of an intoxicant. Dort was cooperative with me during the breath test.

I made contact inside the tavern to view surveillance video. I was directed to Co Owner Edward D. Bomback M/W 04/20/43. Bomback was unaware of the incident and brought the video surveillance. I observed the bouncer, Nathan M. Munsell M/W 09/29/72, speaking with 3 Hispanic males. The males walked in together with 1 wearing a light green/yellow shirt, 1 wearing a long sleeve Green Bay shirt, and 1 wearing a blue shirt.

The video appears that the males were refused entry into the Spot Lite and argued with Munsell at the door. At approx. 0156hrs on the video, Munsell appeared to be attempting to get the parties out of the door. The male in the light green/yellow shirt was in the door way facing Munsell when the male with the blue shirt can be seen reaching between his friend in the yellow shirt and the door frame performing a stabbing motion with an object in his hand. The parties then leave.

I requested a copy of the video from Bomback who stated he would make a copy.

FOLLOW UP/ARREST

Lt. Kempinski, PO Luedke and I went to follow up with the vehicle at the RO's address. Upon arriving in the area, I observed a black Audi with 3 Hispanic males southbound on Cesar Chavez Dr as we were northbound turning on W. Walker St. I asked PO Luedke if she saw the plate as it matched the description. PO Luedke turned around, and advised it is the suspect vehicle.

PO Luedke performed a traffic stop in the 1700blk Cesar Chavez Dr as Lt. Kempinski and I assisted. The male with the blue shirt was seated in the front passenger's seat. He was ordered out of the vehicle by PO Luedke and I. The male stepped out and was not listening to all commands. He was ordered onto his knees, then onto the ground where he was taken into custody.

I performed a search of the male, identifying him as Luis M. Cervantes Escamilla M/W 07/17/84. In Luis's front right pocket I located a Dewalt brand box cutter and a white baggie corner containing a white powder substance, which based on my training and experience I believe to be cocaine.

After completing my search of Luis, he was placed in the rear of PO Luedke's squad car.

The other two males were identified as Edgar Alonso Mejia Corral M/W 04/19/93 (male with light green/yellow shirt) and Mario A. Vega M/W 07/29/99 (wearing a Green Bay Packer fleece).

STATEMENT WITH VEGA

I made contact with Vega and removed his handcuffs. I explained to Vega why he was handcuffed and advised him he was not under arrest and pending no major changes, he would be walking away tonight. Vega stated he understood.

I asked Vega about where he was tonight. Vega initially avoided my question repeating himself that he was called to pick up Corral. Vega denied knowing Luis.

After speaking with Vega for a few minutes, he admitted to being at Spot Lite with Corral and Luis. He stated they were only there for a short time before leaving and going to Encore. I asked Vega about why they left Spot Lite quickly and he stated he didn't know. Vega denied knowledge of any incident at Spot Lite.

After speaking with Vega, I was advised he had provided multiple birthdates and was directed to take him to WAPD for a positive identification. I conveyed Vega to WAPD (not handcuffed). At WAPD, I confirmed Vega's identity

utilizing FASTID. After verifying his identity, he was released.

PHOTOGRAPHS

I took photographs of the vehicle as well as the box cutter recovered from Luis. The photos were uploaded to the DIMS system. The photos were unavailable for viewing at the time of this report.

EVIDENCE PROCESSING

PO Luedke turned over a folded up \$1 bill containing a white powder substance which based on my training and experience I believe to be cocaine.

I weighed the suspected cocaine recovered by PO Luedke in Luis' property as well as the suspected cocaine I recovered from Luis's property. I received a weight of .1 grams for the substance recovered by PO Luedke and .2 grams for the substance I recovered in Luis's pocket.

I obtained a sample of each substance and placed them each into clean test tubes. I performed Cobalt Thiocyanate Field Tests on each sample to test for the presence of cocaine. Upon completion of the field test, I received positive test results for the presence of Cocaine for each test.

The suspected cocaine and packaging were packaged, sealed, and placed on evidence.

Lt. Kempinski reports...

INITIAL RESPONSE TO CALL/ARRIVAL ON SCENE

On 06/03/2017 at approximately 0158 hrs I responded to the Spot Lite (6426 W. Greenfield Ave.) for a report of a male that had been stabbed. Dispatch advised that the bouncer at the establishment was stabbed by a male Hispanic who then fled in a Black Audi. A license plate of 828YZA was provided as the vehicle the offender fled in.

I was the first squad to arrive at the tavern and while en route I had requested WAPD dispatch to send a medical response as well until the condition of the victim was determined.

OBSERVATIONS OF/CONTACT WITH VICTIM- Nathan M. Munsell (09/29/1972)

When I arrived on scene I located the victim (later identified as Nathan M. Munsell, M/W, 09/29/1972) standing in front of the business. Munsell was wearing a polo style shirt which had a cut on the front of it near the bully button area on Munsell's abdomen. I could also see a small amount of blood from the opening of the shirt.

I confirmed with Munsell that he was not in need of immediate medical attention and he showed me the small cut to his stomach area that did not appear to penetrate the abdomen. He also advised he did not need an ambulance for transport or evaluation however I told Munsell that one was already responding based on the reported injury.

A WAFD ambulance responded to the scene and provided an assessment of Munsell who did not require any additional treatment.

VICTIM STATEMENT/LACK OF CONSENT

Munsell provided the following statement. While working at the entry to the business and checking identification per normal procedure Munsell encountered two males who were attempting to enter without an ID. One of the males was described as a shorter Hispanic male wearing a blue shirt which appeared to have some kind of dust or white paint on it. He was described as being in his late 20's to early 30's. Additionally Munsell advised me that this male produced some kind of unofficial ID, which Munsell thought may have been a Mexican ID and Munsell believed the date of birth on it was 07/17/1984.

(This male was later identified as the offender- Luis M. Cervantes Escamilla, M/W, 07/17/1984).

Munsell stated that this male became very agitated when Munsell would not allow him in despite Munsell advising him it was company policy for anyone who enters the business to show a valid form of identification. The male got into Munsell's face several times. Munsell then tried to get the male to leave by moving him towards the door gradually. A second Hispanic male, who was with Escamilla, attempted to get Escamilla to settle down as well. This male was later identified as Edgar Alonso Mejia Corral (M/W, 04/19/1993).

When Munsell was speaking with Corral and telling him that he and Escamilla needed to leave the business Escamilla suddenly reached past Corral and lunged at Munsell with a sharp bladed weapon (later determined to be a box cutter), slashing Munsell's shirt and abdomen area.

Escamilla and Corral then fled from the business and a third Hispanic party who had been inside the business (later identified as Mario A. Vega, M/W, 07/29/1999) left the business to accompany them. Munsell watched as the males all entered a Black Audi sedan which was parked on S. 65th St. and then sped off northbound. Munsell stated that the offender who cut him with the knife was seated in the front passenger seat of the vehicle at the time it left the business.

Munsell stated he did not give anyone consent to attack him or attempt to cut or stab him with a knife during this incident.

SURVEILLANCE VIDEO REVIEW

After speaking with Munsell, Officer Luedke, Officer Stuetzgen and I reviewed the video from the business with the bar owner (Edward Bomback). The video provided the following information and was consistent with Munsell's statement:

A Hispanic male, approximately 25-35 years of age, medium build, short hair, slight facial hair, wearing a blue t-shirt and khaki colored shirts engages in an argument with Munsell who is seen several times trying to get the male to leave. After the male in the blue shirts steps back but continues trying to get in and yelling at Munsell a second male in a green or neon green colored jacket speaks to Munsell. During this conversation the male Hispanic in the blue shirt reaches around the male in the green colored jacket and slashes at Munsell with an unknown bladed weapon.

Munsell reaches down for his stomach and reacts to this stabbing motion of the offender. The males are then seen leaving the entry way to the business. The area of S. 65th St. where the vehicle was parked is not visible via camera.

CONTACT WITH VEHICLE/SUBJECTS

After clearing the scene at the Spot Lite I confirmed with dispatch that the license plate provided by Munsell matched the vehicle description of a Black Audi. I was advised that the license plate provided listed to a 2005 Black Audi to a female subject that had a listed address of 1564 W. Walker St.

At the completion of the on scene investigation Officer Stuetzgen, Officer Luedke, and I responded to the above listed address to attempt to locate the vehicle and the offender. As we reached the area near the house Officer Stuetzgen advised that he believed he had observed the vehicle turning onto W. Cesar Chavez.

Officer Luedke was able to locate the vehicle in the area of the 1700blk of W. Cesar Chavez St. and confirmed it was the suspect vehicle. While the vehicle was stopped at a red light I moved my fully marked WAPD squad car to the driver side of the vehicle and was able to see that it was occupied by three male subjects including a male in a blue colored shirt in the front passenger seat.

Based on the information developed in the investigation as well as the occupant matching the offender description in this case I advised Officer Luedke to attempt a traffic stop on the vehicle. Due to the violent felony offense committed by the offender and reason to believe he was in the vehicle at that time I activated my squad lights and siren and traveled on the left of the offender vehicle to attempt to persuade the vehicle from fleeing and causing a pursuit to take place. The vehicle traveled a short distance before stopping near the curb line.

Due to a radio malfunction triggering the squad emergency alarm I was unable to broadcast the information to dispatch of the traffic stop location and to request Milwaukee Police assistance to our location. *MPD had been notified that we were responding to the address on W. Walker St. for this investigation and a squad had been requested.* I exited my squad car and took a position of cover near the driver side. After seeing that Officer Luedke and Officer Stuetzgen had exited their squads cars and moved to a non-approach position on the offender vehicle I moved around the front of my squad car and began giving orders to the driver and passengers of the vehicle to keep their hands visible.

Based on the violent felony committed and the likelihood that the offender, who appeared to be in the vehicle was still armed I covered all of the subjects at gun point and requested Officer Luedke and Officer Stuetzgen have the offender exit first. I requested and received the vehicle keys to confirm
