An Ordinance to Establish Parking Restrictions on the East Side of the 800 Block of S. 60 Street.

Block: 800

Side: East

Restriction: No Parking Anytime



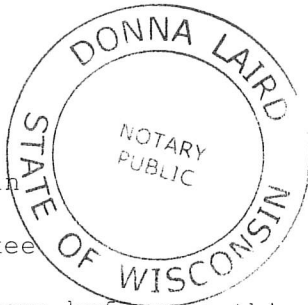


