Upon arrival, I spoke with Sean D. Atkins, M/B, 03/10/70, who advised he was sitting at the bar next to Angela Harris, F/W, 05/03/77, eating their dinners. Atkins heard a M/W, later identified as Robert I. Hayes, M/W, 11/06/57, screaming inside the bar at nobody. Atkins then observed Hayes screaming, "Fuck You" to the ceiling. Atkins advised after Hayes was screaming, everybody in the bar turned and looked at Hayes to see what was going on.

Hayes then started walking towards Harris and Atkins. Hayes continued to scream and yell while walking towards Harris. The bartender told Hayes he needed to calm down or else he would be kicked out of the bar. At this time, Hayes continued to get closer and closer to Harris. Harris continued to move to her right as Hayes was to her left. At one point in time Harris was leaning so far to her right that she was almost sitting in Atkins lap.

Harris told Hayes he needed to move and to give her some space. Hayes became belligerent with Harris. Hayes spit in Harris' face and in her food. The bartender then told Hayes he was no longer welcome in the bar and that he needed to leave immediately. Before leaving the establishment, Hayes screamed, "Fuck You!"

Atkins advised it appeared Hayes was extremely intoxicated and would not listen to anybody around him. Atkins has seen Hayes before in the bar intoxicated.

Atkins had no further information regarding this incident.

Upon arrival to Kokopelli's, the bartender and other patrons of the bar advised Hayes had already left and went into the Remedy bar. I made contact with Hayes inside the Remedy. Hayes was walking out of the bar as I was walking in, due to him being kicked out of this bar as well. I immediately smelled a strong odor of

an intoxicant emitting from Hayes' breath and person. I asked Hayes what he was doing. Hayes said he was just leaving and he was not causing any problems.

When I told Hayes he was causing problems and he needed to come outside to speak with me Hayes replied, "Fuck you, you cunt!" I placed Hayes' arm behind his back and assisted him out of the bar. When Officers attempted to ask him what happened tonight, Hayes would become belligerent and swear at Officers.

Hayes' eyes were red and glassy. Hayes' speech was also slow and slurred. Hayes did not know where he was or what was going on. Officers placed Hayes in the back of my squad (#3).

#### ARREST DECISION

Based on all the witness statements, the victim's statement, and Hayes' demeanor with Officers, Hayes was arrested for Disorderly Conduct and transported to the WAPD for the booking process.

#### BOOKING

Hayes was mugged, booked, and fingerprinted using WAPD booking# 14-001024. Hayes was given municipal citation #M140010241 for Disorderly Conduct and given a court date of 04/07/14 at 0830 hrs.

While in the booking area, Hayes continued to call me a lesbian and a cunt. I did not say anything to Hayes when he addressed me in that way.

### INTERVIEW OF ROBERT I. HAYES (OFFENDER)

Due to Hayes being extremely intoxicated and being uncooperative with Police, an interview was not conducted with Hayes.

#### CASE DISPOSITION

Due to Hayes causing a disturbance at Kokopelli's, Hayes was issued a citation for Disorderly Conduct and given a municipal court date of 04/07/14 at 0830 hrs.

#### INITIAL CALL

On 03/04/14 at approx. 2139 hrs., officers responded to Kokopelli's Pub, 6001 W. Madison St., for a male refusing to leave. Upon my arrival, I made contact with bar owner, Toni M. Virnhelp, F/W, 04/12/69.

#### STATEMENT OF TONI

Toni said that initially, there had been an older intoxicated male with one eye inside the bar refusing to leave, but he had since left several minutes before officers arrived. I asked her what happened. She said the male called several women "cunts." He was yelling specifically at one female and while yelling, he spit in her face and food. Toni told him to leave, but he turned around and called her a "bitch."

#### INITIAL CONTACT WITH ROBERT I. HAYES - OFFENDER

I exited the bar and observed officers escorting Hayes back to the area. While he was next to a squad car, I asked him if he was calling people names. He said he was calling them names because they were calling him names. I asked him if he called anyone inside the bar a "cunt", and he was silent. I asked him why he called them that, and he replied, "Because they were being cunts." I asked him if he spit in someone's food, and he said, "No." I asked him if he spit in someone's face, and he said, "No." During my contact with Hayes, he appeared agitated and I had to repeat my questions several times before he answered.

I responded to 6001 W. Madison st. for an man causing a disturbance in the bar. Upon arrival I spoke with Angela Harris and Sarah Jablonski.

# STATEMENT OF SARAH JABLONSKI-WITNESS

Sarah said the offender was getting unruly in the bar, yelling/swearing at himself and causing a scene. He was only in the bar about seven minutes, and did not take one sip of his beer. Sarah said one of the customers, Angela Harris, told her the man spit in her face. Sarah asked the man three times to leave, but he refused. The owner, Toni Zirnhelt, asked him to leave, but he said to her "fuck you" and refused to leave. Sarah wanted the man out of the bar, and not to come back.

## STATEMENT OF ANGELA HARRIS-VICTIM

Angela said she was sitting at the bar eating her food. The offender sat next to her and leaned over very close to her. Angela moved over because she did not want the man that close to her. The man said "What the fuck is your problem?". She told him she just needed some space. He said "you can have your space" and spit in her face. The man stumbled out of the bar because he was intoxicated. He came back shortly after and demanded his money back. Sarah told the man no, and Angela's husband prevented him from coming back in the bar.
