She asked that Pawn America abide by the City's requests which may restore their neighborhood to the peaceful, safe place it was before the business arrived. Ms. Olson commented on the Committee telling tavern owners that the residents were there first and the tavern needed to be a good business owner and respectful of the neighbors.*

*Assistant City Attorney Merten advised the Committee an ordinance could be drafted for all Pawn Dealers to be required to issue checks for over \$25.00. The Committee asked that it would include secondhand dealers.*
