Ann,

The Sanfelippo's withdrew their special use for a used vehicle dealership on about June 1. I received verbal confirmation of this from Mr. Michael Sanfelippo and his commercial real estate broker Don Zien of CB Richard Ellis.

The plans they had previously submitted in May were incomplete and not ready for Plan Commission consideration (May 24) the prior month.

They were extended the opportunity to submit their revised plans to the June 23 Plan Commission meeting, but decided to walk. For these reasons a public hearing was not scheduled.
