The Clerk states based on the ticket my vehicle was blocking the crosswalk. According to picture #1 the crosswalk is on an angle. How is it possible to park a vehicle on an angled crosswalk and not have it immediately ticketed by a passing police officer as I left my vehicle? My vehicle was ticketed and towed hrs later. I was informed by the towing company due to a complaint my vehicle was towed. No signs out on the street indicate your vehicle will be towed for parking. Chapter 10 in WEST ALLIS ~~Code~~ Codes doesn't indicate your vehicle can be towed for blocking a crosswalk even during STATE FAIR. In my opinion my vehicle was towed because it wasn't profitable to be on the streets as opposed to the residences property. My vehicle was parallel to the curb and not on an angle in which to block the crosswalk and prevent any traffic from pedestrians. The ticket doesn't indicate my vehicle would be towed so I am unaware as to why N&S would tow my vehicle. The pictures provided show detailed angles that support me saying my vehicle was parallel and not on an angle where the crosswalk is. I ask that the towing fee be refunded to me for wrongly towing my out of state vehicle

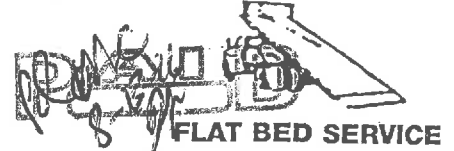
