RE: Administrative Charge for Processing a Nuisance Abandoned Property

Dear Mayor Devine & Common Council Members:

The following information is submitted as documentation of charges for Nuisance Abandoned Properties when posted and follow-up maintenance assistance is to be charged for contractor site work.

In addition to the actual contractor costs charged to the property an additional \$317.00 will be assessed for processing costs. Processing fees are as follows:

1.	<u>Field Work</u> . Receive/Review referral, initial field inspection; pictures of property violations.	.75 to 1.00
2.	Office Research. Check ownership (GIS & other); check foreclosure records (CCAP); contact Attorney's office for title letter report.	.50 to .75
3.	Office/Field Posting a Nuisance Abandoned Property (NAP). Review title report; prepare posting NOTICE; prepare billing for prepare billing for Finance Division; issue written Notice/Orders for mailing with proper affidavits; post site with 10-Day Notice.	.50 to .75
4.	<u>Follow-up After 10-Day Notice</u> . Site inspection; prepare contactor work order; contact contractor with Abatement Work Order or DPW for snow or tall grass/weed abatement.	.75 – 1.00
5.	<u>Site Meetings with Abatement Contractor</u> . Initial, ongoing, and final meetings and inspections for contract approval and payment; clerical processing of billing to Finance Department.	1.5 – 2.0
	Average time to process is 5.0 hours.	Total Time 4.25 – 5.75 Hrs. Average 5.0

B. <u>Inspector Cost (Salary Plus Benefits)</u>.

C. <u>Title Report</u>.

- Each time a property is researched for abandonment, the procedures include contacting the property owner(s), lien holders or foreclosure company. The procedure requires the Attorney's Office to secure a letter title report from a private agency that researches public records.
- 2. Report cost \$60.00 plus .5 hr. Attorney staff time (est. time).

In conclusion, the current average cost to process a Nuisance Abandoned Property is estimated to be \$317.00. The amount will be charged to the property owner or billed as an assessment cost against the property when abatement is required by Order of the Director of Building Inspections & Neighborhood Services per City of West Allis Revised Municipal Code, Chapter 19.
